In the next phase of renewing the Province's education funding model, working groups will be formed in January 2019 to engage further on the key areas and themes identified in the report.

In collaboration with the Implementation Advisory Committee, the working groups will assess the implications of the recommendations made by the Panel and determine strategies for how those recommendations can be best implemented.

The working groups will include representation from all education partners including teachers, parents, school administrators, support staff, trustees, superintendents, the First Nations and inclusive education groups. The groups will report back in the fall of 2019.

No changes will be made to the existing funding model for the 2019-20 school year.

Implementation Advisory Committee (IAC) In October 2018, the Minister of Education appointed an Implementation Advisory Committee comprised of education experts to provide advice and help guide government in the next steps of the funding model review.

The IAC members have extensive experience and knowledge of the education system. Members include:
