The School Act has a provision in it that allows a School Medical Officer (SMO) to stop a student or staff member from coming to school if they pose a serious medical risk to the other students or staff. There is at least one SMO assigned to each district. s.22 is welcome to ask the principal to speak with the SMO, but I do not believe that the SMO will decide that bedbugs pose a sufficient safety risk to trigger the aforementioned remedy.

Would we be able to talk again at your earliest convenience, please?

I want to update you on my efforts to get traction on practical action steps for commuting, congestion and carbon reduction. It seems planners and deputies in the various ministries and agencies all agree this is a fine idea, but are all pointing to other ministries and agencies and/or are consumed with targets and possible strategies for *future* action some years from today.

As we have more BC municipalities declaring a climate emergency (Vancouver, Richmond, CRD – and Islands Trust should be next) and youth around the world demanding action *NOW*, it would seem appropriate the Provincial Government take action *right away* on this ready-to-roll program. It would demonstrate commitment to affordability, services and sustainability – and your leadership would tangibly improve the daily lives of tens of thousands of citizens *within months*.

Carbon taxes, targets, regulations, quotas and subsidies are fine, but they aren't tangible for most citizens – reducing commutes definitely will make "sustainability" real and popular and appreciated. I have been discussing with CRD directors how they might initiate this program on their own for the Capital Region – acting <u>now</u>, in the spirit of their emergency declaration. Recently, I was made aware that there is a document entitled "Improving Equity and Accountability - Report of the Funding Model Review Panel 2018". This document outlines recommendations supporting the *per-student funding model* rather than the current *course-by-course funding model*. If implemented, the majority of our music, musical theatre, dance, drama, leadership, enrichment, distributed learning, etc., programs could be taken out of our schools. Having a *per-student funding model* will impact both students and staff. It will limit students' ability to participate in courses that are offered outside of the timetable and will reduce a teacher's full-time equivalent (FTE) in their trained subject area.

The current *course-by-course funding model* has allowed the creation of enriched learning opportunities for performing arts programs, including multi-grade senior level classes that are offered outside of the timetable (which allows for flexibility for students with heavy academic schedules), cross-enrolment performance classes between schools in a district, offering of new courses where students can

explore and/or specialize in at all levels allowing flexibility, and enrichment classes including arts, academics, trades/tech, languages, athletics, and leadership. The proposed *per-student funding model* would cancel many of these courses, causing a significant amount of lost opportunities for our students.

I personally do not want to see any of these enrichment programs reduced, however, I strongly believe that changing the funding model will do this. It will affect thousands of jobs, will affect students' abilities to complete graduation requirements, and will change the course of education for decades to come. I urge you to defeat these recommendations and to keep the current *course-by-course* funding model.

Dear Surrey NDP Members of the Legislative Assembly,

I am writing to express the STA's deep concern about a threat to elementary library programmes in Surrey public schools. I spoke to Jagrup about it when I met with him last Friday, but wanted to share it with everyone.

On June 30, 2019, at the end of this collective agreement, prep time for elementary teachers will increase from 100 minutes to 110 minutes per week. Currently prep for K-4 (and also 4/5, generally) is deliveredy by teacher-librarians (40 minutes per week) and core music (60 minutes per week). Intermediate prep (Grades 5-7) can vary by school, and can involve French, Band, ADST, or other options, depending on how the school decides to deliver it.

The issue is how the extra 10 minutes per week of prep for each teacher should be delivered next year. For intermediate prep, there is no problem, because whatever staffing is being used to provide that prep will just be increased to be able to cover an additional 10 minutes per week. However, for K-4/5 prep, two of the options Surrey School District is considering involve not adding staffing, but using existing teacher-librarian staffing (either having the teacher-librarians deliver a further 10 minutes per week of prep, or a further 5 minutes, and increasing Music to provide the other 5 minutes).

Our concern is that using existing staffing will compromise library programmes because it will greatly reduce (by roughly 50 percent) the amount of time teacher-librarians have to collaborate with classroom teachers to develop resource- and research-based units and activities. This would be bad for students, and also terrible for the morale of teacher-librarians at a time when recruitment and retention are significant concerns.

I wrote the message below to Jordan Tinney last month. My understanding (from a meeting with HR last Thursday) is that the senior leadership team are still considering options, and that the holdup is confirmation of whether the added staffing required to deliver the additional prep will be funded by the provincial government. I am troubled that the options involving using existing staffing (which would reduce service to students) are still on the table.

Salary increases in this collective agreement were funded by the government. It seems clear that increased preparation time (which requires more staffing) should also be funded, rather than coming at the cost of services to students. If you are able to get any clarification from the Ministries of Education and Finance, we would greatly appreciate it.

Christie Weigel and I had a good meeting today with Pete Nuij and Peggy Antifaeff about the increase to elementary preparation time. I appreciate that they (along with Andrew and Ross) have done a lot of work analyzing the different scenarios. I am writing to express the STA's view about the plans.

In our view, choosing options 2 or 5 (which contemplate taking the extra 10 minutes/division out of existing teacher-librarian staffing) would be a terrible mistake. Taking the extra time out of existing staffing would reduce teacher-librarians' admin time and collaboration time. The collaboration time, in particular, is at the heart of the teacher-librarian role. I have attached an infographic (which we shared at the meeting) that was created by the local branch of the BC Teacher-Librarians' Association, outlining all the different aspects of collaboration for teacherlibrarians. The opportunity to do this sort of work is the reason why people invest the time and money to get trained to be teacher-librarians. (It is worth noting that there are districts where teacher-librarians do not provide prep whatsoever, which means that they can spend all of their time doing this work to teach students vital 21st-century skills and support and enrich the work of classroom teachers.) Using existing teacher-librarian staffing to provide the additional minutes of prep would drastically reduce the time available for collaboration, which would compromise the library programs in our elementary schools. Moreover, it would be devastating to our teacher-librarians' morale, and would doubtless make it more challenging to recruit teacher-librarians to come to Surrey. For these reasons, these options are completely unacceptable to us.

Instead, the additional prep time must be provided using additional staffing. The BCTF and BCPSEA agreed to add 10 minutes of prep at the end of this collective agreement, which was

bound to require an increase in staffing. It is difficult to believe that the mutual intention of the provincial parties in increasing elementary prep was to <u>reduce</u> services to students, yet that is what will happen if staffing is not added to provide the increased prep. Just as the negotiated salary increases were funded, so too must be the staffing required to increase prep.

Although each option has potential disadvantages, we believe that any of the other six options would be infinitely preferable to options 2 and 5. I will leave it to Peggy and Pete to share our thoughts on the other options (we have a slight preference to options 1, 3, and 4 over option 6), but I wanted to be clear in expressing the strongest possible opposition to taking the increased prep out of existing staffing.

Thank you for this. It is really good to know what the plan is.

At first glance, I notice that there is no mention of BCN's BAA curriculum 'HOPE for Boys Leadership11' which forms the foundation of the BCN in-class program at WJ Mouat. The course is in its third year and included boys from grades 10 thru 12. Mouat started with an after school BCN chapter, then moved those same boys into the curriculum. Our mentorship format and greater Network, are critical to the success of the curriculum. I don't know what you will do with that information, but it would be a large commission to not make that clear.

Perhaps also then, in the third paragraph, the sentence could be amended to include the BAA — ie: Through the partnership, after school programs will be set up (where they don't already exist), and new BAA curricula developed, offering targeted mentorship and educational opportunities for young males, to help empower them to make positive life choices. or something similar

The BC portion of her student loan payment is already interest free; however, the larger portion of student loans are dispensed from the federal government. The federal government still charges interest and has not announced any plans to stop. The interest rate everyone pays on the federal portion is the same no matter the individual credit rating. I believe it's 2.5% above prime. The National Student Loan Service Centre is not a provincial entity and the provincial government has no jurisdiction over its operations.

I would encourage you to share this with your local MP. I hope the federal government will follow BC's lead and abolish student loan interest.

- We appreciate the stress and frustration this causes families trying to get supports for their kids.
- The current wait-times are too long, that is why this year, our

government boosted the budget for the B.C. Autism Assessment Network by 20 per cent – an increase of \$1.2 million.

- The number of assessments has increased over the past number of years, from approximately 1,700 in 2013/14 to almost 2,100 in 2017/18.
- We have also increased the number of assessors from 44 to 52, which will help reduce waits. More assessors will be added in the coming months.
- We're going to keep working to increase capacity and bring the wait times down so that kids can get the supports they need sooner.
