New Social Media Guidelines

Social media plays an expanding role in the everyday lives and work of public service employees. Our social media activity, whether as an individual or in an official capacity, can impact public trust and confidence. Our use of social media in official capacities also impacts the quality and responsiveness of service we provide for citizens.

As employees, we are responsible to ensure our social media activities comply with the Oath of Employment, <u>Standards of Conduct</u> and other policies and regulations we follow as public service employees.

To help understand these obligations and support you in making informed choices, new personal-use and updated government-use guidelines have been developed.

Personal use

The BC Public Service Agency is launching the new <u>Social Media Guidelines for BC Public Service Employees</u> to inform your personal use of social media as a public servant. While the guidelines for personal use are new, the expectations they reflect are not. They focus on the principles that will help you make informed choices about your online activity that won't conflict with your commitments to the BC Public Service. They don't prevent you from using social media – they are just intended to help you ensure you're using social media consistent with the Standards of Conduct and other corporate policies.

If you have questions about appropriate professional or personal use of social media, <u>review the resources available on MyHR</u>, and then talk to your supervisor or your ministry ethics advisor.

Government use

Government Communications and Public Engagement has updated the <u>Guidelines for Government Use of Social Media by B.C. Public Servants</u>. The revised guidelines focus on official government use of social media like setting up and managing social media accounts and engaging in citizen consultations. In addition, the guidelines establish clear processes and best social media practices for supporting key priorities across government.

Math Challenge Club

In April, Ms. Fazio provided a comprehensive review of the Math Challenge Club history at Norma Rose Point, outlining requirements for the club to participate in the math challenge competition and the administration's rationale to discontinue their sponsorship of the club. Attached is a copy of Ms. Fazio's letter dated April 16, 2019 for your reference. Any school supported extra-curricular event or club requires the sponsorship of a Vancouver School District employee. In addition, the

Math Challenge Club participation in competitions, as outlined by the competition organizations, requires the coach/organizer responsible for testing be school staff. Unfortunately, staff members at NRP no longer volunteer to sponsor the Math Challenge Club. Because the Math Challenge Club is an extracurricular opportunity and not a curriculum requirement, the school district cannot mandate that a staff member sponsor the club. Therefore the club cannot enter mathematics competitions requiring a VSB staff sponsor.

I recognize this is disappointing and not the response you had hoped. Although you question if closing the Math Challenge Club is "the path of do better," it is the decision the school must make to be in compliance with competition rules. In the future, if a staff member at NRP decides to sponsor the Math Challenge Club, then the club can continue and participate in future competitions.

As requested I have detailed my request to speak with Sheila re: an issue about the private funding of faith-based institutions in BC.

Issue:

s.22

Legal and Moral Grounds for the issue:

I understand that it is the current legal right for a religious school to discriminate against those who

do not share in strict adherence to their dogma.

However, it seemingly violates Article 15 of the Canadian Charter of Human Rights and Freedoms which states:

Equality before and under law and equal protection and benefit of law

• 15. (1) Every individual is equal before and under the law and has the right to the equal protection and equal benefit of the law without discrimination and, in particular, without discrimination based on race, national or ethnic origin, colour, religion, sex, age or mental or physical disability.

Implications within our province, and society:

This issue is not isolated to this community, but to the province, and country as a whole. Below are two articles detailing discrimination against individuals based on sexual preference: https://arpacanada.ca/news/2017/09/19/sex-parents-christian-schools-ontario-human-rights-tribunal/

Use of hundreds of millions of dollars in public funds to subsidize private schools in BC:

In 2018 BC's private religious schools received the majority of \$426 million dollars in **PUBLIC FUNDS** to subsidize their educational programs. (Vancouver Sun 2018)

Not only this, but private schools receive exemptions from property tax benefits at the expense of public funds. (Vancouver Sun 2018)

This subsidization of elite private schools, with discriminatory practices based on religion and sex comes at the expense of an **already arguably underfunded public school system**.

Polling as reported by the Vancouver Sun (2018) states that, "public funding for private schools is very unpopular. Polling shows that **63 per cent of British Columbians oppose funding secular private schools** (and even more oppose funding religious private schools). Opposition to funding elite private schools in particular would likely be higher still."

This is a direct threat to the mental and physical well-being of Canadian citizens by discrimination.
- 6. There is a strong case that the public (\sim 69%) is directly opposed to the use of provincial subsidies for faith-based private schools (The Tyee 2019).

I believe the current legal ability for religious private schools to receive public funds and discriminate against citizens is morally, and legally reprehensible. As such, I formally request that Mrs. Malcolmson pursue the issue with her caucus, as well as with the newly reestablished BC Human Rights Commission.

Hi Melissa,

I just had a constituent in my office who wanted to talk about Extension school here in Nanaimo. The school was closed many years ago, and the building itself is over 100 years old. The school is placed in a small community (unofficially called Extension) on the outskirts of Nanaimo. Years ago there was a deal in the works to give the school to the community who has plans of restoring it as a heritage building to be used for community purposes (events/emergency shelter/gatherings) but (from what I have heard) the Regional District got involved and the plan between the district and the community fell through. The district is now awaiting or applying for funding to tear the school down and we have heard from a few in the community who would still like to see it restored given the age and history of the building. The constituent stated that the money for demolition should just be given to the community to restore- and I explained why that was not possible as the funding comes from a certain revenue stream. However I wanted to see if you have ever run into any similar situations, with older schools in districts being restored with other possible revenue streams or if the Ministry's position is only look at tear downs?

- BC independent schools are regularly evaluated through an inspection cycle to ensure that they are meeting the requirements of their classification.

 - · social change through violent action, or
 - sedition.

INFORMATION:

For the 2018/19 school year, there are a total of 321 funded independent schools in BC:

- 228 Brick and Mortar Group 1 Schools
- 77 Brick and Mortar Group 2 Schools
- 16 Distributed Learning Group 1 Schools

Funding to independent schools:

- Group 1 schools are funded at 50% of the local district amount, are not -for-profit, provide BC Curriculum, employ BC Certified Teachers, students earn Dogwood and the Per student operating costs are equal to or less than the local school district amount.
 - *Note: Distributed Learning (DL) Schools receive 63% of the provincial public school DL rate (currently at \$6,100)
- Group 2 schools are funded at 35% of the local district amount, are not-for-profit, provide BC Curriculum, employ BC Certified Teachers, students earn Dogwood and the Per student operating costs are greater than the local school district amount

*Note: First Nation school students that are not funded federally (status, off reserve), are funded at 100% of the First Nation billing rate

The purpose of my request to contact Mrs. Malcolmson is to address the following issues:

1. Publicly funded private businesses are discriminating against the sexual preferences and religions

of tax-paying citizens seeking employment.

- 2. There is evidence for deeply routed institutional biases in these schools and a social and historical precedent that it is likely not limited to discrimination of only sexual, and religious preference.
- 3. Private citizens are asked, formally and informally as well as prior and post hiring, to such questions as, "Who do you live with? Where do you live? Are you sexually active? Are you pregnant? Are you gay?" (CBC 2019).
- 4. The methodologies used by these organizations to collect information about these preferences on potential employees is not done in an objective or non-discriminatory fashion. In the case of my partner the principle of the school informed her he was informed of us, "living together out of marriage" by "someone who knows her.".
- 5. It is very likely that current employees of these schools are unable to exercise the freedoms provided to them by the Canadian Charter of Human Rights and Freedoms without fearing loss of gainful income, as well as loss of personal and professional reputation. This is a direct threat to the mental and physical well-being of Canadian citizens by discrimination.

Hi Coletta,

You may have received some information from the Ministry of Transportation, nonetheless the information below may be helpful for your constituent:

- Transport Canada is responsible for establishing the Canadian Motor Vehicle Safety Standards which include safety requirements for school buses through the Canadian Standards Association standard D250-16.
- D250-16, article 6.30 specifically addresses the requirements for school bus stop arms by stating: One stop arm equipped with at least two red lamps on each side of the stop signal arm shall be installed as far forward as practical. For buses over 9.15 m (30 ft) in length, a stop arm at the rear of the bus may also be installed. All stop signal arm assemblies shall meet the technical requirements of Section 131 of the MVSR and operate in accordance with Clause 6.19.2.5.
- In British Columbia, when ordering larger Type C and Type D buses we specify two stop arms; one at the front of the bus and one at the rear of the bus.
- Smaller Type A buses and 36 passenger Type C buses only have one stop arm located at the front of the bus.
- The enclosed video clearly shows the front stop arm with lights activated when the bus stops and prior to the student exiting the bus. The oncoming car passes the bus approximately 6 seconds after the activation of the stop arm.
- Provinces and territories enforce safety on Canada's roads and highways and set the rules of the road. They are also responsible for licensing of school bus drivers, policies for safe operation of school buses and for the maintenance of school buses.
- There are some after-market companies offering long "gate/arm" systems that can extend across the path of the oncoming roadway when the lighted stop arm is activated. These long "gate/arm" systems have not been approved by Transport Canada or by D250-16, as it contravenes article 11.12(1a) of the Motor Vehicle Act Regulation; which states: the part of the roadway unoccupied by and to the left of the bus is at least 3 m wide and is clear and unobstructed for the full length of the bus.
