The **Ministry of Mental Health and Addictions** has released *[A Pathway to Hope: Better access to mental health and addictions care](#)*.

A Pathway to Hope lays out government's 10-year vision for mental health and addictions care that gets people the services they need in order to tackle problems early on and support their well-being. It identifies the priority actions government will take over the next three years to help people immediately and reduce demand on services down the road. The focus is on supporting the wellness of children, youth and young adults, supporting Indigenous-led solutions and improving access and quality of care. The roadmap will also build on the ongoing work to address the overdose crisis by starting to establish improved systems of addictions care.

School Food Guidelines Key Messages

- With the release of Canada's new food guide, the Ministries of Health and Education have worked to identify school nutrition policies and resources that may require updating to ensure alignment with current nutrition standards including the *Guidelines for Food & Beverage Sales in B.C. Schools* (the Guidelines) and the related *School Meal and School Nutrition Program Handbook*.
- Health Canada is currently determining what further dietary guidance may be released for health professionals and policy makers to support specific populations and settings, including schools. In addition, the Provincial Territorial Group on Nutrition, a Provincial/Territorial committee supporting national nutrition policy and promotion initiatives, has formed a working group to develop nutrition standards based on the new food guide to inform healthy eating guidelines and resources, including those specific to school settings.
- While awaiting further dietary guidance, the Ministries of Health and Education are in the initial phase of evaluating the current school food environment to understand how the Guidelines are used in practice and what resources are needed to continue to support a healthy school food culture.
- During this transition, the Guidelines for Food & Beverage Sales in B.C. Schools should continue to be applied in their current form. For more information about the guidelines, visit [HealthLink BC](#).
