SUBJECT: Independent Distributed Learning (DL) School Funding

**PURPOSE:** Confirm rate reduction for independent DL schools

## **BACKGROUND:**

EDUC has previously received approval to reduce the funding rate for independent DL (IDL) schools from of 63% to 50% of the public school DL rate of \$6,100 (Appendix A). A difference of \$793 per full time equivalent (FTE) in funding s.13; s.17

- To execute this policy change, the Ministry prepared an Order in Council (OIC) to amend the Independent School Regulation for to Cabinet approval in April 2020.
- The independent school funding rates for the 2020/21 would normally be announced in early April 2020 to allow ISAs to budget for the following school year and would reflect the drop in the IDL funding rate.

unknown. EDUC has moved the IDL enrolment count that normally occurs in May 2020
to April 7, 2020, to reduce the possibility of a large cost-pressure for EDUC should there
be a spike in IDL enrolment from students previously funded in brick and mortar schools
after the March 17, 2020 announcement suspending in-school instruction.
