ECCC's Meteorological Service of Canada (MSC) issues the weather warnings. Incl wind warnings. And marine weather warnings as well.

As mentioned earlier:

Well-forecast gale force winds were blowing through Juan de Fuca, while mention of "Windy near Juan de Fuca Strait" was in the Victoria forecast. Peak winds of 60 km/h were mentioned for the evening. No public warnings were in effect. That threshold is technically 80km/h and/or gusts to 100km/h for West Coast Vancouver Island region. For Victoria, which arguably the Sooke folk are possibly/probably using, the threshold is 70km/h and/or gusts to 90km/h. The marine forecast called for increases in west wind to 30-40knots (55-75km/h).

SUBJECT: Changing Child Care Licensing Regulations (CCLR) for School-Age Child Care

PURPOSE: Describe proposed streamlining to CCLR for school-age care on school

grounds.

BACKGROUND:

- The Province's Child Care BC Strategy envisions that school districts to play a stronger role in the provision of child care; the short-term focus is on school-age care on school grounds.
- Child Care Working Group (of Cabinet) has approved a school-age child care strategy
 beginning with School Act amendments enacted in February 2020. The amendments clarify
 that it is within a board of education's mandate to provide licensed before- and after-school
 care programs on board property directly, in addition to partnering with third party
 licensees.
- School district personnel have identified, as a challenge, differences between licensing regulations for school-aged children and the safety protocols school districts already have in place.
 - In January 2020, EDUC and HLTH met with a group of district and school administrators with direct experience navigating CCLR to review specific possibilities for streamlining.
- HLTH is responsible for CCLR and is working with EDUC to streamline school-age care regulations. Drafting the revised regulations is currently underway.
