SUBJECT: Report on federal child care fee targets by the Canadian Centre for Policy

Alternatives (CCPA)

PURPOSE: To summarize and discuss the CCPA's findings related to B.C.'s targets.

BACKGROUND:

 The CCPA's National Office (Ottawa) coordinates national research and publishes reports, studies, and commentary on a wide range of public policy issues.

- On May 10, 2022, the CCPA released its eighth report in a series tracking child care fees titled Game Changer: Will provinces and territories meet the federal child care fee targets?
- The report draws on publicly available information along with survey data from the CCPA's
 annual survey of licensed child care in 37 Canadian cities¹ to assess plans by provinces and
 territories to achieve affordability targets set out in their respective Canada-Wide Early
 Learning and Child Care (CW-ELCC) Agreements.
- Most CW-ELCC Agreements include a commitment to reducing average fees by 50%² and the report discusses the four main policy approaches being taken by provinces and territories to meet this target:
 - Reducing provincially/territorially set fees in regulated child care
 - Introducing a flat-rate fee reduction
 - Requiring each service provider reduce fees by 50%
 - Changing the value or eligibility for fee subsidies
- B.C. will primarily use flat-rate fee reductions to achieve its 50% target³ and the CCPA suggests that while this is the most common approach, it is less predictable and transparent than setting standard fees, results in a wider variety of fees, and may be difficult to monitor accountability.

DISCUSSION:

 The CCPA uses municipal median fees collected through its annual survey of licensed child care centres to calculate required fee reductions in B.C. See Appendix A.

² Quebec has had its own ELCC system since 1997 with a reduced parental contribution; its CW-ELCC agreement focuses on strengthening that system. Yukon has reduced fees by 50% via its average \$10/day universal program and commits to expanding this program under the CW-ELCC.

³ B.C.'s CW-ELCC Agreement commits to reducing average out-of-pocket child care fees (based on 2019 levels) by 50% by the end of 2022, and to an average of \$10 per day by 2025. This will be achieved through a combination of increased fee reductions and expanding the number of \$10 a Day ChildCare BC spaces.

- Based on its analysis, the CCPA projects that only some of the 37 cities it surveyed will meet the 50% target; however, the report admits that they cannot confirm if B.C. will meet its target because only high-level information about B.C.'s plan has been released:
 - The number of \$10 a Day spaces will increase to 12,500 spaces by the end of 2022
 - The existing Child Care Fee Reduction Initiative (CCFRI) discounts will increase
- There are a number of ways in which the CCPA's analysis differs from how B.C. will calculate required fee reductions to meet the commitments under the CW-ELCC Agreement:
 - The CCPA data is from a much smaller sample size than the Ministry gains from its Annual Provider Profile Survey of all child care providers receiving operating funding.
 - Our commitment to reduce fees by 50% is based on a provincial average. As a result, individual families may see their fees reduced by more or less than 50%.
 - B.C.'s expansion of \$10 a Day ChildCareBC Sites to 12,500 spaces will also play a role in reducing average fees by 50%.
- The report also discusses B.C.'s cap on fee increases⁴ stating that in practice, increase caps are more difficult to monitor than set fees and new centers can open with exorbitant fees⁵.
- The CCPA concludes by stating that providing operational funding combined with provincially and territorial set fees, rather than fee increase caps, "offers the most predictable and transparent way of achieving fee reduction and other learning and child care goals, as well as tracking the impact of public funding." (p. 47).
- The CCPA further projects that after fees drop, public demand for access will become the
 focus and that provinces and territories should work towards enhancing access through
 physical facilities and recruiting and retaining educators to operate those spaces.

CONCLUSION:

 Although the CCPA suggests that five major cities in B.C. may not see child care fees drop by 50% by the end of this year, B.C. is on track to fulfil its commitment in the CW-ELCC Agreement. See Appendix B.




