### Dear Sir or Madam:

I am opposed to allowing Imperial Metals to re-open the Mount Polley Mine. Based on my discussion s with m any indigenous peoples, I do not believe that the re-opening of the mine has the support of the majority of peoples of the Secwepemc Nation, nor the general (indigenous and not) populace off reserve. Williams Lake Band council may appear to support this endeavour, but that does not mean that the majority of Williams Lake Band members do support it. Also, Williams Lake Band does not speak for all Secwepemc peoples. The only way to really understand the interests of the Secwepemc and settler peoples of the regions affected, in my opinion, is to create a poll or referendum. Imperial Metals states that they fulfilled their obligation to have community meetings but in no way reports on how they were responded to by the communities. The BC Conservation Service inquiry, in conjunction with the RCMP, Environment Canada and Fisheries and Oceans Canada, is investigating the impacts of the Mt Polley Breech on the environment and their report is not due out until June. Will the res ults of that investigation be available for the Ministry of Energy and Mines and Ministry of Environment to use in their decision about this re-opening permit application? Why is the deadline for public comment so soon, meaning that we will not have these BC Conservation Service inquiry results available to us by your May 2 deadline for public comment?

It states in the Water Management Plan (WMP) document (Golder 2015) that the current permit allows 1.4 million cubic mm of water discharge, while at the same time stating that the current discharge could be 3 times that. It also states that onsite levels of Nitrate, Copper, Sulphate, Aluminum, Iron, Selenium and Suspended Solids are above accepted concentrations. The report implies that if the WMP is not pushed through then previously unaffected areas like Bootjack Lake will potentially be impacted. This feels like the threat of contamination of Bootjack Lake is being used to push through the latest permit application. The Return to Restricted Operations permit application implies that they will be working at reduced capacities, although the work suggested is at half load, which is still very substantial. I feel strongly that pushing this Return to Restricted Operations Permit through before the results from the BC Conservation et al inquiry, and a fuller understanding of the actual individual First Nations and settler support or rejection of this permit is unnacceptable. Scientists in the area reported a substantial diatom dieoff in the fall of 2014 in Quesnel Lake. Diatoms feed zooplankton that salmon fry consume. Until we better understand the long term impacts of the disaster on the environment, we cannot justify putting any more people, animals and flora in jeopardy by re-opening the mine. The clean-up that has occurred impacts especially on salmon before any re-opening at any capacity will be considered. The WMP could be put into place without starting up the mine again.

## To Whom It May Concern:

While an expert Panel review was released at the end of January, no entity or person has been held directly responsible for the 25 million cubic metres of toxic effluent, metals, medical biohazard and mining-related chemicals that are now in the environment. The minimal clean-up that has occurred barely begins to address the impacts on the environment. There are still two pending investigations taking place. The severity of the damage created by the Mt. Polley disaster remains unknown and yet you, the B.C. government, are now considering a reopening of the mine. Given all of the above, it seems premature to restart the mine that caused the "largest environmental disaster in B.C.'s history".

Given that Imperial Metals did not follow the approved design specifications of their containment walls (ignoring slope, height and material specifications), how can we expect the company to properly correct the dam and other facilities for the mine to re-start? In addition, how can the public be confident that B.C. regulations have strengthened to prevent further disaster when nothing's changed yet, and the original project was carried out in accordance with B.C. regulations?

From the application, there are still many doubts and concerns. Given the water bodies that have been impacted by the disaster, it seems negligent to approve a design that may contaminate yet another, namely Bootjack Lake. There is no long-term plan to handle the large amounts of water it will need to treat in perpetuity. In fact, Imperial Metals has outlined not an actual water treatment plan, but a plan for a plan (to be complete by the end of April 2016; and then a typical Imperial Metals' self-imposed rush deadline to build it within 90 days that could lead to more corners cut).

The tailings from Mount Polley, while not acid-generating to date, are not benign. Over the years, the toxic metals and waste oxidize and react

posing more risks to nearby watersheds. This proposal, that includes potential discharges into various watersheds, does not adequately address the waste stream from the mine and long-term impacts.  $\mathbb{Q}$ 

This application for restart (as well as Imperial Metals' request for a permanent permit for Red Chris) appears to indicate huge flaws in the British Scolumbia's bond and liability insurance limits. Should the company responsible for the largest mining disaster in Canada's history really be granted permits to continue operating less than a year later just to keep them afloat? No. The safety and health of both communities and watersheds, as well as the integrity of the whole mining industry in B.C., is at stake. This permit application from Imperial Metals to restart

Thank you for the opportunity to comment on the applications by Mount Polley Mining Corporation to amend their Environmental Management Act and Mines Act Permits.

I didn't live in this area at the time this mine was approved so I don't have any personal knowledge of what happened at that time but I feel it is necessary to review the history of this project in order to place the August 4 disaster and the current application to restart operations in the proper context.

Fortunately, a submission to the *Mount Polley Independent Expert Engineering Investigation and Review Panel* by the Environmental Law Center from the University of Victoria includes a comprehensive documentation of the approval of the Mount Polley Mine. According to this submission, *a key issue for the public and First Nations concerning approval of the Mount Polley Mine was impacts to pristine or near pristine water bodies such as Hazeltine Creek, Polley Lake and Quesnel Lake. This issue was so significant that Imperial Metals agreed there would be no discharges from the tailings pond or pits. No effluent discharge was a key condition of mine approval and Imperial Metals committed to maximum recycle of tailings and pit water, evaporation enhancing techniques and, if necessary, raising the tailings pond berm height to maintain an allowable freeboard to achieve a negative balance in the tailings pond. At this point in time I can't help but wonder about the sincerity and/or the feasibility of this commitment.* 

It is commonly accepted that creation of jobs through mining will come at a cost, both short and long term, to the environment, to local residents and to the general public. The question for decision makers is at what point are the costs too high to be justified? I can imagine that at times it can be difficult to weigh the costs (including long term risks) and the benefits but in this situation it is clear that the impact of the failure of the TSF far outweighs the short-term economic benefits.

Oldon't have enough information to form an opinion on whether or not the mine should be allowed to re-start operation, but I feel strongly that Mount Polley Mines shouldn't be allowed any additional discharges into the environment. They have used more than their share of the natural environment's ability to absorb pollution and it would be a travesty if they were permitted to add to the damage!

This mine was approved on the basis of no discharge from tailings ponds or pits and this should be the requirement for any restart of operations.

Another important consideration relating to this application is the credibility of the applicant. There was evidence suggesting negligence as a contributing factor to failure of the TSF embankment and there are outstanding investigations. I think the public may be reluctant to share any additional risks with this company and is expecting someone to be held accountable for this disaster.

#### To Whom it May Concern,

I am very opposed to allowing Imperial Metals to re-open the Mount Polley Mine. Based on my discussions with many indigenous peoples, I do not believe that the re-opening of the mine has the support of the majority of peoples of the Secwepemc Nation, nor the general (indigenous and not) populace off reserve. Williams Lake Band council may appear to support this endeavour, but that does not mean that the majority of Williams Lake Band members do support it. Also, Williams Lake Band does not speak for all Secwepemc peoples. The only way to really understand the interests of the Secwepemc and settler peoples of the regions affected, in my opinion, is to create a poll or referendum. Imperial Metals states that they fulfilled their obligation to have community meetings but in no way reports on how they were responded to by the communities. The BC Conservation Service inquiry, in conjunction with the RCMP, Environment Canada and Fisheries and Oceans Canada, is investigating the impacts of the Mt Polley Breech on the environment and their report is not due out until June. Will the results of that investigation be available for the Ministry of Energy and Mines and Ministry of Environment to use in their decision about this re-opening permit application? Why is the deadline for public comment so soon, meaning that we will not have these BC Conservation Service inquiry results available to us by your May 2 deadline for public comment?

It states in the Water Management Plan (WMP) document (Golder 2015) that the current permit allows 1.4 million cubic mm of water discharge, while at the same time stating that the current discharge could be 3 times that. It also states that onsite levels of Nitrate, Copper, Sulphate, Plantinum, Iron, Selenium and Suspended Solids are above accepted concentrations. The report implies that if the WMP is not pushed through then previously unaffected areas like Bootjack Lake will potentially be impacted. This feels like the threat of contamination of Bootjack Lake is being used to push through the latest permit application. The Return to Restricted Operations permit application implies that they will be working at reduced capacities, although the work suggested is at half load, which is still very substantial. I feel strongly that pushing this Return to Restricted Operations Permit through before the results from the BC Conservation et al inquiry, and a fuller understanding of the actual individual First Nations and settler support or rejection of this permit is unnacceptable. Scientists in the area reported a substantial diatom dieoff in the fall of Q 2014 in Quesnel Lake. Diatoms feed zooplankton that salmon fry consume. Until we better understand the long term impacts of the disaster on the Penvironment, we cannot justify putting any more people, animals and flora in jeopardy by re-opening the mine. The clean-up that has occurred (minimal) barely begins to address the impacts on the environment. I suggest that more time is spent getting an understanding of the long term impacts especially on salmon before any re-opening at any capacity will be considered. The WMP could be put into place without starting up the

I am very opposed to allowing Imperial Metals to re-open the Mount Polley Mine.

The BC Conservation Service inquiry, in conjunction with the RCMP, Environment Canada and Fisheries and Oceans Canada, is investigating the impacts of the Mt Polley Breech on the environment and their report is not due out until June. Will the results of that investigation be available for the Ministry of Energy and Mines and Ministry of Environment to use in their decision about this re-opening permit application? Why is the deadline for public comment so soon, meaning that we will not have these BC Conservation Service inquiry results available to us by your May 2 deadline for public comment?

The Return to Restricted Operations permit application implies that they will be working at reduced capacities, although the work suggested is at half load, which is still very substantial. I feel strongly that pushing this Return to Restricted Operations Permit through before the results from the BC Conservation inquiry, and a fuller understanding of the actual individual First Nations and settler support or rejection of this permit is unnacceptable. Scientists in the area reported a substantial diatom dieoff in the fall of 2014 in Quesnel Lake. Diatoms feed zooplankton that salmon fry consume. Until we better understand the long term impacts of the disaster on the environment, we cannot justify putting any more people, animals and flora in jeopardy by re-opening the mine. The clean-up that has occurred (minimal) barely begins to address the impacts on the environment. I suggest that more time is spent getting an understanding of the long term impacts especially on salmon before any re-opening at any capacity will be considered. The WMP could be put into place without starting up the mine again.

were deeply disappointed by this sudden about-face on the part of Minister Bennett; and, so, we are writing to you coun, and you country and environmental remediation work at the spill site have been completed.

The failure of the tailings storage facility (TSF) at Mount Polley gold and copper mine on August 4th, 2014, has been called one of the worst tailings spills on Earth and the biggest environmental disaster in modern Canadian history. Tens of billions of litres of liquid and solid mining waste were released into one of <sup>8</sup> Canada's most treasured deep-water lakes. One of the deepest fjord lakes on the planet and home to a full quarter of the Fraser River sockeye run, Quesnel Lake is a popular destination for paddlers and recreational fishermen, supporting a healthy eco-tourism industry; all of which has now been put at risk.

A central pillar of Mount Polley's Long-Term Water Management Plan (WMP) is the use of Springer Pit to store contact water and tailings generated by operations at the mine. We feel that this plan is highly problematic in that Springer Pit is currently unsecured, with no protective lining to prevent the leaching

of tailings and waste-water into local groundwater aquifers. Imperial Metals' VP of corporate affairs, Steve Robertson, has told the media that "nobody has brought up" leaching concerns for Springer pit because the pit is "solid bedrock" and subject to slow water inflow. However, Mount Polley's Approach for Long-Term Water Management Plan Development directly contradicts Mr. Robertson's statements, noting that the pit has "a finite capacity and it is estimated that once water in the Springer Pit reaches the 1030 m elevation, the pit water will infiltrate into groundwater that will report to Bootjack Lake". The plan goes on to urgently recommend the development of options for the treatment and disposal of contact water from the mine in order to mitigate this concern.

Mount Polley's WMP also notes that both the Ministry of the Environment and Ministry of Energy and Mines have required that the mine develop a contingency plan for dealing with excess water in the event that the finite capacity of Springer pit is exceeded. Shockingly, this contingency plan includes proposed provisions for discharging waste-water into both Quesnel Lake and Hazeltine Creek, remarking that "At present, Hazeltine Creek does not have fish in it. Therefore, if used as a conveyance structure, Hazeltine Creek would not be required to meet ambient water quality guidelines." While the WMP does acknowledge that treatment using best-available-technologies and a dilution zone in Quesnel Lake will remain a requirement for discharge, we are still deeply concerned about the use of these water bodies, which have been historically known to support populations of wild salmon and trout, for the discharge of any effluents from this mine.

Finally, in addition to the above concerns in regards to the mine's WMP, we have grave concerns about Imperial Metals' clear record of negligent operation of Mount Polley mine's TSF, currently the subject of a criminal investigation by members of the BC Conservation Officer's Service and the RCMP. From reported failures to replace lost and damaged monitoring equipment to chronic problems maintaining a tailings beach between the water in the TSF and the dam itself to prevent saturation, the examples of unsafe and irresponsible action on the part of mine operators are numerous and troubling. Indeed, while blame for the failure of Mount Polley's TSF has largely been placed on a layer of unstable glacial clay beneath its foundations which was tragically overlooked by its engineer of record, the province's Mount Polley Independent Expert Investigation and Review Panel noted that there were other significant issues with the mine's TSF operations which could have also led to a failure. Quoting from the panel's report: "The panel was disconcerted to find that, while the Mount Polley tailings dam failed because of an undetected weakness in the foundation, it could have failed by over-topping, which it almost did in May 2014. Or it could have failed by internal erosion, for which some evidence was discovered... Clearly, multiple failure modes were in progress, and they differed mainly in how far they had progressed down their respective failure pathways."

Taking into account Imperial Metal's record of negligent operations at Mount Polley mine along with our serious concerns about the mine's proposed WMP, including the use of Springer pit to store wet tailings and the discharge of waste-water into Quesnel Lake and Hazeltine Creek, we strongly feel that any move to permit a restart of operations at Mount Polley would be dangerous and premature. We \$22 are urging the government of BC to place a hold on issuing any operating permits for Mount Polley mine until the findings of the criminal investigation into the TSF failure have been released and environmental remediation to mitigate the damage done by this disaster have been completed.

Thank you for taking the time to review our comments. We sincerely hope that you will seriously consider the points we have raised with you today, and that you will demonstrate to all British Columbians your commitment to protect swimmable, drinkable, and fishable water in our province by rejecting Imperial 4 Metal's application to reopen Mount Polley mine.

We s.22 were deeply disappointed by this sudden about-face on the part of Minister Bennett; and, so, we are writing to you today to express our strong opposition to a restart of mining operations at Mount Polley mine until investigations into the TSF failure and environmental remediation work at the spill site have been completed.

The failure of the tailings storage facility (TSF) at Mount Polley gold and copper mine on August 4th, 2014, has been called one of the worst tailings spills on Earth and the biggest environmental disaster in modern Canadian history. Tens of billions of litres of liquid and solid mining waste were released into one of Canada's most treasured deep-water lakes. One of the deepest fjord lakes on the planet and home to a full quarter of the Fraser River sockeye run, Quesnel Lake is a popular destination for paddlers

and recreational fishermen, supporting a healthy eco-tourism industry; all of which has now been put at risk.

A central pillar of Mount Polley's Long-Term Water Management Plan (WMP) is the use of Springer Pit to store contact water and tailings generated by operations at the mine. We feel that this plan is highly problematic in that Springer Pit is currently unsecured, with no protective lining to prevent the leaching of tailings and waste-water into local groundwater aquifers. Imperial Metals' VP of corporate affairs, Steve Robertson, has told the media that "nobody has brought up" leaching concerns for Springer pit because the pit is "solid bedrock" and subject to slow water inflow. However, Mount Polley's *Approach for Long-Term Water Management Plan Development* directly contradicts Mr. Robertson's statements, noting that the pit has "a finite capacity and it is estimated that once water in the Springer Pit reaches the 1030 m elevation, the pit water will infiltrate into groundwater that will report to Bootjack Lake". The plan goes on to urgently recommend the development of options for the treatment and disposal of contact water from the mine in order to mitigate this concern.

Mount Polley's WMP also notes that both the Ministry of the Environment and Ministry of Energy and Mines have required that the mine develop a contingency plan for dealing with excess water in the event that the finite capacity of Springer pit is exceeded. Shockingly, this contingency plan includes proposed provisions for discharging waste-water into both Quesnel Lake and Hazeltine Creek, remarking that "At present, Hazeltine Creek does not have fish in it. Therefore, if used as a conveyance structure, Hazeltine Creek would not be required to meet ambient water quality guidelines." While the WMP does acknowledge that treatment using best-available-technologies and a dilution zone in Quesnel Lake will remain a requirement for discharge, we are still deeply concerned about the use of these water bodies, which have been historically known to support populations of wild salmon and trout, for the discharge of any effluents from this mine.

Finally, in addition to the above concerns in regards to the mine's WMP, we have grave concerns about Imperial Metals' clear record of negligent operation of Mount Polley mine's TSF, currently the subject of a criminal investigation by members of the BC Conservation Officer's Service and the RCMP. From reported failures to replace lost and damaged monitoring equipment to chronic problems maintaining a tailings beach between the water in the TSF and the dam itself to prevent saturation, the examples of unsafe and irresponsible action on the part of mine operators are numerous and troubling. Indeed, while blame for the failure of Mount Polley's TSF has largely been placed on a layer of unstable glacial clay beneath its foundations which was tragically overlooked by its engineer of record, the province's Mount Polley Independent Expert Investigation and Review Panel noted that there were other significant issues with the mine's TSF operations which could have also led to a failure. Quoting from the panel's report: "The panel was disconcerted to find that, while the Mount Polley tailings dam failed because of an undetected weakness in the foundation, it could have failed by over-topping, which it almost did in May 2014. Or it could have failed by internal erosion, for which some evidence was discovered... Clearly, multiple failure modes were in progress, and they differed mainly in how far they had progressed down their respective failure pathways."

Taking into account Imperial Metal's record of negligent operations at Mount Polley mine along with our serious concerns about the mine's proposed WMP, including the use of Springer pit to store wet tailings and the discharge of waste-water into Quesnel Lake and Hazeltine Creek, we strongly feel that any move to permit a restart of operations at Mount Polley would be dangerous and premature. We s 22

are urging the government of BC to place a hold on issuing any operating permits for Mount Polley mine until the findings of the criminal investigation into the TSF failure have been released and environmental remediation to mitigate the damage done by this disaster have been completed.

Thank you for taking the time to review our comments. We sincerely hope that you will seriously consider the points we have raised with you today, and that you will demonstrate to all British Columbians your commitment to protect swimmable, drinkable, and fishable water in our province by rejecting Imperial Metal's application to reopen Mount Polley mine.

To the Cariboo Region Mine Development Review Committee,

I am writing to express my outrage that the BC Provincial Government is considering Imperial Metals Corporation's application to reopen the Mount Polley Mine site.

The Mount Polley disaster in August of 2014 released approximately 10 billion liters of contaminated water and 4.5 million cubic meters of metals-laden fine sand into the Fraser River watershed via Hazelton Creek, Polley Lake and Quesnel Lake. [1] According to initial studies undertaken by the University of Northern British Columbia's Quesnel River Research Centre, the resulting plume of toxic sediment has moved down Quesnel Lake and into Quesnel River. [2] The heavy metals and other contaminants from the ruptured Tailings Storage Facility are bioaccumulative; we can thus expect that salmon, as predatory fish, will accumulate much higher concentrations of these materials in their fatty tissues that what is found currently in the contaminated sediments. [3]

Salmon play a profound role in the lives of Indigenous peoples in BC; the contamination of this watershed thus constitutes an unquantifiable injury to the Secwepemc First Nation, as well as to all of those Nations downstream between the breached Tailings Storage Facility and the delta of the Fraser River. As a settler hoping for genuine reconciliation with the Indigenous Nations where I live, I find this assault absolutely unacceptable.

As reported in the Tyee, "the Northern Secwepemc te Qelmucw leadership council, which is composed of four northern Secwepemc bands, finalized a mining policy dated Nov. 19, 2014. ...The 54-page policy outlines exactly what the Secwepemc expect to happen within any current or future mine on its more than 53,000 square kilometers of traditional territory."[4] Until this mining policy – and thus respect for Indigenous rights and title – is fully integrated into the provincial approach to mining proposals, no new approvals should be granted to mining projects on Secwepemc territory.

Salmon also play a vital role in maintaining the ecosystemic integrity of the forests on the West Coast. [5] As someone who loves the lands and waters in this place, the Mount Polley disaster – and the long-term contamination and physical suffering it undoubtedly implies for human beings, eagles, bears and other inhabitants of the Fraser River watershed – has caused me very acute grief. According to a filing with Environment Canada in 2013, 326 tonnes of nickel, 400 tonnes of arsenic, 177 tonnes of lead and 18,400 tonnes of copper and its compounds had been dumped into the tailings pond. [6] Ingestion of these contaminants takes place not only through the consumption of fish and other animals, but through drinking water and inhalation of the airborne dust that moves through the area as the tailings dry out.

According to a recent article in the Victoria Times Colonist, "...on Jan. 27, the total aluminum reading in Quesnel Lake at the outlet of Hazeltine Creek — the path the mine waste flowed to reach the lake — was nearly 15 times the Canadian drinking water guideline. Tests showed that levels of iron were six times above Canadian drinking water guidelines and manganese was twice the guideline. Aluminum levels were also exceeded in the month of January at the Quesnel River bridge at Likely and farther downstream at the Gravelle Ferry Bridge. ... The latest results from February and March show government guidelines were exceeded for copper for aquatic life on the Quesnel River near the town of Likely, downstream from the mine."[7] While the company claims that the water will be clear of contamination by August 2015, Quesnel Lake turns over during seasonal temperature changes in the spring and fall, bringing water from the depths – and thus also contaminated sediments – up to the surface. Until the contaminated sediments are removed, therefore, the safety of drinking water in the area will be seriously compromised.

In my academic work on water, I have reviewed the links between aquatic contamination and cancer, reproductive disorders, neurological disorders and other serious afflictions. While difficult to precisely quantify, a spill like the Mount Polley disaster means that more people will suffer from cancer and that more people will suffer watching their loved ones die before their time. Children will suffer from disorders based on their exposure to these toxins in utero and during the vulnerable years of brain development. Animals in the region will also suffer from similar afflictions. The contamination of water on this scale thus represents a profound act of violence.

The negligence of Imperial Metals Corporation – and thus their culpability for this disaster – is beyond question. The design of the tailings dam required that a dry beach should be maintained between the tailings and the dam itself. Aerial photos from the 2012 Annual Review of the Tailings Storage Facility show that this required beach zone was already absent along 40% of the impoundment perimeter. Despite documentation that the water volumes behind the dam exceeded Maximum Operating Levels in May of 2014, Imperial Metals Corporation elected to continue depositing tailings into the already-overloaded Storage Facility.[8] To grant this company permission to continue extracting profits from this mine site – or from any mine site in this province, for that matter – sets an appalling precedent for corporate impunity. Moreover, I am not convinced that Imperial Metals Corporation has an adequate plan in place to safely contain additional toxic wastewater if they are permitted to continue operation of the mine.

Cleanup of the spill has not been anything close to adequate. As indicated above, the contaminated tailings must be removed from the affected areas and placed into an effective containment facility to protect human and ecosystemic health.

To approve the reopening of the Mount Polley mine would effectively sanction and intensify what has already been a devastating violation. To approve the re

British Columbia must reject the reopening of Imperial Metals' Mount Polley mine without their consent of communities impacted by the tailings disaster.

The Government of British Columbia is failing the indigenous people of Secwepemc territories, the residents of Likely, BC and those living on the Quesnel and Fraser River watersheds. This is a matter of urgent concern for all our organizations.

On 04 August 2014, the tailings storage facility at the Mount Polley Mine, near Likely, BC, and owned by Imperial Metals Corporation (IMC), had a catastrophic failure, allowing approximately 25 millions of cubic metres of toxic sludge and contaminated water to rush into nearby Polley Lake and seven kilometers down Hazeltine Creek to Quesnel Lake. This spill is one of the biggest environmental disasters in modern Canadian history.

The BC Government initially denied it was an environmental disaster, has downplayed the damage and has taken little to no action to assure that such a disaster would not happen again. Now, Imperial Metals Corporation has submitted an application to provincial regulators to return to operations. Our organizations strongly urge that this application be rejected for the following reasons:

## To Whom it May Concern,

I am very opposed to allowing Imperial Metals to re-open the Mount Polley Mine. Based on my discussions with many indigenous peoples, I do not believe that the re-opening of the mine has the support of the majority of peoples of the Secwepemc Nation, nor the general (indigenous and not) populace off reserve. Williams Lake Band council may appear to support this endeavour, but that does not mean that the majority of Williams Lake Band members do support it. Also, Williams Lake Band does not speak for all Secwepemc peoples. The only way to really understand the interests of the Secwepemc and settler peoples of the regions affected, in my opinion, is to create a poll or referendum. Imperial Metals states that they fulfilled their obligation to have community meetings but in no way reports on how they were responded to by the communities. The BC Conservation Service inquiry, in conjunction with the RCMP, Environment Canada and Fisheries and Oceans Canada, is investigating the impacts of the Mt Polley Breech on the environment and their report is not due out until June. Will the results of that investigation be available for the Ministry of Energy and Mines and Ministry of Environment to use in their decision about this re-opening permit application? Why is the deadline for public comment so soon, meaning that we will not have these BC Conservation Service inquiry results available to us by your May

R2 deadline for public comment?
It states in the Water Management Plan (WMP) document (Golder 2015) that the current permit allows  $\frac{\mathbb{Z}}{2}$  1.4 million cubic mm of water discharge, while at the same time stating that the current discharge could § be 3 times that. It also states that onsite levels of Nitrate, Copper, Sulphate, Aluminum, Iron, Selenium and Suspended Solids are above accepted concentrations. The report implies that if the WMP is not spushed through then previously unaffected areas like Bootjack Lake will potentially be impacted. This <sup>™</sup>feels like the threat of contamination of Bootjack Lake is being used to push through the latest permit application. The Return to Restricted Operations permit application implies that they will be working at

reduced capacities, although the work suggested is at half load, which is still very substantial. Scientists in the area reported a substantial diatom die-off in the fall of 2014 in Quesnel Lake. Diatoms feed zooplankton that salmon fry consume. The clean-up that has occurred (minimal) barely begins to address the impacts on the environment. #### **Recently I learned that:**

The province of BC has accepted the application to reopen Imperial Metals mine, giving one month, until May 2, for public comment. The Secwepemc Women Warriors Society, who have been monitoring the impacts at disaster site and who called the, National Day of Action, argues that by "Allowing this corporation to reopen the Mount Polley mine is a violation of sovereignty and opens the territory up to further damage. Imperial Metals has no consent from the Secwepemc."

It must be a very hard job, holding office and trying to balance those things that supply the economy while protecting the environment. However, surely you must see that if we ruin the place where we live, there will be nowhere else to go? As governors of this land (equal in government to our B.C. Provincial leaders) the Secwepemc people should be treated with high regard. The people of B.C. are counting on you to hear them, recognize the true nature of this disaster, and stop the Mt. Polley Mine from entering into operation at this time.

Peace of mind has been lost, quality of life has been ruined, the land is ripped, torn and polluted in the Mt. Polley mining area. When will we stop and see that once our water is no longer drinkable, our air is no longer fit to breathe and our land in full contamination that we will have nothing? Our First Nations people know the true meaning of honour and the privilege we have in a land of such abundance - we need to listen to them and heed their words.

#### In October of 2014, I read:

Dr. Lemly declined to be interviewed because the situation in the Elk Valley is under active investigation, but he has expressed his views on selenium pollution in the past.

"How bad does it have to get? Unfortunately, you have to have the ecological equivalent of a nuclear meltdown for people to stop and say, 'Wait a minute. We are doing more harm than good,'" he said, commenting on a situation in Idaho, where a chronic selenium problem only caused alarm after trout were found with two heads.

Dr. Lemly has also commented on why scientific research about selenium pollution often gets ignored: "It's not a question of knowing better, it's a question of not wanting to know. If policy makers would rather let egos, power and money stand in the way of protecting the environment, then they should be held responsible."

Responsible... and in a position of honour because you hold all of us in your hands. Something has to change. I feel sorry for government that there is so much "putting on a show" that you feel you must do. But the people want you to be real, speak your truth and show courage - the courage to stand up and say - a hard path is before us, but we can make it there, together.

Please - no one wants a government that ignores the cries of the people. Please put the honour back into "honourable" and stop the Mt. Polley Mine from continuing until such time as the damage is fully understood and rectified to the best possible outcome.

Please, bring all the honour your titles say that you stand for, and make this right.

After reading through the MPMC's "permit amendment application for re-start, myself and my immediate family members **are very opposed** to allowing Imperial Metals to re-open the Mount Polley Mine and to the permit application.

The starting of the milling operation will increase metals' concentrations within mill recycle water flows. The metals here are complex and would require an expensive form of mine water treatment. The MPMC has not agreed to even consider a treatment plant as an option. MPMC has only investigated "passive treatment." Now MPMC seems to be looking for *dilution* within the larger Quesnel lake or Quesnel river system by diffuser-pipe to save money. The water balance accumulation will require better management than MPMC have suggested.

The interstitial water/Arsenic and Cadmium that was released during the dam failure will cause possible dissolved heavy metals to enter the food web and depending upon the concentration of metals ...copper is lethal to fish and Cadmium lethal to bot fish and humans. Many sub-lethal biological impacts cannot be "measured." We do not know the effects on the small fish fry and we will not know these true impacts until the cycle of sockeye salmon-run do not return in 3 or 4 years. Until we better understand the long term impacts of this disaster we cannot agree to or justify further re-start of operations.

There are two outstanding reports and many missing documents and amendments. The Conservation Service inquiry (in conjunction with the RCMP), and Environment Canada and Fisheries and Oceans, have not finalized their reports. The focus of government and MPMC should be on the future Water Management of the area and continued research this TSF disaster has caused.

Also, the Waste Handling Plan; the mines Act Permit; and the Effluent Discharge Permit, all need to be better explained to all of the local people. We have endured lies and insults and this has caused misunderstanding in our community's. Sincerely.

Thank you for taking our comments. See I believe in sustainability and I would like to see the community of Likely endure. However, tourism is the no. 1 industry in Likely, and while the mine provides some temporary surges of money into the community, the preservation of Quesnel Lake and assurance of it's health for a lifetime of tourism outweighs the mine benefits by far.

I am very concerned that for years Mount Polley Mining Corporation applied to discharge supernatant water down Hazeltine Creek and into Quesnel Lake. These proposals were not accepted and there was much concern. Hazeltine Creek was home to 13 species of fish. I believe that by approving the MPMC permit with their plan to discharge water down Hazeltine Creek gives a clear message that if you eliminate the problem of fish - i.e. by destroying the habitat and making the creek no longer suitable for fish, then you are free to dump your mine waste.

Many many people feel that the clean up efforts have merely been a means to creating an effluent channel. This is unacceptable. We do not know the full impact of this breach. While the presentation to the public of all tests is that "everything is fine". The actual reports from Minnow show that there was fatality and reproductive impairment in Fathead Minnow and C. Daphnia. They suggested bi-monthly testing. The only follow up to this was a memo from Imperial Metals on January 15th stating that they have done a lot of testing and there were no toxicity due to metals. There are no independant lab reports to go with this? It stated in the Minnow report that "However, all Quesnel Lake deep water samples were observed to impair C. dubia reproduction". No follow up to this? Do you all just expect that none of us will read these reports?

My primary concern from the start is the possible return of endangered coho to this creek. These coho survived the last 100 years after flow from Bootjack Lake to Hazeltine Creek was diverted for Bullion Pit mining in the early 1900 and never restored. Flow to this creek was never restored due to mining, yet these fish managed to make it every year. Maybe only 12 fish, but they made it. We have to ensure a suitable habitat for these fish. There are no plans for cleaning tailings out of Quesnel Lake and no single expert has a positive answer for us yet as to how this is going to turn out. We need to see your primary concern being restoring this habitat and monitoring the fish and the creek and the lake. NOT allowing this mine to discharge down the creek into the lake.

I would like to see Mount Polley reopen at some capacity eventually if they were to do dry-stack tailings or water purification. It is unreasonable that after what happened they were given the green light to open Red Chris Mine and that now they are being considered to open MP without applying any best available technology. This is unacceptable.

and when Mtn. Polley Mine tailing lake burst, I took some time to look into the issue.

What I found, scared the hell out of me, that the Government of Canada and BC would licence such a mine in the first place. This mine should have never opened up in this local, due to the local glacial clay terrain, the self policing and required maintenance of the toxic waste site well after the mine closes. Certainly, the mine should not be opened up ever. It should be closed down permanently, right now, today.

I do not believe that this mine is sustainable. The cost to properly manage the waste site and the amount of water run off will cost the public taxpayer dearly over the next 1000 years and beyond. I calculated the amount of money made from this site, the benefits to the public in tax income and wages and business versus the price of looking after this site for over a 1000 years. This is short term gain (greed) for long term pain.

This toxic waste site has to be managed well after the mine closes down and stops producing gold and copper. This kind of maintenance cost never show up in the mine's present bond. The present bond is for reconstituting and reclaiming the surrounding mine site after the site closes down. I believe from current BC government records that less than 19 million dollars is set aside for this kind of reclaiming so far.

Presently what I have noticed is that the re-permitting of Mtn. Polley Mines is a licence to pollute our water ways with about 30 heavy metals. Some of these toxic metals are very damaging to human and animal life. This is totally unacceptable to me.

In short, you are planing to dump thousands of cubic meters of toxic mine wastes into Hazeltine Creek or pipe it directly into Quesnel River. This would be a terrible crime and I will support to prosecution of any government official or politician who authorizes such a damaging event.

I also think that the two outstanding investigations that were announced and have not been reported to the public, would be compromised, if you entertain such a permit reopening. I hope criminal charges are laid.

To Whom it May Concern,

I am very opposed to allowing Imperial Metals to re-open the Mount Polley Mine. Based on my discussions with many indigenous peoples, I do not believe that the re-opening of the mine has the support of the majority of peoples of the Secwepemc Nation, nor the general (indigenous and not) populace off reserve. Williams Lake Band council may appear to support this endeavour, but that does not mean that the majority of Williams Lake Band members do support it. Also, Williams Lake Band does not speak for all Secwepemc peoples. The only way to really understand the interests of the Secwepemc and settler peoples of the regions affected, in my opinion, is to create a poll or referendum. Imperial Metals states that they fulfilled their obligation to have community meetings but in no way reports on how they were responded to by the communities. The BC Conservation Service inquiry, in conjunction with the RCMP, Environment Canada and Fisheries and Oceans Canada, is investigating the impacts of the Mt Polley Breech on the environment and their report is not due out until June. Will the results of that investigation be available for the Ministry of Energy and Mines and Ministry of Environment to use in their decision about this re-opening permit application? Why is the deadline for public comment so soon, meaning that we will not have these BC Conservation Service inquiry results available to us by your May 2 deadline for public comment?

It states in the Water Management Plan (WMP) document (Golder 2015) that the current permit allows 1.4 million cubic mm of water discharge, while at the same time stating that the current discharge could be 3 times that. It also states that onsite levels of Nitrate, Copper, Sulphate, Aluminum, Iron, Selenium and Suspended Solids are above accepted concentrations. The report implies that if the WMP is not pushed through then previously unaffected areas like Bootjack Lake will potentially be impacted. This feels like the threat of contamination of Bootjack Lake is being used to push through the latest permit application. The Return to Restricted Operations permit application implies that they will be working at reduced capacities, although the work suggested is at half load, which is still very substantial. I feel strongly that pushing this Return to Restricted Operations Permit through before the results from the BC Conservation et al inquiry, and a fuller understanding of the actual individual First Nations and settler support or rejection of this permit is unacceptable. Scientists in the area reported a substantial diatom die-off in the fall of 2014 in Quesnel Lake. Diatoms feed zooplankton that salmon fry consume. Until we better understand the long term impacts of the disaster on the environment, we cannot justify putting any more people, animals and flora in jeopardy by re-opening the mine. The clean-up that has occurred (minimal) barely begins to address the impacts on the environment. I suggest that more time is spent getting an understanding of the long term impacts especially on salmon before any re-opening at any capacity will be considered. The WMP could be put into place without starting up the mine again.

British Columbia must reject the reopening of Imperial Metals' Mount Polley mine without the consent of communities impacted by the tailings disaster.

The Government of British Columbia is failing the indigenous people of Secwepemc territories, the residents of Likely, BC and those living on the Quesnel and Fraser River watersheds. This is a matter of urgent concern for all our organizations.

On August 4, 2014, the tailings storage facility at the Mount Polley mine, near Likely, BC, and owned by Imperial Metals Corporation (IMC), had a catastrophic failure, allowing approximately 25 millions cubic metres of toxic sludge and contaminated water to rush into nearby Polley Lake and seven kilometres down Hazeltine Creek to Quesnel Lake. This spill is one of the biggest environmental disasters in modern Canadian history.

The B.C. government initially denied it was an environmental disaster, has downplayed the damage and has taken little to no action to assure that such a disaster will not happen again. Now, Imperial Metals Corporation has submitted an application to provincial regulators to return to operations. Our organizations strongly urge that this application be rejected for the following reasons:

Continuing Ecological Destruction: In the eight months since the August 4, 2014 failure of the tailings storage facility, IMC's wholly-owned subsidiary Mount Polley Mining Corporation (MPMC) has demonstrated greater effort to ready the tailings storage facility for imminent production than to remediate the land and prevent further pollution of Quesnel Lake and the downstream rivers. Now the company plans to release "treated" mining wastewater back into the watershed and potentially use Quesnel Lake as the site of discharge.

Criminal Investigation: The company remains under criminal investigation for gross negligence leading up to the massive failure of the tailings storage facility at the Mount Polley mine. Consent of Communities: The lands to which Imperial Metals Corporation (IMC) has acquired access through provincial and federal permitting are the contested, occupied, traditional, ancestral, and unceded territories of the Secwepemc people. The Secwepemc people have not given their unanimous free, prior, and informed consent to the projects on their territories. Neither have the people of Likely, BC.

Until all communities impacted have unanimously given their explicit free, prior, and informed consent to any and all project plans, timelines, and methods, with caveats, special requirements, and timelines that are on their own terms, and until a third-party team of observers, individually selected by the ancestral authorities of the area and with full access to all areas of the Mount Polley mine site and all areas of the area affected by the tailings failure, has reported that IMC/MPMC has fulfilled their duty to clean up the affected area, this permit should be rejected.

Neglect and Greed: MPMC has demonstrated a pattern of opting to maximize profits at the expense of the land and ecosystems their operations threaten. The managers of MPMC ignored repeated warnings from consultants and employees regarding the unsafe condition of the tailings storage facility, workplace health and safety, and other environmental discharges.

Clean Up and Remediation: Until the IMC has removed every cubic metre of spilled tailings waste to the tailings storage facility, has returned the destroyed land to its original condition, and has returned the water and bed conditions of Polley Lake, Hazeltine Creek, Etney Creek, and Quesnel Lake to their pre-spill conditions, the re-opening of this mine would be furthering an ongoing catastrophe.

There is still time for the provincial government to do the right thing. The Premier needs to act now to demonstrate her government's commitment to respecting and upholding the rights of Indigenous peoples and the people of B.C.
