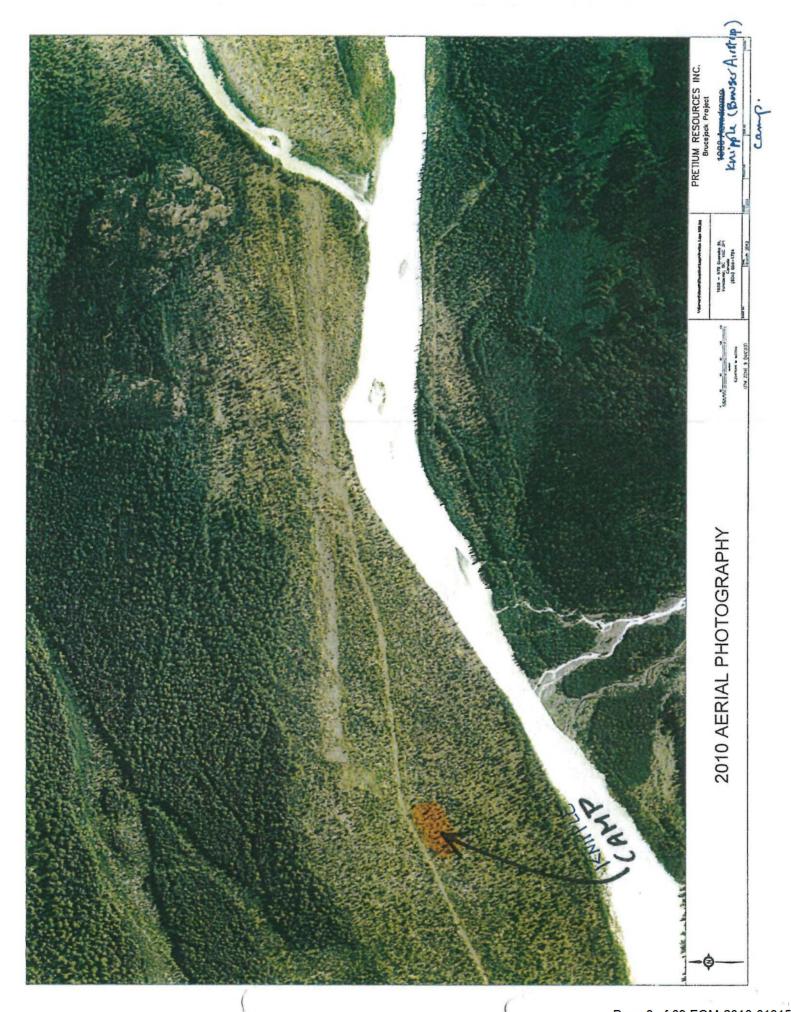

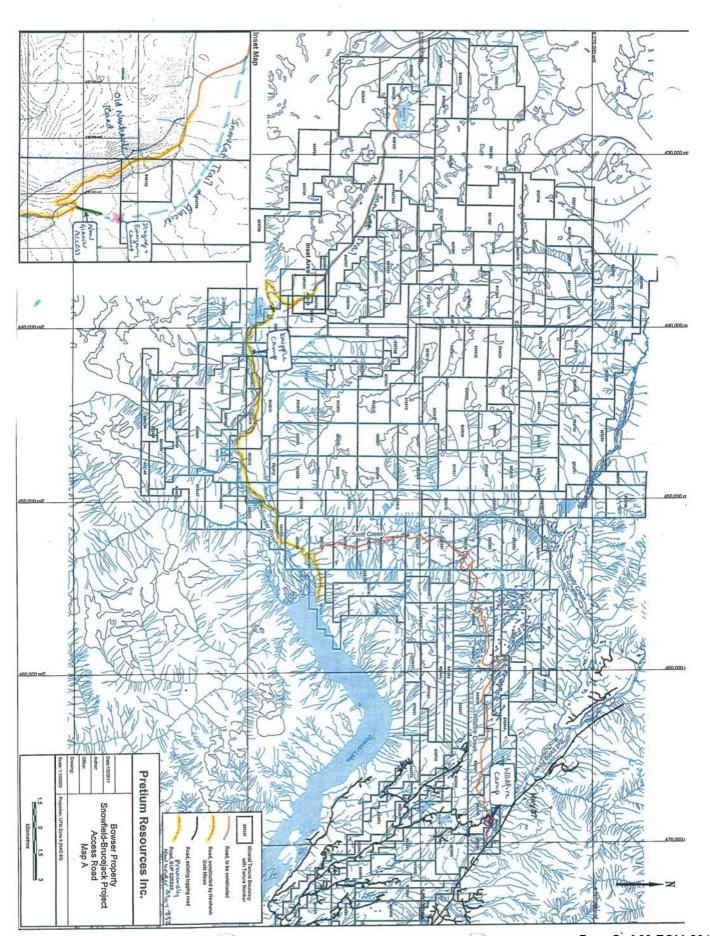
- Best management practices, outlined in the Handbook for Mineral and Coal Exploration in BC, are to be utilized in conjunction with direction provided by the Code.

- On completion of construction, "as built" drawings of the road and bridge structures of the Temporary Road are to be provided to the Inspector and regional Mines office.
- On completion of the road construction, a post-construction environmental plan is required for the Temporary Road.

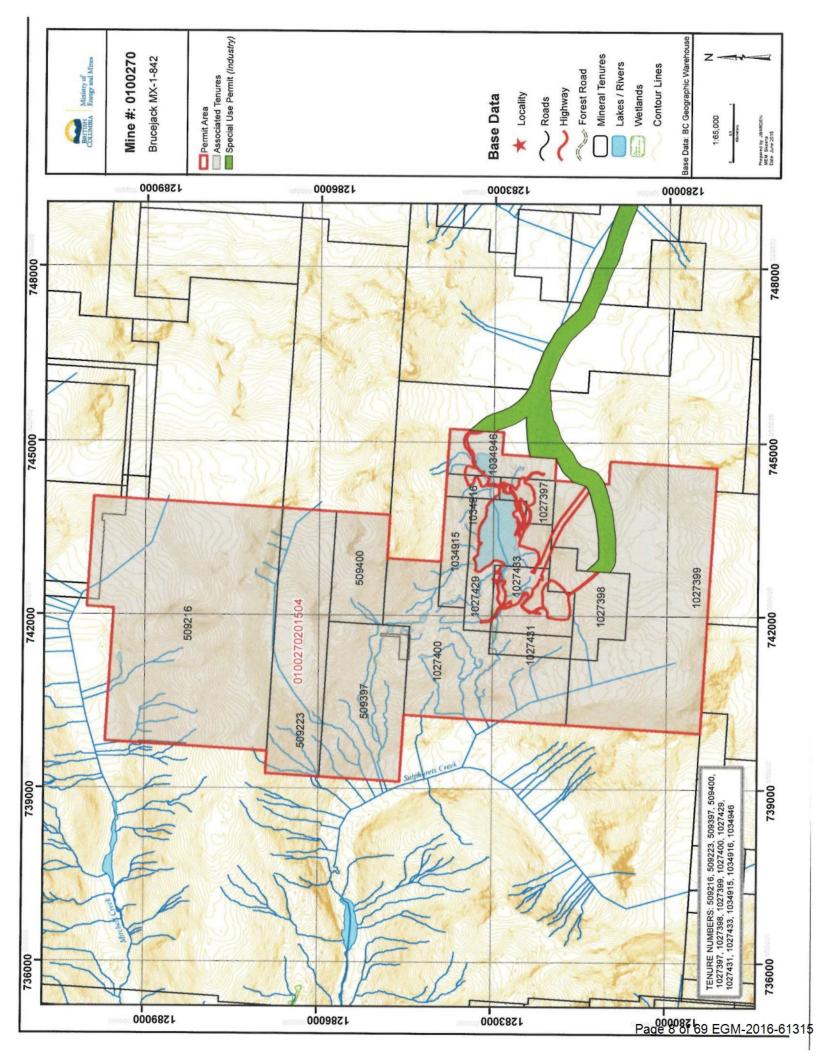

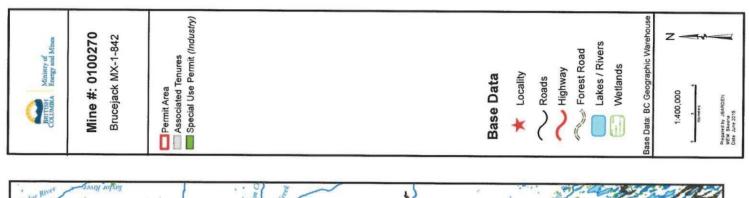

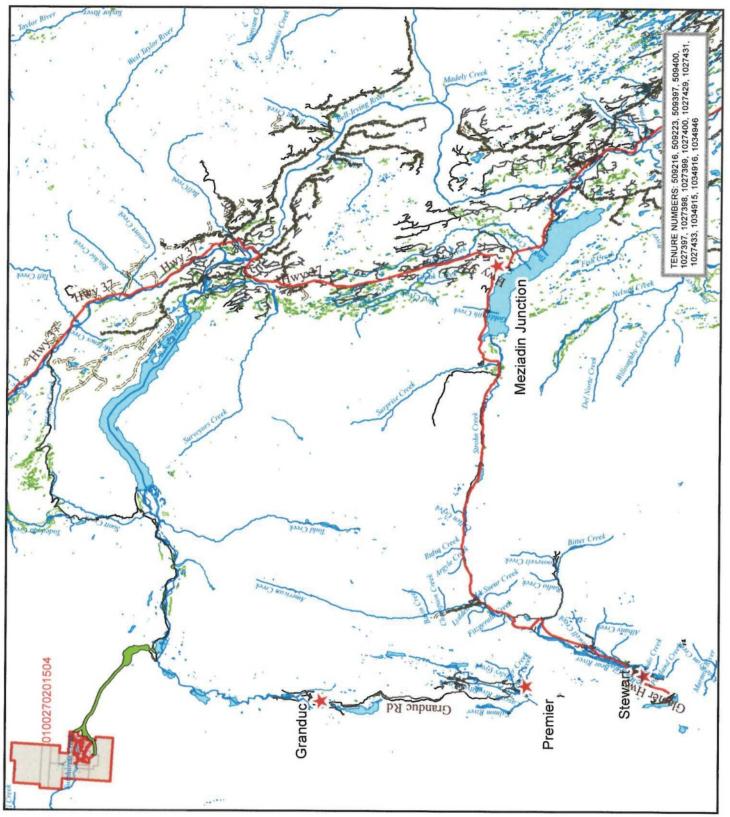

WHEREAS:

- A. The Permittee wishes to use a portion of Crown land in a Provincial Forest for the purposes of construction and maintenance of a road, including construction and maintenance of bridges and other drainage structures, and has not been authorized under any other enactment to use the land.
- B. The Permittee made application on April 8, 2015, in accordance with section 8 of the Provincial Forest Use Regulation of the Forest Practices Code of British Columbia Act, and has submitted a plan that sets out how the land will be used.
- C. The Permittee is issued this permit in accordance with section 3 of the Mining Right of Way Act and the Forest Practices Code of British Columbia Act.

1.00 GRANT OF RIGHTS AND TERM

- 1.01 Subject to this Permit and the Acts, regulations, and standards referred to in paragraph 6.01, the Permittee may use the Crown land designated on the attached Exhibit "A" map to this Permit (the "Permit Area") for the purpose of:
 - (a) construction and maintenance of a road, including construction and maintenance of bridges and other drainage structures.
- 1.02 The term of this Permit begins on July 23, 2015, and will terminate on the date when the District Manager notifies the Permittee in writing that:
 - (a) the road has been deactivated to the satisfaction of the District Manager; or

- (b) future use of the road by others will preclude the need for permanent deactivation.
- 1.03 There is reserved to the Province:
 - the right to grant rights-of-way across, through or over the permit area to other parties, on such terms and conditions as the District Manager determines;
 - (b) the right of employees and agents of the Province to use and to cross the road and the permit area; and
 - (c) the right to grant timber harvesting rights to others with respect to the timber located outside the clearing area, but within the permit area.

2.00 CONDITIONS AND REQUIREMENTS

- 2.01 The Permittee may only carry out activities on the Permit Area in accordance with the "1.0 Plan of Use" attached as Schedule "A" and obligations defined in the Environmental Assessment Certificate (EAC #M 15-01), dated the (26th) of (March) (2015), conditions defined in the Mines Act Permit(M-243) that apply to the access road and any commitments made by Pretivm Resources Inc. through the application phase.
- 2.02 Prior to any major works (i.e. realignments or stream crossing structures) being completed on the SUP, the proponent is required to make application to the Province as this will initiate an amendment to the SUP.
- 2.02 The Permittee shall retain an Engineer of Record who will be responsible for design and construction of the road and bridges.
- 2.03 The Permittee where practicable will restrict the timing of construction to drier periods of the year which will avoid spring freshet.
- 2.04 This Permit authorizes the use and maintenance of the Brucejack Access Road (SUP S25923).

The following annual commitments are required:

- 1). A maintenance plan is to be submitted annually on or before May 31.
- 2). A summary of works planned and carried out must be provided annually and may be submitted with the new maintenance plan.
- 3). An Invasive Plant Control Plan, approved by FLNRO, is required as part of the Road Management Plan. An Invasive Plant Report outlining survey and control work will be provided to FLNRO as part of the aforementioned maintenance plan, and copied to the Ecosystem Section.

- 2.05 The district manager, at any time during the term of this permit, may unilaterally revise the terms and conditions contained in this permit if he/she deems it necessary for the proper management and conservation of the forest resources in the permit area.
- 2.06 A revised Road Closure Plan will be required once the scheduled upgrades have been completed.
- 2.07 Erosion Event Reporting In the case of erosion events of >50 m3 (landslide or fluvial erosion) or >5 m3 of soil material deposited directly into a stream (landslide), the proponent must provide details of the event, including coordinates and photographs, to the province within 48 hours. This erosion event information will be communicated to the province using the following email address:

- 2.08 The current access road which was previously constructed under a Ministry of Energy and Mines authorization for the purpose of exploration requires upgrades which are necessary to bring the road up to current forest road standards. The following conditions which are the result of a field reconnaissance that has been completed by FLNRO have been mutually agreed upon between the proponent and FLNRO:
 - a) The proponent is expected to elevate the level of mitigation with respect to fine sediment production and subsequent delivery to the nearby stream channels. (This condition is specific to the Wildfire hill location)
 - b) An audit of the entire SUP length shall be conducted during a high flow period to ensure major and minor drainage structures are adequate.
 - c) Design and construct road features to prevent negative interactions between natural processes and the constructed road on the Scott Creek fan.
 - d) There is an expectation that the section of road crossing the Bowser River floodplain will be left in its present location but if there are issues with flooding or erosion hazards, the proponent has committed to moving the road towards the margin of the floodplain as long as avalanche hazards would not require active management. Specific sections of the road which have been identified as defendable (from streambank erosion) and not defendable have been identified in the Geohazards and Geomorphology Review that was completed by FLNRO. (As per the attached Schedule A Section 2.0)
 - e) An annual report on the ablation monitoring and the significant changes to the glacier shall be provided.

Completed by Matt Sakals, PGeo PhD (Research Geomorphologist) and Alexandre Bevington, (Research Earth Scientist).

- 2.09 The Permittee is required to share all annual reports, which have been requested by the province as a condition of this permit, with the Nisga'a Nation as represented by the Nisga'a Lisims Government.
- 2.10 As per the memorandum received July 17, 2015, from Pretivm Recourses, the permittee intends to reactivate a section of the New Hawk Road for the purpose of Emergency Response. This will allow the permittee to address any potential spills that may happen along this section of the SUP from 35km to 59km. (As per the attached Schedule A Section 3.0). Any deviation from this memorandum will need to be approved by the District Manager.

3.00 OTHER RIGHTS

- 3.01 The Permittee's rights under this Permit are subject to any other rights of use and occupation over the permit area and the clearing area which the Government has granted to third parties and the Permittee covenants not to obstruct or impede a third party in their authorized use or occupation of these areas.
- 3.02 Except where a mineral reserve established under section 22 (2) of the *Mineral Tenure Act* allows otherwise, the Permittee covenants and agrees not to obstruct, or impede the use, or diminish the rights held under tenures which have been, or which may be, issued to third parties under the *Mineral Tenure Act*.

4.00 ANNUAL RENT

- 4.01 In addition to money payable by the Permittee under the Forest Act and the Forest Practices Code of British Columbia Act and regulations made under them, the Permittee will pay to the Crown, immediately upon receipt of a statement issued on behalf of the Crown, annual rent in the amount of:
 - (a) \$ 00 for the first year; and
 - (b) for ensuing years, an amount determined by the District Manager.

5.00 DEPOSIT

- 5.01 In addition to any money payable by the Permittee under the Acts or regulations referred to in paragraph
- 6.00, or the money referred to in paragraph 4.01, the Permittee must maintain a deposit in the amount of \$2,000,000.00 in the form of a security acceptable to the District Manager, before using the land as specified in paragraph 1.01.
 - The permittee has requested a phased implementation of the security deposit and has submitted a plan which clearly describes the approach the permittee wishes to take. The following phased implementation plan has been approved by the District Manager:
 - a) A deposit amount of \$1,000,000.00 to be provided on the commencement date of this permit.

- b) On the first anniversary date of this permit an additional deposit of \$600,000.00 will be required.
- c) On the second anniversary date of this permit an final instalment of \$400,000.00 will be required to round out the deposit to a total of \$2,000,000.00 and will be maintained as specified in section 5.02

Any deviation from the approved phased implementation plan will require the proponent to notify the district manager as this may require a reconfiguration of the phased deposit.

- 5.02 Commencing on the anniversary date of the permit and each anniversary thereafter, the Permittee must adjust the deposit by an amount to maintain the \$2,000,000.00(CDN) deposit which is calculated by multiplying the sum of \$2,000,000.00(CDN) by the Consumer Price Index for the new calendar year and dividing by the Consumer Price Index for the previous calendar year.
- 5. 03 The District Manager may use any or all of the deposit referred to in paragraph 5.01
 - (a) to satisfy a claim made by the owner of personal property, other than the Permittee or the Province, who has property situated on the Permit Area, or
 - (b) to cover the costs resulting from a failure of the Permittee to meet the conditions of this Permit.
- 5.04 The District Manager, after at least four weeks notice to the Permittee, may take from the deposit:
 - an amount sufficient to cover costs incurred by the District Manager in remedying the Permittee's failure to meet the conditions of this Permit; or
 - (b) an amount equal to the District Manager's estimate of the costs which the District Manager could reasonably expect to incur in remedying the Permittee's failure to meet the conditions of this Permit, and for that purpose a security included in the deposit may be realized.
- 5.05 A notice referred to in paragraph 5.04 must specify:
 - (a) the condition of this Permit which the Permittee failed to meet; and
 - (b) the amount the District Manager takes from the deposit.
- 5.06 If the District Manager gives the Permittee a notice that an amount has been taken under this part from the deposit, the Permittee within four weeks of the date from which the notice is given, must add to the deposit, in a form acceptable to the District Manager, an amount sufficient to replenish the deposit to the amount specified in paragraph 5.01.
- 5.07 Subject to paragraphs 5.04, 5.05 and 5.06, if:
 - (a) the District Manager takes from the deposit an amount equal to the District Manager's estimate of the costs which the District Manager could reasonably expect to incur in remedying the Permittee's failure to meet the conditions of this Permit; and

(b) the costs incurred by the District Manager in remedying the Permittee's failure to meet the conditions of this Permit are less than the amount taken from the deposit;

the District Manager will as soon as feasible return to the Permittee an amount equal to the difference between the amount taken from the deposit and the costs incurred by the District Manager.

5.08 If

- (a) the District Manager takes from the deposit an amount equal to the District Manager's estimate of the costs which the District Manager could reasonably expect to incur in remedying the Permittee's failure to meet a condition of this Permit, and
- (b) the costs incurred by the District Manager in remedying the Permittee's failure to meet a condition of this Permit are greater than the amount taken from the deposit,

the District Manager may take from the deposit an additional amount equal to the difference between the costs incurred by the District Manager and the amount originally taken from the deposit, and for that purpose a security included in the deposit may be realized.

- 5.09 Subject to the Forest Practices Code of British Columbia Act and the regulations made under that Act, the Crown will return to the Permittee the deposit, less deductions made under paragraphs 5.04 and 5.07, when:
 - (a) this Permit expires, or is surrendered; and
 - (b) the District Manager is satisfied that the Permittee has fulfilled all obligations under or in respect of this Permit.
- 5.10 Amounts taken under part 5.00 from the deposit are in addition to and not in substitution for any other remedies available to the Crown in respect of a default of the Permittee.
- 5.11 The Permittee agrees that \$2,000,000.00 of the deposit paid will be used for the purpose of:
 - (a) satisfying a claim made by the owner of personal property, other than the Permittee or the Province, who has property situated on the permit area; and
 - (b) covering the costs resulting from a failure of the Permittee to meet the conditions of this Permit.
- 5.12 If the Permittee fails to meet a condition of this Permit or damages the personal property referred to in paragraph 5.11, the District Manager may take from the deposit referred to in paragraph 5.11 an amount estimated by the District Manager to be required in order to fulfil the conditions of the Permit or restore the damage to the property.

6.00 LEGISLATIVE FRAMEWORK

- 6.01 This Permit is subject to:
 - (a) the Forest Act:
 - (b) the Forest Practices Code of British Columbia Act;
 - (c) the Forest and Range Practices Act;
 - (d) the Mining Right of Way Act;
 - (e) the Nisga'a Final Agreement
 - (f) the Wildfire Act; and
 - (g) the regulations and standards made under those Acts.
- 6.02 The Permittee must:
 - (a) comply with the Acts, regulations and standards referred to in section 6.01 and any other applicable legislation
 - (b) ensure that its employees, agents and contractors comply with these Acts, regulations and standards when engaging in or carrying out activities or operations under or associated with this Permit.
- 6.03 Nothing in this Permit is to be construed as authorizing the Permittee to engage in any activities or carry out any operations otherwise than in accordance with the requirements of the Acts, regulations and standards referred to in section 6.01.

7.00 NOTICE

- 7.01 A notice given under this Permit must be in writing.
- 7.02 A notice given under this Permit may be:
 - (a) delivered by hand;
 - (b) sent by mail;
 - (c) Email address; or
 - (d) subject to paragraph 7.05, sent by facsimile transmission;

to the address or facsimile number, as applicable, specified on the first page of this Permit, or to such other address or facsimile number as is specified in a notice given in accordance with this part.

- 7.03 If a notice is given under this Permit, it is deemed to have been given:
 - if it is given in accordance with subparagraph 7.02 (a), on the date it is delivered by hand;

- if it is given in accordance with subparagraph 7.02 (b), subject to paragraph 7.04, on the eighth day after its deposit in a Canada Post Office at any place in Canada;
- (c) if it is given in accordance with subparagraph 7.02 (c), subject to paragraph 16.05, on the date it is sent by email; and

 - obtain the necessary permits or authorization for the crossing of alienated lands including but not limited to powerlines, pipelines, railroads, public roads, mineral claims, Agricultural Land Reserve's;
 - (b) obtain the necessary permits or authorization from other resource agencies.

- 8.05 Subject to the prior approval of the District Manager, the Permittee must ensure that any gate shall not be, or become, a hazard to the users of the road. The gate must be placed in a conspicuous location, adequately marked with permanent reflective material to be clearly visible to the operator of a motor vehicle from a safe stopping distance. Warning signs must be located to give vehicle operator's adequate warning of the obstruction.
- 8.06 Where the Permittee desires industrial users of the road to announce their position and direction of travel by means of radio, the Permittee must post the radio frequency at the start of the road, together with kilometre markers along the road to enable all industrial users of the road to use the posted radio frequency in the appropriate manner.

 - (d) a contractor of the Permittee who engages in any activity or carries out any operation, including but not restricted to the Permittee's operations, under or associated with this Permit; or
 - (e) any other person who on behalf of or with the consent of the Permittee engages in any activity or carries out any operation, including but not restricted to the Permittee's operations, under or associated with this Permit.
- 9.02 For greater certainty, the Permittee has no obligation to indemnify the Crown under Paragraph 9.01 in respect of any act or omission of:
 - (a) an employee, agent or contractor of the Crown, in the course of carrying out his
 or her duties as employee, agent or contractor of the Crown; or
 - (b) a person, other than the Permittee, to whom the Crown has granted the right to use or occupy Crown land.
- 9.03 The Crown is not liable to the Permittee for injuries, losses, expenses, or costs incurred or suffered by the Permittee as a result, directly or indirectly, of an act or omission of a person who is not a party to this Permit, including but not restricted to an act or omission of a person disrupting, stopping or otherwise interfering with the Permittee's operations under this Permit by road blocks or other means.
- 9.04 Paragraph 9.01 does not apply to an act or omission which is a direct response to, and complies with, an order made by a Ministry employee or another officer of the Crown.

9.05 Amounts taken under Part 5.00 from the deposit and payments required further to the indemnity referred to in Paragraph 9.01, are in addition to and not in substitution for any other remedies available to the Crown in respect of a default of the Permittee.

Pretium Resources Inc. (Pretivm) is applying for a Special Use Permit (SUP) for:

- Conversion of the authorization for the existing Brucejack Access Road from Mines Act Permit MX-1-832 to SUP;
- Upgrades to the Brucejack Access Road to support development and operation of the Brucejack Gold Mine.

The enclosed Tables of Concordance (Tables 1 & 2) were developed as per discussions between Pretivm and the BC Ministry of Forests, Lands and Natural Resource Operations (MFLNRO) Major Project Office following the Ministry of Energy and Mines (MEM) decision to not authorize the Brucejack Access Road under the same Mines Act permit as the Brucejack Gold Mine development. Rather than have Pretivm prepare new documentation (i.e. Special Use Permit application to permit the Brucejack Access Road), MEM and MFLNRO Major Project Office determined that referencing the existing information in the Mines Act and Environmental Management Act Permits application submission through the use of Table of Concordances would be acceptable. The Tables of Concordance were developed using guidance provided to Pretivm by MFLNRO on March 17, 2015.

Electronic files that support the Table of Concordances and Pretivm's application for a Special Use Permit for the Brucejack Access Road include:

SUP shape file (final file pending)

- LiDAR contour data (narrow coverage), Orthophotos with contours (wider coverage)
- As built drawings for the existing Brucejack Access Road (0 to 58.6 km) and 2014 upgrades to Wildfire Hill

The as-built drawings prepared by Cypress Forest Consultant's Ltd. (Cypress) include Cypress recommendations for road improvements. Pretivm subsequently retained Allnorth Consultants Ltd. (Allnorth) to prepare the detail design for road improvements. A preliminary plan for road improvements that incorporates some of the Cypress recommendations and preliminary changes from Allnorth (Figure 1) has been developed. Detailed design is in progress and until that process has been completed, the details around the proposed upgrades cannot be confirmed.

Description of Project:

The Brucejack Access Road is an existing 75.3 km road that starts at Highway 37, at approximately km 216, and travels generally westward to Brucejack Lake. The road consists of the following sections:

km 0 to 35: all-weather road completed in 2011 to 2013;

km 35 to 58.6: all-weather road existing prior to 2011;

km 58.6 to 70.9: traverse across the main arm of the Knipple Glacier; and

km 70.9 to 75.3: Lakeshore Drive.

The Special Use Permit application includes the all-weather portion of the existing road from 0 to 58.6 km, plus the 12 km Knipple Glacier crossing. Lakeshore Drive, km 70.9 to 75.3, will be covered under a *Mines Act* permit.

The Brucejack Access Road was constructed as a temporary, all-season exploration access road to provide access to the Brucejack mineral exploration site. Some upgrade work was completed at km 2 to km 3 on Wildfire Hill during 2014 (Appendix A). Additional upgrades are proposed to improve safety and to handle the higher traffic loadings from both construction and operations activities associated with the development of the Brucejack Gold Mine Project. Upgrades will include an increase in design speed to 40 km/h where possible, minor re-alignments of the sharper curves, reductions of the steeper grades, the addition of pullouts, and surfacing of some sections. Design will also take into consideration borrow and quarry sources required to complete upgrade work. Construction issued drawings are not be available at this time; these drawings will be available within the next several months.

The Brucejack Access Road is gated and access will continue to be controlled through a manned security gate during the life of the mine, as per Environmental Assessment Certificate (EAC) # M15-01 Condition No. 8. Authorized users that will be granted access are as defined in the Traffic and Access Management Plan, EAC #M15-01 Condition No. 7. The EAC and Table of Conditions are provided in Appendix B.

Planned Use and Life:

The Brucejack Gold Mine Project will have four phases:

- 1) 2-year Construction phase;
- 2) 18-year Operations Phase;
- 3) 3-year Closure phase; and
- 4) 5-year Post-closure phase.

The Brucejack Access Road will be decommissioned once it is determined to no longer be needed for the Project.

Survey and Design Standards:

The existing Brucejack Access Road was designed to specification noted in the MFLNRO engineering manual current at the time of the design. Design upgrades will be in substantial conformance with standards provided in the most recent version of the Forest Service Engineering Manual.

Assessments:

The original road design was approved by the Ministry of Energy and Mines in May 2010 and is included under *Mines Act* Permit No. MX-1-832.

The Brucejack Gold Mine Project was issued a provincial Environmental Assessment Certificate on March 26, 2015. During development of the Environmental Assessment Application data related to wildlife and wildlife habitat, archaeological heritage resources, terrestrial ecosystems including - wetlands, rare plants, invasive plants, metals in soils and plants, aquatic resources, meteorological conditions, geohazards and risk assessment, hydrology, surface water quality, fish resources and fish habitat, ML/ARD and traditional and non-traditional land use were collected within the access road corridor and has been considered in the proposed upgrades (e.g. installation of toad tunnels during road upgrades). Additionally, environmental management plans / component plans have been developed that take into consideration the Brucejack Access Road (e.g. Wildlife Management Plan, Traffic and Access Management Plan).

Special Use Permit Application: Brucejack Access Road

Records of Referrals:

For the proposed upgrade work, no referrals have been made for the SUP application to agencies other than MFLNRO, although there has been an extensive referral process through the EAC review process, except Pretivm has recently applied for an Occupant Licence to Cut (OLTC) to cover areas not covered under the existing OLTC (L48433), i.e. km 35 to 58.6 of the road. The proposed upgrade work does not include any work in or about streams therefore no related referrals are anticipated.

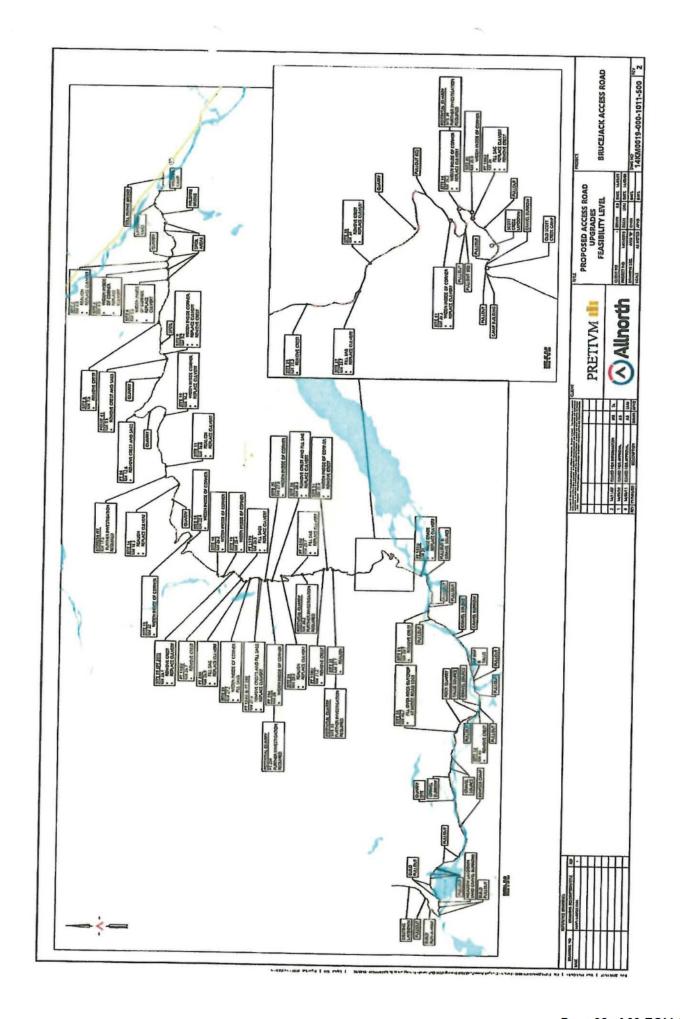

5 ENVIRONMENTAL

The environmental issues related to the Project were mainly caused by the topography and the geology of the area. Sensitive riparian areas such as Wildfire Creek and an adjacent flood plain were located downhill, of extended areas of disturbed soil with steep slopes which were vulnerable to erosion. Measures were taken to prevent erosion and sedimentation into riparian area.

The TNDC crew worked in collaboration with the EM to fix problems as soon as they were identified. Tsetsaut Ventures Limited (TVL) staff also assisted the EM with the reclamation of the area (seeding and covering seeds with straw). TVL are responsible for the maintenance of Wildfire Hill after the construction completion.

- C. The assessment of the Project was conducted from February 6, 2013 to March 6, 2015, and included consultation with Aboriginal Groups and the public respecting the Application;
- D. Compliance with this Certificate, including its conditions, will be monitored by the staff of EAO, partner agencies, and others who have been authorized to inspect under the Act;
- E. On March 6, 2015, pursuant to Section 17 of the Act, the Executive Director referred the Application, the Assessment Report and his recommendations to the undersigned; and
- F. The undersigned have considered the Application, the Assessment Report; and, the recommendations of the Executive Director.

Now Therefore:

We issue this Environmental Assessment Certificate to the Proponent for the Project as described in Schedule A, subject to the following conditions and the conditions set out in Schedule B.

Conditions

Definitions:

- The Holder must provide any document or information requested by EAO for the purposes of compliance inspection and verification.
- Should the primary contact for the Project change, the Holder must notify EAO Compliance and Enforcement staff, in writing, within 30 days and provide the physical address, email address and phone number(s).

Transfer of Certificate

- (1) Except as provided below, neither this Certificate nor any interest in it may be transferred to any person.
 - (2) A transfer of this Certificate will only be effective if the proposed Holder acknowledges that, upon transfer, it will be responsible for complying with the conditions of the Certificate, and both the proposed Holder and the Holder;
 - a. obtain consent for the transfer from the Executive Director prior to completing the transfer transaction;
 - apply under Section 19 of the Act for such amendments to this Certificate, if any, as the
 Executive Director deems necessary to ensure compliance with and enforceability of this
 Certificate and to otherwise reflect the proposed transfer; and
 - c. confirm by written notice to the Executive Director, within 14 days of the completion of all aspects of the transfer transaction other than this notice, that the transfer has been completed.
 - (3) An interest in this Certificate may be transferred by way of a grant of security to lenders or financers without consent.

- (4) A transfer to a trustee in bankruptcy, by a receiver or a trustee in bankruptcy pursuant to a court approved sale or as part of a court approved arrangement under the Company Creditors Arrangement Act may occur without consent.
- (5) If this Certificate is transferred without consent, pursuant to Sections 5(3) or (4), the new and former Holder must notify the Executive Director within 30 days of the transfer and apply within the time specified by the Executive Director for any amendments to this Certificate that the Executive Director deems necessary to ensure compliance with and enforceability of this Certificate and to otherwise reflect the completed transfer.

Transfer of Interest in Project

 - a. obtain consent for the transfer from the Executive Director.
 - apply under Section 19 of the Act for such amendments to this Certificate, if any, as the Executive Director deems necessary to ensure compliance with and enforceability of this Certificate and to otherwise reflect the proposed transfer.
 - (2) A transfer to a trustee in bankruptcy, by a receiver or a trustee in bankruptcy pursuant to a court approved sale or as part of a court approved arrangement under the Company Creditors Arrangement Act may occur without consent.
 - (3) If a significant interest in the Project is transferred without consent pursuant to Section 6(2), the Holder must notify the Executive Director within 30 days of the transfer and apply within the time specified by the Executive Director for any amendments to this Certificate that the Executive Director deems necessary to ensure compliance with and enforceability of this Certificate and to otherwise reflect the proposed transfer.

Changes to Schedule A Under Section 19(5) and (6) of the Act

 - e. whether, after any consultation with Aboriginal groups undertaken by the Holder or any further such consultation directed or undertaken by the Executive Director, the proposed activities may adversely affect Aboriginal Interests that were not (i) considered in the Application and assessment, or (ii) considered in any regulatory or approval processes that concluded after the date of this Certificate; and

- f. whether and to what extent the conditions in this Certificate constitute practical means of preventing or reducing any potential adverse effects that will, or are reasonably likely to, result from the proposed activities.
- (3) If the Executive Director determines that the proposed changes to the Project Activities are not material in nature, then the Executive Director may make a decision regarding an amendment of Schedule A pursuant to Section 19(3) of the Act.
- (4) If the Executive Director determines that the proposed changes to the Project Activities are material in nature, then the Holder must apply to the Executive Director to amend Schedule A pursuant to Section 19(1) of the Act.

The Contribution Agreement will require the Holder to contribute up to the following amounts to the Province's costs of implementing the NMMP: a) \$7,500 payable as early as the date (the "Brucejack Access Road Start Date") of any physical alteration, including site preparation, to the Brucejack Access Road right of way made for the purpose of improving the Access Road; and b) an amount ("Annual Contribution") consisting of \$3,000, plus an adjustments for inflation and Project Vehicle Wildlife Incidents referred to below, payable as early as on the first and every subsequent anniversary of the Access Road Start Date until FLNR determines that the Holder has commenced permanent closure and decommissioning of the Project. Where the Province has not incurred expenses in implementing the NWWP and invoiced the Holder at the earliest payable date set out above the Contribution Agreement will allow those amounts that have not been invoiced, together with interest accruing on them, to be carried over and invoiced at a later date in addition to the Annual Contribution for a particular year. The Annual Contribution will be adjusted by an inflation factor based on the increase in the British Columbia Consumer Price Index from the date of the issuance of the Environmental Assessment Certificate (EAC).

No. Condition

Five years after the first shipment of concentrate from the ore processing complex, and every five years after that date, the Annual Contribution will be adjusted by an amount determined by the Province to reflect any increase or decrease in moose accidents caused by Project vehicles along the Brucejack Access Road ("Project Vehicle Wildlife Incidents"). However, in no circumstance shall the Annual Contribution be less than \$3,000 plus any adjustment for inflation and BC Consumer Price Index as described above.

The Contribution Agreement may require the Holder to review, prepare, comment on, or otherwise participate in the preparation and presentation of draft plans, final plans, and reports regarding the NMMP.

Brucejack Mine Access Road Review by Ministry of Forests, Lands and Natural Resource Operations - Geohazards and Geomorphology Review

We conducted an overview assessment on 19 – 21 May 2015 of the Brucejack Mine access road with specific attention to potential hazards to the environment as well as potentially overlooked geohazard elements. Progressing from Highway 37 towards the mine, the main issues of concern are:

1. Wildfire Hill (56.518N, 129.519W)

The bridge across Wildfire Cr at approximately 2 km (56.518N, -129.518) appears to be in an excellent location with a relatively narrow crossing with bedrock support on each bank. The road location on the mine side of the bridge traverses a steep sidehill where two through-cuts were required. Exposed cut slopes are on the order of 50 m long and very steep. This site appears to have been built according to the design provided by AllNorth (date: 22 July 2014). At the time of our assessment a number of issues were evident:

- The cutslopes are failing in many locations (Figure 1); they have filled the ditchlines and are causing issues for drainage control. The cutslopes are also encroaching on the running surface of the road. Failures are expected to continue into the future due to the steepness of the cuts, especially with road and ditch maintenance undermining the base of the slopes, as well as icing processes. Bioslope stabilization methods were attempted with limited success. Further engineering measures could be employed to increase slope stability and reduce this chronic source of fine textured sediment delivery to the receiving aquatic environment.
- Small failures associated with hillslope adjustment are disrupting intended drainage pathways. Maintenance is required to maintain drainage pathways and prevent delivery of water to potentially dangerous locations; however, maintenance must not undermine cutslopes as this will likely contribute to further hillslope retrogression.
- Retrogression of the hillslopes has resulted in trees present right to the top edge of the cutslope. These trees are subject to windthrow and further disruption of the cutslopes.
- Winter road safety is actively managed through required check-ins and check-outs through the hazardous road segment as well as active avalanche control.
- Potential condition: The proponent should elevate the level of mitigation with respect to fine sediment production and subsequent delivery to the nearby stream

channel. A water quality monitoring site could be established to capture sediment derived from this exposed terrain.

2. Drainage Control

Throughout much of the Wildfire area and into the Scott Cr drainage (3-35 km along) the access road), the road generally has inadequate drainage. Although our assessment took place during a period of high flow (19-21 April 2015), the road drainage system should have been capable of conveying the runoff. We noted numerous locations where

blocked culverts resulted in water flowing away from its natural course down the ditchline (Figure 2); this can lead to drainage diversions, a common factor contributing to landslides and other erosion events. The cause appears to be the upgrades made to the original road; the new road subgrade is too wide for the original culverts and the fillslope materials extend over the culvert inlets in some cases. We also noted undersized (diameter) drainage structures and sites requiring structures where none were located.

The drainage issues should be remedied before mid-September when the first of the fall storms may arrive.

Further instances of inadequate drainage structures were noted past the Knipple Causeway; these should also be remedied.

 Potential condition: A government or third-party audit should be conducted during a high flow period to ensure major and minor drainage structures are adequate.

3. Wildfire Cr Bridge (52.66N 129.662W)

This bridge installation encroaches upon the wetted area of the stream. Remediation is not required as the stream is flowing from wetland complexes and is unlikely to transport much sediment which could lead to morphological changes that would challenge the bridge. The proponent should be aware that this may be required in the future and that a longer crossing structure will be required.

4. Scott Cr Fan Area (56.421N, 129.765W)

The access road crosses the Scott Cr fan ~500 m downstream from the fan apex. Streams have high probabilities of changing their channels on the active surfaces of fans. Bank height provides an indicator of the active surface, but it must persist until the apex of the fan or until reaching a confining hillslope or elevated fan surface. In this case, the bank heights in the vicinity of the bridge were reasonable (~1.3 m) but bank overtopping in conjunction with a debris jam is certainly conceivable. Unfortunately, about 350 m upstream from the bridge bank heights diminished to zero and the stream was above the surrounding fan surface (Figure 3); the water was staying in the established channel only because of the riparian forest influence. Beaver activity was also noted along the banks in this vicinity. Much evidence of overbank flow and sediment deposition was found throughout the left side of the fan upstream of the road.



Figure 3. Approximately 350 m upstream of the crossing, Scott Creek is positioned above the surrounding fan surface; there is also significant woody debris in the channel and beaver activity. This stream has a moderate probability of avulsion and a high likelihood of overbank flows.

The length of the crossing structure appears to be less that the normal channel width. This is an additional risk factor for the road on the fan.

The Scott Creek fan is adjacent and directly connected to the Bowser Delta, a location where sockeye salmon have been known to spawn.

Due to both the natural conditions on the Scott Cr fan and design elements of the road, there is a moderately high probability of a negative interaction between the stream and the road. Some degree of contingency should be incorporated into the road design such that natural hydrogeomorphic events have a lesser impact on the environment, worker safety, and haul road operations. Various methods may be employed to accommodate the probability of stream avulsion or overbank flows arriving at the road alignment, see Land Management Handbook 57 for initial guidance. Further consultation with FLNRO staff is also available.

Of additional note, the 'Hydrology Station' installed at the bridge site will suffer from errors due to the high-stage overbank flows noted above.

Potential condition: Design and construct road features to prevent negative interactions between natural processes and the constructed road on the Scott Cr fan. OR Design road features to prevent negative interactions between natural processes and the constructed road on the Scott Cr fan and prepare to construct the design following a major event rather than reconstruct or defend the existing road, excepting routine maintenance (i.e., grading).

5. Bowser River Floodplain

The road alignment traverses across the Bowser River floodplain from ~39.5 km to ~60 km. In this section, the road generally has little relief above the active channel (Figure 4). Apparently, much of the disturbance on the floodplain is due to a jokulhlaup, or glacial outburst flood, that occurred in 1931 (Baseline Information of the Application) and the existing geomorphic conditions indicate that the stream is free to migrate about the floodplain. While the road material is good, and construction and re-construction is relatively straightforward, the road should not unduly confine the stream within the floodplain. Typically, it is only appropriate to defend roads against stream channels on floodplains where the road is at the margin of the floodplain or where other alignment constraints require it. In this situation, it is often inappropriate to locate the road at the margin of the floodplain due to the hillslope snow avalanche hazard. Therefore, a balance must be found between unnecessarily confining the floodplain and the snow avalanche risk. It is recommended that erosion protection works be permitted for defendable sections as the road alignment is in an appropriate location (Figure 5).

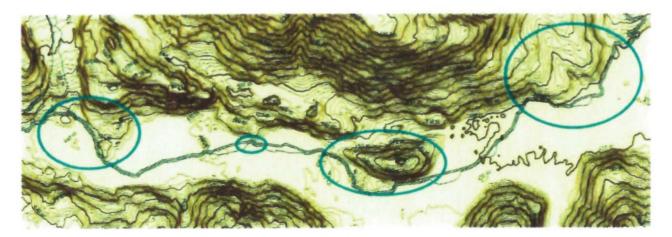


Figure 6.Approximate locations of defendable road sections (blue) along the \sim 35 - 55 km section.

• Potential condition: No erosion protection works or bank defenses should be employed in the non-defendable segments. Instead, the proponent should identify the extent of snow avalanche risk that would be unacceptable without active avalanche management, an acceptable buffer based on the hazard may then be added and only along this alignment may erosion protection works be constructed. Road segments have been classified as defendable or non-defendable (Table 1 and Figure 6). Exceptions to the classification may be made on a case-by-case basis.

6. Bowser Camp Geohazard (56.393N, 129.949W)

It is our understanding that no specific geohazard assessment has been completed for the location of Bowser Camp; however, the Bowser airstrip has been the subject of geohazard evaluation and assigned a return period for flooding between 5 and 20 years and a High Facility Risk (Application Appendix 2-C). The camp would be in a higher hazard zone as it is closer to the river. Due to the configuration of the floodplain, the history of glacial outburst floods in the valley, and the presence of a camp, a geohazard assessment is overdue.

To serve as an example, during our field visit we identified an active landslide of significant size (800 m long by 700 m wide) in a tributary valley adjacent to the camp location yet just outside of the geohazard assessment area (Figure 6). The possibility of this landslide running out over the camp or blocking the river and causing the flooding or destruction of the camp is one such hazard that should be investigated. The camp may have to be re-located if the total geohazard risk is intolerable.

 Potential condition: Will this become a Lands tenure? Perform a comprehensive geohazard assessment for the Bowser Camp or commit to moving the camp to another suitably assessed location before the spring of 2016.

7. Knipple Glacier Outwash Crossing

Near to 54 km the access road crosses the outwash plain of the Knipple Glacier. This is a highly active hydrogeomorphic zone and thus the proponent should be prepared for high maintenance and possible rebuilding costs in this area. A recent rock avalanche occurred

near the toe of the glacier on the east side of the valley. Knipple Creek seems to run through the material with ease; however, such an event could have been more destructive if it would have impounded water. The proponent would be well served to ensure that all the existing structures (culverts and bridges) are properly maintained in order to maximize the resilience of the outwash crossing.

8. Glacier Road

The proponent has been using a glacier road for a few years and has developed operational protocols for safe glacier travel considering crevasses, mill wells (vertical tunnels carved by water and debris) and water flow on the glacier surface. The requirement for a high level of maintenance at the margins of the glacier road and throughout the traverse has been noted and is being applied. The proponent has also acquired staff with expertise in vehicular glacier travel. The long-term operational viability of the glacier road is not known, but will be watched with interest and we have interest in collaborating with the proponent on research related to the glacier dynamics both within the vicinity of the road and beyond. It is our opinion that the environmental effect of the road on glacial processes will be negligible but that monitoring of glacier mass balance and albedo should nevertheless be implemented because of the uniqueness of this road, globally.

 Potential condition: Annual reporting of glacier road conditions, problems and remediation, and glacier mass balance monitoring.

9. Snow Avalanches

Various snow avalanche hazards exist along the proposed SUP road alignment. The proponent has been actively managing these sites to mitigate the hazard over the past few winters and has developed strict operational policies in place to reduce the risk. We support the installation of the proposed automated explosion systems.

A realignment of the 'Lakeshore Drive' component of the access road that is on the Mines

tenure is also supported as it will decrease the spatial exposure of the route to snow avalanche hazards. Similar to the access road, the proponent has been managing the snow avalanche risk at the mine site with appropriate diligence.

10. Erosion Event Reporting

In the interest of increasing our knowledge of earth surface processes and their interactions with land use, the following condition is meant to ensure reporting of significant erosion events, it is not expected that appropriate actions have been developed by the reporting deadline.

• Potential condition: In the case of erosion events of >50 m3 (landslide or fluvial erosion) or >5 m3 of soil material deposited directly into a stream (landslide), the proponent must provide details of the event, including coordinates and photographs, to the province within 48 hours. This erosion event information will be communicated to the province using the following email address:

RE: PROPOSED UPGRADES TO NEWHAWK ROAD FOR EMERGENCY RESPONSE REQUIREMENTS

1 INTRODUCTION

Pretivm is currently developing the Brucejack Project which is located approximately 65 kilometers north of Stewart in northwestern British Columbia. Pretium is preparing an Emergency Spill Response Plan to address potential spills that may occur along the section of the Brucejack Access Road from 35 km to 59 km (Knipple Glacier), which travels in close proximity to the Bowser River and is completely within the Bowser River flood plain The spill response plan includes the deployment of containment booms on the Bowser River and as such, Pretium has identified the need to re-activate the historic Newhawk Road which was constructed in the 1980s to access the Brucejack site. The road has been abandoned since the late 1980's.

The following describes the assumed upgrades that will be completed on the Newhawk road from 35 km on the Brucejack Access Road to the banks of the Bowser River.

2 ASSUMED UPGRADES TO THE NEWHAWK ROAD

The following outlines the assumed upgrades required to provide Spill Response vehicle access to the Bowser River along the Newhawk Road. For the purpose of this report all assumptions have been based on a minimal review of the initial 100 metres of the road from 35 km toward the river

The road will be required to be traversed by typical ½ ton to 1 ton 4 X 4 pickup trucks, usually with an 8 foot box. The vehicle will be towing a trailer assumed to be ranging in length from 10 to 20 feet (includes the tongue). The trailers may carry supplies and or a rubber inflated boat.



The Newhawk Road has not been active since the late 1980's. The road is brushed in with Alder and Willow species and as such the road requires brushing to provide access for the typical vehicles required to respond to a spill. This work will be carried out by a crawler tractor of the D6 or D7 size. The intent is to clear a travel corridor of 7 to 8 meters in width. At the site where the road connects to Bowser Lake; immediately at the mouth of the Bowser River; a staging area will be cleared that is sufficient to stock pile materials and provide sufficient room to turn vehicles around safely.

It is assumed the running surface and all stream crossing structures are intact and no repairs or upgrades are required. Once the road is brushed out, an inspection of the crossing structures will be completed to confirm this assumption.

The entire road will also be assessed by a Certified Danger Tree Assessor once the right of way has been brushed out.

Any upgrades or stream crossing replacements required to be undertaken will comply with the current legislation requirements and follow best management practices outlined in the current Ministry of Forests, Lands and Natural Resources Operation, Forest Engineering Manual.

All new activities that expose mineral soil will have an approved grass seed mix applied in dry form immediately after work is completed.

3 ROAD REHABILITATION

At the completion of the Brucejack Project and the potential for spill response is negated, the Newhawk Road will be de-activated.
