# Union of British Columbia Municipalities – Flood and Wildfire Advisory Committee March 5, 2021 – Speaking Notes Parliamentary Secretary for Emergency Preparedness

MLA Jennifer Rice

Thank you Cameron, [add or substitute based on who will introduce] and good afternoon everyone. It is an honour to be with you today. I'm calling you today from my community of Prince Rupert, traditional territory of the Tsimshian peoples, where I am honoured to live, play and serve the people. I really wish I could be with you today in person, but I know this remains the reality for us. Hopefully, in the near future, we will be able to meet face to face. This committee represents so much to the municipalities of British Columbia as I understand that this committee was originally formed with a focus on floods and fires in the wake of the 2017 and 2018 events, but has since broadened its scope to wider EM issues, and has become the primary UBCM point of contact working closely with the Province on the modernized EM legislation. I think we are all seeing the need to do more, and do better on emergency management, given the seriousness and variety of challenges we're now facing. Floods and wildfires, but also pandemic, sea level rise, drought, tsunamis and of course earthquakes. In my fours years as

Parliamentary Secretary for Emergency Preparedness, I've had an opportunity to connect with local authorities and First Nations impacted by natural disasters. These disasters can be widespread like the wildfire seasons of 2017 and 2018, or really focused geographically like the May 2018 flooding events in Grand Forks. Throughout this time, I've built an appreciation that emergency management is not just about response, but all pillars of emergency management including preparation, mitigation and recovery. In addition, emergency management isn't just a single agency accountability, but rather all levels of government and – importantly, an all of society responsibility. This is why I'm really honoured that Premier Horgan not only continued my role is Parliamentary Secretary for Emergency Preparedness, but also expanded my mandate, and I would like to take a few minutes to tell you about it, and then hear from you if you have any initial thoughts on how I should best move forward in this role.

### [Shift to PowerPoint Presentation]

I have a few slides to refer that outline my mandate commitments as well as the initial approach that I am taking. Unless anyone has any pressing questions, perhaps I'll just move through these and then we can have a bit of a dialogue. But before I do that, I should tell you in general what a Parliamentary

Secretary does. Just like all Parliamentary Secretaries, it is my job to assist my Minister, Hon. Mike Farnworth, Minister of Public Safety and Solicitor General in carrying out his duties. In doing so, I may be asked to represent the Minister at public events, deliver speeches on behalf of the Minister, or act as a spokesperson for the government's position. It is my job to reach out to stakeholders, businesses, civil society and individuals across B.C. to better understand their perspectives and bring their views to the Minister. Beyond this general mandate though, I do have some specific commitments that I have been assigned.

Moving past the title slide to <u>Slide 2</u>, my first mandate commitment focuses on community gaps, with a focus on future proofing communities for a variety of disasters, including things like pandemics. You'll note that the language only references response, but I am interpreting this is being inclusive of all phases of emergency management – preparation, response, mitigation and recovery. Gaps could include many things, and I'm open to hearing what they are. I know the work around the Emergency Program Act is probably top of mind, but I also know that many communities have capacity challenges around emergency management, quite apart from any modernization work. And I know that this

committee has communicated loud and clear, that communities can't take on additional legislative obligations, without additional resources. I look forward to discussing that further.

My approach is not to create new engagement channels, but rather use existing mechanisms such as connecting with this committee as well as working with First Nations Leadership throughout the province and engaging with the emergency management community in public forums. As I engage further in that dialogue, I expect more targeted outreach to occur.

Moving to <u>Slide 3</u>, my second key mandate commitment is to support the modernization of the Emergency Program Act. I know this committee has been very involved and I see you are getting an update later in this agenda. I see my role not so much to get involved in the legislative work that has gone on to date, but rather to focus on the implementation angle of the modernization, helping to answer the question "what is this going to take to implement at the community level?". I know that's a big question, and with all the pressures on government, I want to say at the outset that we might not be able to do everything for everybody, but we need to hear where these gaps are or we won't be able to

do anything. Just like in mandate commitment 1, I expect to engage with local authorities and First Nations through existing mechanisms such as this one.

My third mandate commitment is outlined on <u>Slide 4</u>, and emphasizes supporting the Ministry of Forest, Lands, Natural Resource Operations and Rural Development in its work with communities to reduce wildfire risk. While this work is being led by Ministry Conroy and her ministry, I am pleased there is recognition that we need to work together. Later this month I will be connecting with the FireSmart Community Advisory Committee to have a similar conversation to the one we're having today. I will be working with FLNR and the BC Wildfire Service to identify additional opportunities to dialogue with communities and to support all of our collective work.

And lastly, I would be remiss, if I didn't mention my ongoing responsibilities supporting the work of the public education program at EMBC with events such as the Highwater Hike which promotes tsunami awareness. In addition, I will continue to support senior political EMBC operations with my MLA colleagues as emergency events unfold and am fully committed to directly support communities that have been impacted by disasters, as I did with Grand Forks during their response and recovery.

I think I'll pause there and see if there are any initial comments or thoughts.
