Good Afternoon

Thank you for those that were able to attend the Heat call today with IHA, FNHA and EMBC.

As this call was short notice and for those that were not able to attend, the following is a brief summary of the points covered.

- Weather forecast calls for extended heat, with limited overnight recoveries in temperature.
- These heat conditions are unusual and early, giving little opportunity for people to adapt to hot weather.
- Concerns are for those that may be vulnerable such as those without homes, access to A/C, children and seniors.

For communities that may be looking at setting up cooling centers

- A Medical Health Officer (MHO) order is not required. There were elements of EMBC Policy 5.13 that required an MHO order but policy 5.13 is specific to the COVID Pandemic and not required for other emergencies.
- It is expected that Local Government and First Nation communities will utilize their existing owned facilities (Rec Centers, Curling rinks, offices etc.)
- Where those facilities do not exist, there are other Commercial or Non-Government Organizations that may have suitable facilities (Malls, Churches, community centers etc.) may also be able to assist.
- Occupancy limits of facilities must be respected and further guidance for COVID protections will be provided
- IHA will be sending out further guidance around cooling centers and a tool kit which will be shared by EMBC when received.

Clarification on costs that may be considered for reimbursement by EMBC

- A task number will be required to seek reimbursement
- A State of Local Emergency (SOLE) is not required.
  - A SOLE is only required when accessing the powers under the Emergency Program Act, such as evacuations.
- Reimbursements are limited to incremental costs, examples include:
  - Staff wages/overtime to open a civic facility that would otherwise not be open.
  - Workers Compensation coverage for ESS volunteers to support.
  - Water for use/distribution within the facility.
- For communities that do not have suitable facilities, please contact EMBC to review and discussion options.

As this call was short notice and for those that were not able to attend, the following is a brief summary of the points covered.

- Weather forecast calls for extended heat, with limited overnight recoveries in temperature.
- These heat conditions are unusual and early, giving little opportunity for people to adapt to hot weather.
- Concerns are for those that may be vulnerable such as those without homes, access to A/C, children and seniors.

For communities that may be looking at setting up cooling centers

- A Medical Health Officer (MHO) order is not required. There were elements of EMBC Policy 5.13 that required an MHO order but policy 5.13 is specific to the COVID Pandemic and not required for other emergencies.
- It is expected that Local Government and First Nation communities will utilize their existing owned facilities (Rec Centers, Curling rinks, offices etc.)
- Where those facilities do not exist, there are other Commercial or Non-Government
   Organizations that may have suitable facilities (Malls, Churches, community centers etc.) may also be able to assist.
- Occupancy limits of facilities must be respected and further guidance for COVID protections will be provided
- IHA will be sending out further guidance around cooling centers and a tool kit which will be shared by EMBC when received.

Clarification on costs that may be considered for reimbursement by EMBC

- A task number will be required to seek reimbursement
- A State of Local Emergency (SOLE) is not required.
  - A SOLE is only required when accessing the powers under the Emergency Program Act, such as evacuations.
- Reimbursements are limited to incremental costs, examples include:
  - Staff wages/overtime to open a civic facility that would otherwise not be open.
  - Workers Compensation coverage for ESS volunteers to support.
  - Water for use/distribution within the facility.
- For communities that do not have suitable facilities, please contact EMBC to review and discussion options.

## Tips to stay safe and cool during extreme heat wave

VICTORIA – British Columbians are being asked to take precautions this weekend, as Environment Canada has put out a heat warning for most of the province, predicting a dangerous long heat wave beginning today and lasting until Tuesday.

Environment Canada notes that the record-breaking temperatures will provide little relief at night, with elevated overnight temperatures, increasing the risk of heat-related illnesses. HealthLink BC has these tips for keeping cool and healthy:

- Never leave children alone in a parked car. Temperatures can rise to 52°C (125°F) within 20 minutes inside a vehicle when the outside temperature is 34°C (93°F). Leaving the car windows slightly open will not keep the inside of the vehicle at a safe temperature.
- Drink plenty of fluids. Drink extra water even before you feel thirsty and if you are active
  on a hot day. Ask your health care provider about how much water you should drink on
  hot days if you are on water pills or limiting your fluid intake.
- Keep cool. Stay indoors in air-conditioned buildings or take a cool bath or shower. At temperatures above 30°C (86°F), fans alone may not be able to prevent heat-related illness. Remember, sunscreen will protect against the sun's ultraviolet (UV) rays but not from the heat.
- Plan your outdoor activity before 10 a.m. or after 4 p.m., when the sun's Ultraviolet (UV) radiation is the weakest.
- Avoid tiring work or exercise in hot, humid environments. If you must work or exercise, drink 2 to 4 glasses of non-alcoholic fluids each hour. Rest breaks are important and should be taken in the shade.
- Avoid sunburn. Use a broad-spectrum sunscreen with SPF 30 or higher on exposed skin and an SPF 30 lip balm and reapply often.
- Wear lightweight, light-coloured, loose-fitting clothing and a wide brimmed hat, or use an umbrella for shade.
- Regularly check older adults, children and others for signs of heat-related illness and
  make sure they are keeping cool and drinking plenty of fluids. Check on those who are
  unable to leave their homes, and people with emotional or mental health concerns
  whose judgment may be impaired.
- Don't forget that heat also affects your pets. Never leave your pet in a parked car, limit exercise, and be sure to provide plenty of water and shade.

Home treatment for mild heat exhaustion may include:

- Moving to a cooler environment
- Drinking plenty of cool, non-alcoholic fluids
- Resting
- Taking a cool shower or bath

If your symptoms are not mild, last longer than 1 hour, change, worsen, or cause you concern, contact a health care provider.

Elevated heat also increases the risk of wildfire, and British Columbians are being urged to do their part to prevent human-caused wildfires and help keep communities safe. To report a wildfire, unattended campfire or open burning violation, call 1 800 663-5555 toll-free or \*5555 on a cellphone.
