TO: Madeline Maley, Assistant Deputy Minister, Regional Operations Branch,
Emergency Management BC

ISSUE: *EMBC heatwave supports to First Nations and Local Government*

BACKGROUND:

- Historically, EMBC has supported First Nations and Local Governments in severe weather emergencies with a compounding factor (stranded travelers, prolonged power outage, etc.) but has not supported eligibility for extreme heat or cold, except on a case-by-case basis.
- A long duration heatwave caused by an exceptionally strong ridge of high pressure impacted the Province beginning on June 23rd, 2021. Though most regions have returned to seasonal normal, heat warnings persist in the Okanagan and Fraser Canyon areas.
- EMBC regions distribute Environment and Climate Change Canada Severe Weather Notifications and Warnings to all First Nations and Local Governments as a standard operating practice. Additionally, all EMBC regions provided heat wave briefings to Local Governments and First Nations through specific coordination calls, or through already scheduled wildfire/freshet/COVID-19 coordination calls.
- On June 25, 2021, EMBC Regional Offices/Provincial Regional Emergency Operations Centers (PREOCS) noted a significant increase in calls from First Nations and Local Government to support the activation of cooling centers.
- EMBC authorized incremental cost reimbursement for staffing of cooling centres, bottled water supplied to cooling centres, and facility rental where no appropriate Local Government or First Nations-owned facility was available. EMBC engaged with Health Authority (in. First Nations Health Authority) and federal partners to share information and consider additional supports required.
- On June 28, 2021, as the severity of the heat wave impacts became apparent through discussions with First Nations and Local Government, EMBC adapted by making the cost of transporting individuals to and from cooling centers where scheduled public transportation was unavailable (rural and remote areas), as well as those costs incurred in supporting the Health system at a local level. The EMBC Southwest Regional office in Surrey had also phoned their community Emergency

Program Coordinators in the communities to let them know reimbursements would continue to be supported.

- Key messages include:
 - EMBC shares messaging from Environment and Climate Change Canada (ECCC). British Columbians can also sign up for ECCC weather updates and it's up to Local Governments to activate their emergency plans.
 - EMBC has provided significant support to First Nations and Local Government during this heat wave, and has expanded eligibility to include transportation and assistance to the Health system.
 - EMBC has supported the addition of surge medical response capacity for fire departments.
 - EMBC continues to work closely with local Emergency Operations Centers to ensure supports are well understood, and to address specific needs that are not clearly covered under established reimbursement eligibility.
 - EMBC continues to work with other Ministries (spec. Health), First Nations organizations, and federal partners to adapt to the emergent needs of communities in this unparalleled event.
 - EMBC has committed to working with all response partners to ensure a robust Provincial extreme weather plan exists for anticipated future events driven by climate change.

INDIGENOUS PEOPLES CONSIDERATIONS:

- EMBC has worked provincially and locally with First Nations Health Authority (FNHA) and Indigenous Services Canada to provide wrap-around and culturally appropriate coverage for the needs of indigenous communities during this event, and has provided pathways through response partners for costs not eligible under EMBC's funding frameworks.

Importance: High

- EMBC has provided government staff to chair coordination calls that include local governments and first nations, Interior Health, FNHA, and ISC to identify community concerns and gaps during the heatwave.
- EMBC staff have been in communication with a number of First Nations and Local Governments to discuss eligible reimbursements in an effort to support a response to the heatwave.
- EMBC is providing reimbursements for local communities that to ensure staff wages/overtime to open a cooling centre is being reimbursed, workers compensation coverage for Emergency Support Services (ESS) volunteers, water for use/distribution within the facility, transportation to and from cooling centres in communities where no scheduled public or reasonable transportation exists, and rental of facilities where no appropriate public spaces or facility exists within a particular community.
- EMBC has messaged to indigenous communities in BC, EMBC is working in close coordination with the First Nations Health Authority and Indigenous Services Canada to provide wrap-around supports to address public safety concerns.
- Some communities have established cooling centres but have not reached out to EMBC for support. Some communities may have taken action without reaching out to EMBC.
- EMBC continues to share interior health heat alert information with First Nations and Local Governments such as the following link that provides tool kits for FN and LG on how to manage heat waves:

Speaking Points for Minister Farnworth
Media Availability – Extreme Heat Event
June 30, 2021

Introduction

- Over the past several days, B.C. has seen an unprecedented heat wave, with record-breaking temperatures across the province that have lasted into the night.
- Extreme heat brings a danger that we must take seriously.
- It has the potential to cause serious risk to people, pets and communities.
- And I want to offer my sincere condolences to those who have lost loved ones over this past week.

Provincial Supports

- As a province, we've provided support in a number of ways to help people and communities get through this unprecedented heat wave:
- Working with local communities and First Nations and making supports available to them, such as Emergency Management BC reimbursements for incremental costs associated with cooling centres or fire service response to increased heat related calls. This includes:
 - Transportation to and from cooling centers in communities where no scheduled public or reasonable transportation exists.
 - Staff wages and overtime to open a civic facility that would otherwise not be open.
 - Workers Compensation coverage for ESS volunteers to support.
 - Water for distribution within the facility.
- Emergency Management BC is also working with the First Nations Health Authority and Indigenous Services Canada throughout this event, and I encourage Indigenous communities to reach out if there are heat-related emergency needs or gaps in your community.
- BC's Health Authorities and BCCDC provide resources to support local governments in developing Heat Alert and Response Plans
- BC's Health Authorities issue extreme heat alerts that were accompanied with the opening of cooling centres coordinated by municipalities and issued specific warnings to those over the age of 65 at greater risk of heat-related illness.

- Ministry of Health staff has been reaching out to local health authorities to ensure that the information and coordination of health information is consistent across province, managing the distribution of staff to deal with increased calls, and developing plans to respond to heat stress for testing and vaccine clinics, as well as long-term care and assisted living homes.
- Police and emergency services are redeploying officers and pleading for people to only call 9-1-1 during emergencies, as heat-related deaths have depleted front-line resources and severely delayed response times.

Public Health Advice

- Our systems across the province are working hard, but getting through a weather event like this safely, also means each and every person must continue to do their part to ensure their own safety and that of their neighbours and loved ones.
- So I ask everyone to remember the advise we issued last week:
 - Never leave children or animals alone in a parked car
 - Drink plenty of fluids
 - Keep cool in air-conditioned buildings, or take a cool bath or shower
 - Plan activity before 10am or after 4pm
 - Avoid tiring work or exercise in hot, humid environments
 - Wear lightweight, light-coloured, loose-fitting clothing and a wide brimmed hat
 - Avoid sunburn by using a broad-spectrum sunscreen, reapplying often
- Many businesses that offer air conditioning and a cool centre, such as libraries, are extending hours to provide relief for those who do not have access to a cool area.
- And please...take a moment to take an inventory of all the people in your lives – your parents and grandparents, and elderly or vulnerable neighbour. Check to see how they're doing and how you can support them.

Moving forward

- This kind of heatwave is not typical of British Columbia, but with the reality of climate change, we can't ignore the potential for this to become more common in the future.
- As Minister Dix mentioned the other day, we've broken records day after day for calls to emergency services.
- And weather records have been broken and broken again. This week has seen the hottest temperatures ever recorded in Canada.
- And two of the past three years have been the worst wildfire seasons B.C. has faced – this year we could be facing another difficult one.

- So we have to be ready.
- Because we can't ignore the possibility of a next time, and it's clear that we can't rely on what we've done in the past.
- So after we're past this, we all need to take a hard look at what we need to change for the future.
- Air conditioners and heat pumps are in short supply in the middle of a heat wave.
- And local governments need to continue to modify plans as our climate changes. But we are here for support. Please let Emergency Management staff know what you need.
- Our government is working to prepare for a changing climate so that we can build a better future for our kids and grandkids and protect the places we call home.
- We're taking more than a dozen actions this year as part of the first phase of the Climate Preparedness and Adaptation Strategy to help set the stage for future work.
- As a final word, I want to tell everyone across British Columbia – please take this heat seriously.
- These deaths are tragic, and I want to offer my condolences to anyone who has lost a loved one.
- Stay safe and help others who can't help themselves. We need to work together here.
- I'm now happy to take your questions.

South West Emergency Management Partners

To assist Indigenous Communities and Local Governments in responding to the current Heat Wave the following is an overview of what supports are available through the Emergency Program Act:

- Reimbursements are limited to incremental costs, examples include:
 - o Staff wages/overtime to open a civic facility that would otherwise not be open.
 - o Workers Compensation coverage for ESS volunteers to support.

- Water for use/distribution within the facility.
- Transportation to and from cooling centers in communities where no scheduled public or reasonable transportation exists.
 - Requires Expense Authorization Form (EAF) approval from PREOC
- For communities that do not have suitable facilities, please contact EMBC to review and discussion options.
 - Community requested by Health Authority to provide assistance to respond to impacts to current heat wave, those activities may be considered for reimbursement.
 - Would be considered through Expense Authorization Form (EAF) to the EMBC Regional Duty Manager or PREOC.
 - Incremental costs to support fire service responding to increased heat related calls.
 - Would be considered through Expense Authorization Form (EAF) to the EMBC Regional Duty Manager or PREOC.
- “For Indigenous communities in BC, EMBC is working in close coordination with the First Nations Health Authority and Indigenous Services Canada to provide wrap-around supports to address public safety concerns. Please contact the EMBC Regions or PREOC if there are heat-related emergency needs or gaps in your community.”

As promised, the reimbursement of incremental costs that EMBC may support during the current heat wave is provided below. EMBC has included a transportation provision that may be supported based on the concerns that FNHA had flagged to EMBC at 16:30 hrs today. See the below example and requirements for reimbursement.

For communities that may be looking at setting up cooling centers

- A Medical Health Officer (MHO) order is not required. There were elements of EMBC Policy 5.13 that required an MHO order but policy 5.13 is specific to the COVID Pandemic and not required for other emergencies.
- It is expected that Local Government and First Nation communities will utilize their existing owned facilities (Rec Centers, Curling rinks, offices etc.)
- Where those facilities do not exist, there are other Commercial or Non-Government Organizations that may have suitable facilities (Malls, Churches, community centers etc.) may also be able to assist.
- Occupancy limits of facilities must be respected and further guidance for COVID protections will be provided
- IHA will be sending out further guidance around cooling centers and a tool kit – which will be shared by EMBC when received.
