Hello all,

The next Joint Committee of BC/Canada Ministers and FNLC leadership is scheduled to take place in person in Vancouver next Monday, April 11th. Ministers are expected to attend in person, and DMs via video. Materials will be distributed later this week.

The federal budget is scheduled to be tabled on Thursday this week, and this is having an influence on Canada committing to a firm meeting agenda. Below is Canada's latest thinking as of Saturday, and I will follow up again when we have a firm sense of things. What we do know is 3 things that BC will be responsible for: (1) Premier Horgan will deliver opening remarks; (2) Tom Ethier will deliver a presentation on floodplain history and context that will be followed by discussion by Ministers; and (3) Minister Farnworth will present a short deck about BC's known and expected costs for a large DFAA claim from Canada that might turn into an announcement.

With federal Minister Blair in town for the meetings, he is also taking the opportunity to meet with Mayors from flood-impacted communities (joined by Minister Farnworth), as well as meeting in-person in Abbotsford with the Emergency Planning Secretariat that represents 31 Mainland Cost Salish Communities.
