Ministerial Order No. M205

WHEREAS a declaration of a state of emergency for the Stikine Region in the Province of British Columbia was declared on July 10, 2023;

AND WHEREAS section 10(1) of the *Emergency Program Act* provides that I may do all acts and implement all procedures that I consider necessary to prevent, respond to or alleviate the effects of any emergency, including causing the evacuation of persons from any area of British Columbia that is or may be affected by an emergency or a disaster, making arrangements for the adequate care and protection of those persons and controlling travel to any area of British Columbia;

AND WHEREAS the Little Blue River Fire, southwest of Lower Post, poses a significant threat to the health, safety and welfare of persons;

AND WHEREAS evacuation of and limiting entry to areas affected by the Little Blue River Fire reduces the risk of injury or death;

I, Bowinn Ma, Minister of Emergency Management and Climate Readiness, order that the attached Little Blue River Fire Evacuation Order is made.

Evacuation Order - Little Blue River Fire

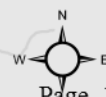

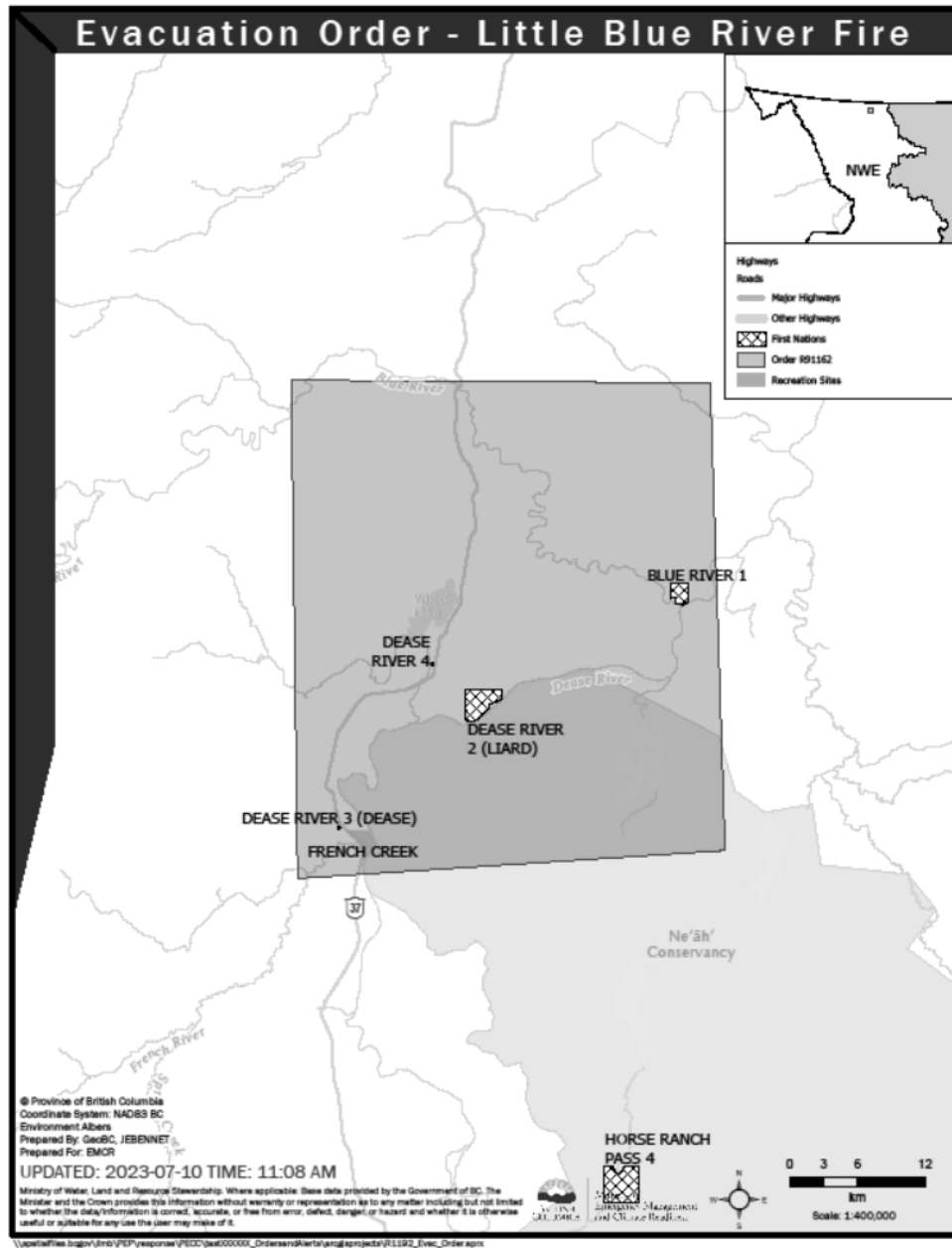
