Doug and Brent asked that I circle back on a few follow-ups from the call earlier this week.

1. David Hutchens remarks at the fed Natural Resources committee are attached here. Video for Molly and John's remarks from April 26 can be accessed here:

Lots of dialogue on April 26 on hydrogen from MPs and NRCAN/ECCC's views on the same. I gather Ottawa isn't quite as efficient as the BC legislature at publishing hansard blues so it may be a while yet before transcripts are published..

2. Agricultural sector & ghg emissions abatement: see attached for the letter we mentioned. We'd provided this in 2018 as part of the Revitalization of ALR and ALC consultation. This is a bit dated and we will circle back on this internally to see if there are any updates we'd seek to provide.

One item we should mention that is related is the consultation around Air Quality permitting

fees that Metro Van is currently undertaking. Not sure if this is something that EMLI is plugged into but worth being aware of given our conversation on the ag sector. I know the Canadian Biogas Association has concerns with regard to what is being considered and potential impacts on their sector, as do we. Below email provides some context on their views. We reflected these comments in our own submission but flagging for your awareness.



Metro Vancouver has proposed <u>Potential Amendments to Air Quality Permit and Regulatory Fees</u> that would create significant challenges for biogas plant development and operation.
