Good Afternoon,

Below I have included a summary of what I have cobbled together regarding the Albert Lake Diesel Spill. At this point as the alleged violation is both unconfirmed and 4 months old, as such there are no actions for EEP to take. From what I have gathered, allegedly a diesel spill occurred, and the responsible person failed to report it and then what I believe to be the bigger issue, the waste from that spill was dumped in the woods where it leached into a lake. I believe that some sort of investigation is warranted but have to leave it to the agencies who have that mandate to decided. Shawn and Jason, I will leave it to the two of you to determine what if any appropriate next steps need to be taken and who will take them.

I am going to be closing the EEP file on this incident. Should a spill be confirmed and a responsible party identified there may be some compliance issues for EEP to engage on (spill reporting and end of spill reporting).

I have had the ECC create a DGIR to house the information. DGIR 223247.

- The incident was first reported to Ministry of Forests, Compliance and Enforcement on Oct 4, 2022. Their file number is 197332
- The violation is reported to have occurred on Aug 25, 2022
- The Ministry of Forests C&E staff forwarded the complain to the conservation officer service for investigation
- · The COS staff then forwarded the file to ROB Compliance, planned compliance
- Planned Compliance then forwarded it to Reactive Compliance as it is a reactive issue
- Reactive compliance then forwarded to the COS as it is not a permitted site or operation, and the details suggest that an investigation is needed not inspection
- · Ministry of Energy and Mines was also briefed at some point but as this was not at a mine site but rather an exploration project, they have deferred to ENV
- · IT appears that the issue has gone back and forth between ENV Compliance and the COS multiple times
- No one has taken any actions at this point, that includes engaging or briefing the Takla Nation

Next Steps

- EEP to re-engage with COS to request an investigation
- ROB Reactive Compliance has agreed to assist the COS with the investigation if required.
- · Spill response actions currently are not appropriate as:
 - There has been no confirmation of a spill just a reports.22
 - EEP currently does not have a responsible person to undertake actions, this would need to be determined through investigation
 - · The incident occurred long enough ago that effectiveness would be limited
 - Remoteness of the site and the onset of winter are both complicating factors
- If an RP and a spill are determined to have occurred further spill response actions or enforcement of EMA can occur

- 1. Kaza Lake Many members have brought this to our attention for clean-up.
- McConnell Property Member have mentioned some old buildings or clean-up work needed at the old McConnell property. We would be interested to look further into his property regarding roads being built as well.
- 3. Chuchi Lake— Would have to look more into this, but reports from residents about old sites and stuff being left behind by companies.
- 4. Albert Lake Very recent information: We were just notified about a contractor possibly spilling fuel into a creek near this lake this summer. Lands looking to quickly do water sampling as soon as we get more information.

Perhaps we could plan a meeting to discuss some possible next steps?

CONDITIONS

The Chief Inspector of Mines hereby approves the Notice of Work and Reclamation Program (Application) subject to compliance with the following conditions:

1. Reclamation Security

- a. The Permittee shall maintain with the Minister of Finance securities in the amount of forty four thousand six hundred and forty six dollars (\$44,646). The security will be held by the Minister of Finance for the proper performance of the approved program and all the conditions of this permit in a manner satisfactory to the Chief Inspector.
- b. Year one of the MYAB program is limited to 7 drill sites, construction of up to 2.0 kilometers of exploration access road and up to 1.2 kilometers of hand-cut ATV trail. Reclamation security amount of \$28,646 covers year one of the Multi-Year Area Based (MYAB) program. Following completion of year one of the MYAB program, the total reclamation security will be re-evaluated by the regional Inspector of Mines. MYAB mining activities beyond the year one activities shall not be initiated until the security has been re-evaluated and written authorization has been issued by the regional Inspector of Mines.

Permit Approval

This approval is valid for the period beginning February 22, 2019 and ending prior to February 22, 2024.

Land Use

The land surface shall be reclaimed with the intent of establishing average pre-mining capability to the following end land use objective: wildlife habitat.

4. Documentation

While it remains valid and subsisting, a copy of this Approval shall be kept at the subject mining property, and shall be available to the regional Inspector of Mines and other authorized government officials.

Mine Emergency Response Plan

The Mine Emergency Response Plan shall be posted in a conspicuous place accessible to all persons on the mine site.

6. Environmental Protection

- a. Contaminated or sediment laden water, created as a result of mining activities, shall be contained on the mine site and not allowed to enter any watercourse.
- b. All practicable measures shall be implemented to minimize impacts to wildlife.
- c. Excessive dust and noise shall be controlled at the source.
- Immediately following cessation of drilling at a drill site, drill holes shall be capped and/or sealed.

Disposal of Fuels and Toxic Chemicals

Fuels, chemicals, or reagents which cannot be returned to the manufacturer/supplier are to be disposed of in compliance with municipal, regional, provincial and federal statutes.

8. Exploration Access Construction and Modification

- a. Fording of watercourses is not authorized.
- b. Any stream within the mine site shall be assumed to be fish bearing unless determined otherwise by an appropriately qualified professional.
- c. Crossing on fish bearing streams shall adhere to Fish-Stream Crossing Guidebook (September 2012).
- d. All practical means shall be implemented to minimize surface ground disturbance, including the amount of new trail and road development. This shall include maximizing the use of existing access.
- e. Prior to initiating access construction, a qualified person shall determine the terrain stability classification for all areas where new roads and trails are to be constructed. Access construction in areas classified Class 4 Terrain stability or greater will require an engineered design. This engineered design shall be provided to the regional Inspector of Mines for review prior to initiating construction.
- f. All new exploration access shall be fully reclaimed including re-contouring of disturbed areas to achieve surfaces similar to pre-disturbance shapes.

Fuels and Lubricants

Handling, transportation, and storage of all fuels and lubricants shall conform to the requirements of the *Field Guide to Fuel*, *Handling*, *Transportation and Storage*.

10. Erosion and Sediment Control

- a. Erosion shall be minimized through landform configuration, development of maintenance-free vegetation covers and through the development of stable, selfsustaining drainage control features.
- Culvert crossings must be installed and removed in a manner that prevents sediment introduction to the aquatic environment and ensures downstream water quality is not impacted.

11. Wildlife Protection

Exploration activities shall be conducted in a way that:

- a. minimizes impacts to terrestrial and arboreal lichen forage,
- b. minimizes predator mobility,
- c. limits caribou visibility to predators,
- d. limits forage for, and thus production of, early-seral ungulates (alternate prey species),
- e. limits fragmentation of large tracts of annual range, and
- f. limits disturbance to caribou.

12. Reclamation

a. Progressive reclamation shall be conducted whenever practicable.

- b. Reclamation activities shall include:

 - iii. Salvaged and stockpiled soil material shall be replaced and shall:

 - c. All topsoil, overburden, and organic material including large woody debris for use in reclamation shall be salvaged and stockpiled.
 - d. Materials stockpiled for reclamation purposes shall be re-vegetated using a certified weed-free seed mix species appropriate for the BEC Zone and the site conditions, to reduce erosion of stockpiles during the storage period.
 - e. Materials salvaged for use in reclamation shall be segregated based on salvage origin and measured suitability for reclamation purposes. Any materials with the potential to be contaminated shall be characterized and evaluated for suitability for reclamation uses prior to mixing with other sources and/or applying on-site.

13. Annual Reporting

The Annual Summary of Exploration Activities and Multi Year Area Based Annual Update forms when submitted, shall be accompanied by a detailed as-built map of the mine site.

14. Archaeological Chance Find Plan

All workers on the site shall be aware of and understand the Archaeological Chance Find Plan and shall adhere to the procedure.

In the event that an archaeological site is encountered during the course of the approved mining activities, the program shall be suspended or modified in such a manner so as to ensure that the site is not damaged, desecrated or otherwise altered and the occurrence shall be reported immediately to the Archaeological Branch of the Ministry Forests, Lands & Natural Resource Operations and, the Ministry of Energy & Mines (Inspector of Mines). Work shall not be resumed until authorized by the joint Ministries.

Site Access:

- The Mine Manager, or in their absence a Designate, shall allow Employees of other Provincial Ministries holding authorizations related to Compliance and Enforcement duties onto the mine site subject to the following conditions:

Site Stability:

- The inspector shall be advised in writing at the earliest opportunity of any unforeseen conditions that could adversely affect the extraction of materials, site stability, erosion control or the reclamation of the site.
- 2. The stability of the slopes shall be maintained at all times and erosion shall be controlled at all times.
- 3. The discovery of any significant subsurface flows of water, seeps, substantial amounts of fine textured, soils, silts and clays, as well as significant adverse geological conditions

shall be reported to the inspector as soon as possible and work shall cease until the inspector advises otherwise.

Site Specific Conditions:

- 1. Exploration activities are limited to Exploration surface drilling and induced polarization and those activities described in your March 3, 2016 Notice of Work.
- 2. No site disturbance, including diamond drilling, is authorized inside of Old Growth Management Areas. This includes drill hole locations labelled N and O on the maps attached to the Notice of Work.
- 3. The Permittee shall develop a written Safe Work Procedure for the safe use of an induced polarization geophysical system. This procedure shall contain but is no limited the items listed below.
 - I. Energized wires shall be sufficiently insulted to prevent electric shock
 - II. Induced polarization electrodes shall have visible warning stickers stating "Danger – High Voltage"
 - III. Signs shall be posted to warn other persons who may enter the area
 - IV. Electronic communications shall be provided to every member of the crew whose movements are out of sight and sound of the other crew members
 - V. All signs shall be removed on completion of the survey and no wires used during the survey shall be left on the site after the survey is completed.
- 4. The operator shall ensure that the proposed exploration activities do not affect nesting birds, especially under Section 34 of the *Wildlife Act*. Typical species of interest would be Heron, Eagle, Peregrine Falcon, Spotted Owl and primary cavity nesters.
 - I. No mechanical work shall be conducted during Marbled Murrelet nesting and rearing season or for a two-week period before and after this season.
- 5. All work shall be suspended during any forest closures relating to extreme fire hazard conditions as determined by the Ministry of Forests, Lands and Natural Resource Operations. Firefighting equipment shall be maintained on the site in accordance with the Forest Fire Prevention and Suppression Regulation.
- 6. The mining operation shall not negatively impact any utility service infrastructure, other resource based activities or recreational values in properties which share common boundaries with the mining activity.
- 7. The manager shall forward to the Inspector a copy of the Health and Safety Assessment form submitted to the Minister of Finance each year.
- Access roads created or utilized under this permit shall be provided with adequate drainage, appropriately ditched and/or water barred.

- 9. The site shall not be used for any other purpose than that described in the Notice of Work. Disused or damaged equipment shall not be stored on site and the site shall not be used for the disposal of items including but not restricted to; garbage, wood waste, toxic materials, and petroleum waste.
- 10. Appropriate measures shall be taken to protect against inadvertent access to the settling pond(s), ditches, wells, trenches etc.
- 11. The Permittee shall ensure spill kits are available in all locations where there is a potential for a hydrocarbon spill.
- 12. The Permittee shall immediately contain and implement remedial measures for any spill of hydrocarbon or other deleterious substance at the mine site. Any such occurrence shall be reported to the Inspector, and to the Provincial Emergency Program in accordance with the Spill Reporting Regulation of the Environmental Management Act. Contaminated materials shall be disposed of in a manner acceptable to the Regional Waste Manager. Any spill of hydrocarbons requiring reporting under the Transportation of Dangerous Goods regulations shall be considered a Dangerous Occurrence.
- 13. Sediment laden water resulting from mining activities, including surface drainage, shall not be allowed free access to creeks or water courses but shall be suitably contained and /or treated to produce **final effluent not exceeding 25 mg/l total suspended solids** prior to discharge to the surrounding environment.
- 14. The Permittee shall under take monitoring programs, as directed by an Inspector of Mines to demonstrate and ensure all environmental and reclamation objectives are achieved.
- 15. Machinery shall not be operated in a water course or riparian area.
- 16. Machinery operating near a watercourse and/or settling pond shall be in good repair and free of oil leaks and free of surface oil and grease.
- 17. Stationary engines shall be provided with drip pans that shall be cleaned on a regular basis.
- 18. Equipment shall be refueled using mobile tanker. Mobile equipment shall not be refueled or serviced within 50 meters of any watercourse.

Hi guys,

I took a quick look at this file.

The 2019 ASEA test pits were confirmed via email to have been dug and stated the project was confirming bedrock. I couldn't see any correspondence back from the Inspector on whether or not this was followed up on after this.

They submitted a 2020 ASEA which indicated only soil sampling. A 2021 MYAB showed no drilling, 800 m of trail and 5km IP, a 2022 MYAB captured the 2019 test pits, showed 9 drill pads and a site total of 1.8km of trail and the 5km of IP. This included a map showing locations of the drill sites (see attached) The report for this year won't have been submitted yet.

We should still get out there as it hasn't been inspected, but hopefully this helps clarify work done on the site.




