

US - China deal improves potential for direct LNG exports

LNG exports highlighted in US-China joint statement on trade

- On May 11, 2017 the US and Chinese governments announced a deal that improves the potential for direct LNG exports between the countries.
- In the statements jointly released by US Department of Commerce and Chinese Ministries of Commerce and Finance, ten areas were identified where significant progress has been made regarding trade negotiations and where market access or increased co-operation is expected by the end of the 100-day period (July 16, 2017).
- One point of specific interest to the global gas industry was the explicit statement that China is
 welcome to receive direct imports of US LNG and that the country is treated no less favourably than
 any of the US' non-free trade (FTA) trading partners regarding LNG export authorizations. The
 statement goes on to highlight that Chinese companies are free to negotiate with US LNG exporters
 including for long-term contracts subject to the individual parties' commercial consideration.
