He has been unpleasant at best.

I know many of you directed him to our department (thank you – that is the appropriate course of action) and after emailing him twice, we finally connected.

Marielle has had more than one conversation with him and this morning I reiterated our position.

For your information s.22 let me know on the call that he is not a journalist but a citizen and his website, when launched, will be citizen driven.

I asked him for examples of his past published work.

I explained to him that he can get all the news releases he wants and needs by subscribing through the public facing website (<https://news.gov.bc.ca/subscribe>) and can connect with Comms shops if he has questions or wants to request interviews.

He is extremely unhappy that I won't have him added to the Media Advisories list as he not an accredited journalist at this time.

As you know, often advisories have media dial in information that is not for the general public and this gentleman has not demonstrated that his is, in fact, media.

I explained that it was my call whether or not he was added to the list. He did not like that.

He has already threatened to go to the Ombudsperson, and today he suggested going to court to get some sort of injunction against me or the government. I'm not exactly sure but that was when I ended the call (that he was recording).

If he calls you or your department, please refer him back to me.
