Minister- we are providing a funding grant for a study to ITM Power (AIM: ITM), the energy storage and clean fuel company, to undertake a Power-to-Gas (P2G) feasibility study. They are putting a release out next week of their own and would like to use the same quote as this government release we would like to distribute.

The project involves techno-economic feasibility for large scale centralized production of renewable hydrogen. Hydrogen electrolysis of up to 300MW for both domestic and international export will be considered. Assuming a positive economic result, a pilot plant will be considered for construction in the future. The project team includes ITM, Chiyoda Corporation, Mitsui & Co., Ltd. and G&S Budd Consulting Ltd. The project is due to commence in Q2 2018 and has a duration of 18 months.
