Mining Month celebrates mining's contribution to innovation in B.C.

British Columbia has a long history in mining, from the first coal mines on Vancouver Island in the mid-1800s, through the Cariboo gold rush to the modernized mines of today, mineral exploration and mining has remained a foundational industry of our province.

Given its history and important role in our daily lives, it is fitting that this year, for the first time, we expand the celebration of this important industry from a single week to a full month. As Minister of Energy, Mines and Petroleum Resources, it is my pleasure to proclaim May Mining Month in British Columbia.

Our government understands the important contributions the mining industry makes to the people and communities of our province. And while some may view mining as simply a traditional sector, we recognize it is much more than that: it is a hotbed of innovation for the future.

British Columbia is the largest producer of copper and second largest producer of silver in Canada. As we transition to electric vehicles, solar panels and wind turbines, those minerals will be even more essential – the average two megawatt wind turbine contains five tonnes of copper and 230 tonnes of steel and electric cars require up to four times more copper than conventional vehicles.

Not only are British Columbia minerals and metals key components in renewable energy production and reducing carbon emissions, but our mining industry is also partnering with high-tech companies and adopting cleaner technology to reduce its impact on the environment.

A great example of this innovation and technology is MiningVR, a virtual reality (VR) platform designed right here in British Columbia by high-tech firm LlamaZOO. This unique VR technology

gives mining companies the ability to map mine plans onto a life-sized interactive experience that aids companies in all facets of mine development, including resource management, mine planning and reclamation.

Using LlamaZOO's technology, mines can bring their mine site to any location with virtual reality. This means technical experts, governments, First Nations and community members can take a virtual walk through a company's mine site from any location in the world, and thus reduce associated GHG travel emissions.

One of the biggest mining companies in B.C., Teck Resources, is also a partner in one of the largest technology superclusters: the B.C. based Digital Technology Supercluster. Part of its work will focus on what it calls the Earth Data Store that will facilitate improved data collection, sharing and visualization – enhancing confidence in resource sector project planning and assessments for proponents, Indigenous Peoples, government and communities.

Our government is also working with our federal, provincial and territorial partners to develop the Canadian Metals and Minerals Plan. Part of our discussions involves looking at ways to ignite innovation in our mining sector. This may include the development and adoption of clean technologies and the use of artificial intelligence to improve safety and reduce hazards.

As a regulator, government also has a role in innovation for our mining sector. That is why I launched the Mining Jobs Task Force in February to look at ways we can create and sustain good jobs in mining across BC. Among other issues, our twelve member Task Force will look at innovation in the mining sector, examine how BC compares to other jurisdictions and provide recommendations to strengthen mineral exploration and mining in our province. In an era when we will need minerals for an electrified economy and transportation, we want B.C. to be cutting edge and a world leader.

Along with looking at what government and our BC mining sector can do here at home, we're reaching out abroad to let the world know that BC mining is an excellent investment. Just this past month, the government, along with First Nations and several exploration companies from B.C.'s northwest region created the B.C. Regional Mining Alliance (BCRMA) to promote British Columbia's mining opportunities internationally. The B.C. Regional Mining Alliance is an opportunity for First Nations and industry to showcase how collaboration is leading to world-class mineral development in our province and demonstrates our governments' commitment to working with First Nations and industry to build a new generation of relationships and partnerships.

Our government is committed to working with First Nations, mining communities and industry to strengthen and improve natural resource development in this province so that we can build a strong, sustainable, innovative economy that works for all British Columbians.

"Our government is committed to working with First Nations and industry to build and strengthen the opportunities these agreements create."

The Nisga'a Nation will share in benefits of Brucejack Gold Mine

GINGOLX – A new agreement with the Province will ensure the Nisga'a Nation will receive a share of mineral tax revenue collected from the Brucejack Gold Mine in northwestern B.C.

"Part of our commitment to a new government-to-government relationship with First Nations, based on recognition of rights, includes sharing the wealth from natural resource projects in the province. Together, we can improve the lives of people living in First Nations communities and create a strong economy for generations to come by sitting down with First Nations as true partners in economic development within their territories," said Minister of Indigenous Relations and Reconciliation Scott Fraser.

The B.C. Government entered this revenue-sharing agreement to create access to a source of revenue for the Nisga'a Nation. The Economic and Community Development Agreement has the potential to generate more than \$8 million annually for the Nisga'a Nation.

"Bringing prosperity and self-reliance to the Nisga'a Nation is the first priority of Nisga'a Lisims Government. We have developed a strong working relationship with Pretium Resources Inc. and look forward to our continued collaboration on the Brucejack Gold Mine. On this historic day, the 18th anniversary of the effective date of the Nisga'a Final Agreement, we are pleased to once again affirm the Nisga'a Nation's government-to-government relationship with British Columbia," said Eva Clayton, President of Nisga'a Lisims Government.

The Brucejack mine is an underground mine owned and operated by Pretium Resources Inc. The Nisga'a Nation and Pretium entered into a Co-operation and Benefits Agreement for the project in 2015. That

agreement provides for collaboration during permitting process and financial and other benefits to the Nisga'a Nation as project milestones are reached.

Under the Co-operation and Benefits Agreement, Pretium committed to provide education and training for Nisga'a citizens, setting employment targets and ensuring Nisga'a businesses have access to contracting opportunities.

The annual payments the Nisga'a Nation will receive under the ECDA with B.C. are in addition to the benefits received under its agreement with Pretium.

The mine was commissioned in April 2017 and will gradually ramp up production to 2,700 tonnes per day and create more than 300 jobs during the minimum 22-year life of the mine. Company representatives have said that involving First Nations early in the process gave them the confidence to proceed with the project.

"Agreements that provide for meaningful engagement and commitment for the long-term put all parties on solid ground. This brings certainty, which is beneficial both for business and communities," said Pretium Resources Inc. Executive Vice-President Michelle Romero.

Dear Mr. Maier:

Thank you for your interest regarding BC's new framework for natural gas development and for your company's continuing efforts to advance the development of a liquefied natural gas (LNG) industry in BC.

As we have discussed, on March 22, 2018 the Province announced a new framework to support natural gas development. If the conditions outlined in that announcement are met on or before November 30, 2018, the Province will seek to enact legislation or regulations so that the framework would apply to any company participating in the LNG industry in BC.

If the framework is implemented, the Province would establish a mechanism to offer an exemption on Provincial Sales Tax (PST) to all proponents constructing significant facilities in British Columbia, conditional on them entering into a separate agreement with the Province committing to make a series of operating performance payments. This relief from PST would be in line with the policy for manufacturing facilities and would apply during the construction of the plant. The PST exemption would not apply to the procurement of feed gas or to mid-life capital refreshes of plant equipment.

Projects that enter into an agreement to make operating performance payments would be committing to make a series of performance-contingent payments (e.g. coming due upon first production of LNG in a given year) over a set period (for example 20 years). The total value of payments under the agreement would approximate what the project would have otherwise paid in PST during the initial facility construction period, however, it is the Provinces intention to structure these payments to be operating in nature – they are not simply a deferral of PST. It is envisioned that the majority of the value of payments would be made in the final years of the agreement to maximize the benefit of this measure on project economics.

Another key component of the framework would be the Clean Growth Incentive Program. Under this program, as described in Budget 2018, the Province intends to establish a series of emissions intensity benchmarks, replacing existing requirements under the current *Greenhouse Gas Industrial Reporting and Control Act*. Under this program, LNG Facilities would be eligible for a partial or full refund of carbon taxes paid above \$30 per ton of emissions depending on their performance against the established benchmarks. It is my understanding that the design of your facility would position it as the lowest emission-intensity LNG facility in the world. If this is the case, it would be eligible for a full refund of carbon tax above \$30 per ton under the proposed program.

The framework includes plans to take steps so that LNG projects would pay the general industrial electricity rate charged by BC Hydro instead of an LNG rate or the eDrive rate. The standard industrial rate levels the playing field with other industries, and allows for the rolling in of some interconnection costs subject to discussion with BC Hydro. I understand that your company is in ongoing discussions with BC Hydro to better understand the opportunities to supply clean power to enable your facility to run entirely on electricity.

Lastly, the framework also includes the repeal of the existing LNG income tax while retaining the natural gas tax credit.

The Province has worked closely with the team from Kitimat LNG regarding the fiscal framework in BC as it relates to the economics of your specific project. We look forward to continuing to work with you to build our understanding of other competitiveness issues that may be unique to your project and to identify potential measures to address those unique issues.

Once again, thank you for interest. Chevron and its Kitimat LNG project are a valued part of the natural gas industry in BC and the Province appreciates the investments it has made and continues to make in the industry. I look forward to continuing to work with Chevron as we build a thriving, safe, environmentally responsible and competitive natural gas industry.
