Dear Evan,

I received your business card from one of our Executive Officers, Corinne McKay, who attended the meeting with the Premier last week. Corinne indicated that I could contact you to follow up on the Premier's discussion with members of Nisga'a Lisims Government at the Terrace meeting. I had asked our general counsel, Margaret Rosling, to follow up and your administrative assistant gave her this address for further correspondence.

Nisga'a Lisims Government is requesting a meeting with the Premier, Minister Mungall and Minister Fraser to follow up on our discussions last September at the First Nations Gathering concerning potential LNG development in the Nass Area and the steps that are necessary to close the pending land transaction at Nasoga Gulf. Of course, we would be pleased if other members of the Cabinet and senior staff are able to attend as well.

We have identified April 16 as a date the NLG senior government representatives are available and are hoping that this date can work for the Premier and his Cabinet colleagues. We understand that the Legislature is in session on that date and are planning to travel to Victoria for the meeting so that it does not interfere with duties in the House.

Minister Donaldson has recently corresponded with us as well, seeking a meeting to discuss issues that have arisen as a result of the recent amendments to regulations relating to grizzly bear hunting. We have also advised Minister Donaldson that April 16 is our preferred date.
