We strive to make decisions on average within 60 days for Notice of Work applications. That being said we have a number of files that take a lot longer than the average as a result of complexity of the work program, proximity to urban areas and/or deep consultation processes. In this case due to the proximity to urban area and community concerns the inspector is undertaking a longer process to ensure a robust decision.

I understand the statutory decision maker is continuing to work with the company to gather information to support his decision.
