- In the first phase of the review, government is working with BC Hydro to identify cost savings, efficiencies, new revenue streams and other changes.
 - This part of the review is being done to keep electricity rates low and predictable over the long-term, while ensuring BC Hydro has the resources it needs to continue to provide clean, safe and reliable electricity.
- A report on the first phase of the review, and government's response, will be released in the fall of 2018.

Hi Scott,

To answer your question – to date, uptake from the taxi industry in the CEV Program has been very limited.

The major user of EVs as a taxi is a company called Current Taxi, located in Kelowna. They are an all-electric taxi fleet using solely Tesla vehicles. They have recently added a Model 3 to their fleet which will have received an incentive under the CEVforBC program. However, the rest of the fleet, comprising of Model S and Model X vehicles, will have not received an incentive due to the program's MSRP cap. As we are aware, no other uptake from the taxi industry has occurred.

Further, under our Specialty-Use Vehicle Incentive (SUVI) Program we have included a pilot offering of a \$5,000 incentive for the BYD E6 which is being offered in North America as a vehicle only for Taxis and fleet delivery. To date, there has been no uptake under this offering.
