Thank you for taking the time to share your views with me about the future of the Site C dam. I appreciate the active participation from British Columbians on this issue and want to assure you that I listened and heard your concerns.

As you are most likely aware, we have made the difficult decision to proceed with Site C. The project should never have been started, but we cannot change the previous government's mistakes. - Ensuring the Peace River Legacy Fund implements solutions to longer-term environmental, social and economic issues.

Background

This is a follow-up to a media request from December 13, 2017.

Recommendation
