The new underground generating facility is nearing completion.

Throughout late March and April the process of watering up of the tailrace and power tunnel will take place. Access to the underground areas will get less and less.

Generating unit testing will begin in May.

In June the first generating unit will begin to generate electricity into the power grid. (note also in June the final generator in the old generating facility will be shut down – we are hoping that MCT is available to pull the switch! Full connection is expected in October.

As an fyi on Friday March 9<sup>th</sup> MCT will be touring the facility as preparations for watering up begins. I understand that Check TV and CTV will also be there.

The Ministry may be responding directly to your request below but I've also asked our comms department to draft me a one/two page Key Messages document that I can share with you re: the issues you bring up below. Please draw from these.

## Two -Tiered Rates:

- B.C.'s new government is committed to making life more affordable for everyone.
- We have heard from many people who are concerned with two-tiered rates, especially in regions of the province not served by natural gas and by people who rely on electricity to heat their homes in the winter.
- In the months ahead, we will work with BC Hydro and other utilities (such as FortisBC) to address concerns about two-tiered rates.
- BC Hydro customers concerned about their rates are encouraged to engage with BC Hydro and the British Columbia Utilities Commission regarding BC Hydro's 2017 Rate Design Application.

## RE: Difficulty obtaining meeting with Minister, Deputies, Assistant Deputies, etc.

There seems to be mass confusion within both your constituency office and the ministerial office. I have spoken to (and emailed) several people in both offices since the day after Michelle's appointment as Minister. Yes, I have also spoken to you on a number of occasions.

There are 2 separate issues shared with you:

1. An urgent need to have input into electricity policy reform and re-make of BC Hydro. This requires expert input from leaders in renewable electricity. Time was of the essence and it was intertwined with Site "C" and other issues. Where are the Minister, Deputy Ministers and assistants getting the necessary input? I have half a century's involvement in this sector. Our operation is the oldest hydroelectricity producer in the province and we were the first certified "green" electricity producer in western Canada. I have been willing to share my expertise for free. In view of the difficulty to secure a meeting with the Minister (and/or staff) I have taken valuable time to make written submissions. I have never received an acknowledgement (or thanks). Repeatedly we have tried to follow up the meeting requests with people in both offices. Most of the time our communications are not acknowledged. The scant responses have been an apology stating that our submissions were lost and asking us to resend (which we promptly did) and most recently a comment by a staff person in the ministerial office stating that they couldn't find any requests from us for a meeting! In almost 50 years of dealing with a succession of governments, I have never experienced such difficulty in providing input to a Minster. In the past they have generally come to me.

Rob, you made a comment in your email about Michelle dedicating "her time to meeting with her constituents and local stakeholders". Geographically, we are the same distance from our MLA, Katrine Conroy, as we are from Nelson. I volunteered to come to Nelson. In terms of consistuents, in Michelle's portfolio as minister, is the oldest electricity producer in BC, the first certified "green" hydroelectric producer in western Canada, one of only six generating/distribution utilities in BC and the *only utility currently supplying 100% renewable electricity*.....are we not in her constituency? Katrine Conroy (our MLA) has met with me on several occasions to discuss electricity reform and she shares our frustration that we cannot get beyond Michelle's gate.

I want you to know that month's before the current government was elected, I was invited to a special meeting in Vancouver to speak with Adrian Dix, Gary Holman, Katrine Conroy and John Horgan to discuss how immediate electricity policy reform could be jump started in the event that the NDP could win the election. I was given solemn assurance that I would be involved in the much needed reform. What happened? \$.22 s.22

2. This is the less important issue. I extended an invitation to the Minister to visit our 121 year old operation. It is located less than 2 hours from Nelson. I am making the assumption that the Minister would like to be aware of this important BC/Canadian/World history. I assume she would like to learn new things about technology, the environment and the economics of a true "green" producer. The invitation is for her benefit, not ours. Is it important for her (and her staff)? Previous ministers, chairmen of BC Hydro, other important utility people, engineers and scientists have requested to see our facility. None of them have been disappointed. The invitation was a courtesy to Michelle. I understand she is busy too. If it is important to her (and this is largely in the hands of her advisors), she is welcome to benefit by a visit here and an interaction with the pioneers of true "green" electricity. Regardless, I hope she does not disregard the important issues discussed in item (1) of this letter. I want and need to be involved!!!

The Chamber of Mines of Eastern British Columbia is a not for profit organization with over 100 members devoted to supporting and advocating the interests of our members and exploration industry.

We are writing today to express our concerns and offer solutions regarding permitting and bonding for mining and exploration in British Columbia. Permitting and bonding for the exploration and mining industry needs to be consistent and realistic in order to create a feasible work program and to acquire investment capital.

Our primary concern is the length of time it takes to obtain a work permit. Some individuals have had wait times in excess of a year. The duration of time is detrimental to Junior mining companies and individual prospectors alike. In our region many of the mining camps are above 1200M altitude which only allows in some cases 4 month access due to snow pack. When a permit is delayed during the accessible months, the opportunity can be lost. We live in an environment susceptible to wild fires, landslides, avalanches and flooding. We need to be able to work when conditions allow.

Investors have been diverting money from mining and exploration in our district. Time delays and excessive bonding rates are adding to the current environment of uncertainty in our region.

With the increased use of minerals in new technology, the world's supply of raw materials will not be adequate to fulfill the needs of manufacturers which currently source materials from "not so desirable" sources such as the Congo and China who have practices which are harmful to the environment and its human population.

British Columbia has the opportunity to be a world leader as we have the highest environmental and reclamation standards in the world. It can take 3 to 10 times the required amount of minerals to produce an electric vehicle compared to a conventional vehicle. In order to meet this demand many more exploration projects need to be permitted.

We recommend the following improvement to the permitting process.

 Government persons who are working on the permit should be more educated in the sphere of exploration and there should be more training for personnel who administrate permits.

- Realistic and reasonable bonding amounts based on set variables incorporated into an automatic computer generated system that will speed up the process. A process such as this could potentially reduce the number of permitting officers and increase the amount of mines inspectors.
- In an age of being able to stake claims online we should have an automatic system for bonding and permitting which then can be reviewed and inspected if so desired/required.

We would be more than happy to host a meeting with all agencies and departments involved in the permitting and bonding. To provide constructive suggestions and come to solid resolutions which will enhance the certainty of investment in British Columbia.

We thank you very much for your time and attention and we look forward to your response.
