British Columbia has a wealth of minerals and metals that are needed for electric cars, wind turbines and transit systems to support a global movement towards a low carbon future. It's because of exploration groups like yours that we are able to make new mineral discoveries to meet the growing demand for minerals that are the foundation of the green energy economy.

We are building on British Columbia's strengths to champion a stronger economy. The Mining Journal's 2017 World Risk Report awarded British Columbia the title of least risky jurisdiction in the world for investments in mining projects. In fact, our province is also one of the only seven jurisdictions to be AAA-rated on the Mining Journal's 2017 World Risk Report Investment Risk Index of the 85 jurisdictions it reviewed.

With global commodity prices rising, British Columbia's mineral exploration sector is improving and there are signs of a turnaround as investment capital increases.
