- Yesterday, I attended the Council of Ministers Responsible for Transportation and Highway Safety, held in Montreal.

- This was an important meeting to engage the voices of ministers across the country to find solutions for moving forward with strategies for a greener future.
- As the B.C. representative, I was able to share with my colleagues there some of the strides that our province has made.
- The province launched the CleanBC strategy in December 2018. The strategy puts B.C. on the path to a cleaner, better future – with a low-carbon economy that creates opportunities for all while protecting our clean air, land and water.
- Part of the strategy includes launching a Zero Emissions Vehicle (ZEV) standard to require automakers to meet an escalating annual percentage of new light-duty ZEV sales and leases reaching 10% by 2025, 30% by 2030 and 100% by 2040, with a supporting plan to expand infrastructure and make them more affordable.
- I look forward to seeing how these conversations evolve as we continue them in the future.
