In 2018, we launched an Annual Review of the Standards of Conduct and Oath of Employment e-module. To support this requirement, the Public Service Agency developed a mandatory *Annual Review of the Standards of Conduct and Oath of Employment e-module*. The course should be successfully completed before **May 31, 2019**, and annually thereafter. Ministries can determine the best time to complete the annual reviews.

New employees hired after June 1, 2018 do not have to complete the annual review in the 2018-19 cycle as they will go through the standard onboarding process of signing the Standards of Conduct Acknowledgement and swearing the Oath of Employment.

Please discuss the importance of the annual review with your teams to ensure employees understand how the Oath of Employment and Standards of Conduct relate to their day-to-day work.

If you have any questions, please connect with your ministry ethics advisor. As ambassadors for good ethics management, they are equipped to provide advice on ethical issues, assess issues and access further resources and support.
