Doug Underhill, Manager, Forest Hydrology and Infrastructure with TimberWest, and Jason Carvalho, Project Manager with Couverdon Real Estate, facilitated the inspection and lead the tour.

Geotechnical Inspector

Valentine Mountain is an exploration site near Sooke, BC. At least two bulk samples were processed onsite; a ~650 t sample by Valentine Gold in 1988 and a ~65 t sample by Beau Pre in 1998. Geotechnical infrastructure includes a tailings storage facility and bulk sample trenches. The inspection tour included the following locations:

- Tailings Storage Facility (TSF),
- Mill Site, and
- Trenches.

The following documents were referenced as part of the inspection preparation and follow-up:

- "Tailings Impoundment Construction Report Valentine Mountain Project" dated December 1, 1987 by Peter Peart, P.Eng., Consulting Geotechnical Engineer.
- "Initial Geotechnical Assessment Tailings Pond, Valentine Mine, Valentine Mountain Au Deposit, Sooke, BC" dated December 23, 2003 by Jacques Whitford Environmental Consulting Limited (Jacques Whitford).
- "Decommissioning and Reclamation Plan Tailings Pond, Valentine Mine, Valentine Mountain Au Deposit, Sooke, BC" dated January 12, 2004 by Jacques Whitford.
- "Valentine Mountain Property Preliminary Geotechnical Evaluation of Tailings Dam" dated November 30, 2010 Thurber Engineering Ltd. (Thurber).
- "Valentine Mountain Mine Tailings Disposal Facility 2014 Dam Safety Inspection" dated December 1, 2014 by Thurber.

At the time of inspection, the weather was overcast, lightly raining and ~10°C. All areas of interest were visible and accessible.

Preamble

The purpose of this inspection was to:

- Assess whether the Mine is meeting the intent of the geotechnical requirements of the Code;
- Assess whether the Mine is meeting the intent of the geotechnical conditions in its Mine Permit;
- Assess whether geotechnical engineering practices at the Mine are generally consistent with accepted practices at mines in British Columbia; and,
- Provide general comment on geotechnical conditions at the mine.

This report is governed by the conditions and limitations set forth in the Mines Act and Code. This report is based on a review of select reports and work areas at the Mine, and cannot practically cover the entire mine site. Professional reliance has been used throughout this inspection.

Please note EMPR expects that all written recommendations made by a Professional Engineer, relating to geotechnical stability affecting health, safety, or environment, are followed by the Mine unless a suitable alternative written recommendation is provided by a Professional Engineer.

This report summarizes EMPR's observations, comments, and recommendations based on the Mine site tour, preliminary review of annual geotechnical reports, and technical discussions with Mine staff. If required, inspection orders have been issued. For ease of reference the Mine Manager is asked to respond in red text in the space provided below each inspection order and information request.

Dated: November 21, 2018

Location: Tailings Storage Facility

The TSF is a side-hill impoundment, consisting of a single embankment. The embankment was constructed to its current elevation in 1987. The embankment has not been raised or otherwise modified since its original construction. The embankment has a maximum height of 9 m, crest width of 6 m, downstream slope of ~1.33H:1V and upstream slope of ~2H:1V. The upstream till zone is separated from the supporting downstream rip rap by a geotextile. Rip rap is located along the upstream embankment face and at the embankment crest, extending 0.5 m above the till. There is an underdrain system within the facility consisting of perforated pipe running parallel to the embankment along the upstream toe, connected to a solid pipe passing through the dam at the maximum dam height. The downstream outlet has a cap and the pipe has a pressure gauge at the downstream side.

The 2014 Dam Safety Inspection (DSI) noted that a leak in the underdrain system pressure gauge developed or increased in flowrate between 2010 and 2014. Photos from the 2014 DSI depict a lower flowrate than was observed during the inspection, and it was noted by the inspection facilitators that the underdrain system flowrate had increased since July 2018. A photo of the flow during the inspection is included as Photo 2. Boulders had been placed over the underdrain system outlet pipe, so the condition of the outlet and the source of the flows (pressure gauge, end of pipe, and/or area surrounding the pipe) could not be identified (Photo 3).

The TSF is estimated to have ~ 1 m of freeboard, although there is no measuring device on site to confirm this approximation. Water was discharging through the spillway, and vegetation is growing in the spillway (Photo 4).

A slump in the downstream face of the embankment near the left abutment was documented in 2003, 2010, and 2014 (Jacques Whitford, 2003; Thurber, 2010; Thurber, 2014). The slump did not appear to increase in size between 2010 and 2014 (Thurber, 2014). The slump has not been repaired and was visible during the inspection.

An order under *Mines Act* Section 15(5) was issued November 16, 2018 to address concerns related to the underdrain system and outlet, and spillway. The November 16, 2018 order is attached and must be considered along with this inspection report.

Review of EMPR files indicate the mine is out of compliance with numerous Part 10 Code sections, including the following:

- Section 10.1.13 Quantifiable Performance Objectives
 - Quantifiable Performance Objectives have not been determined and reviewed by the EoR and TSF Qualified Person (QP).
- Section 10.4.1 Updated Plans
 - Mine plans, reclamation and closure plans, and water balance and water management plans have not been updated.
- Section 10.4.2 Governance
 - The Mine Manager has not
- Section 10.4.3 Register of Tailings Storage Facilities and Dams
 - The Mine Manager has not:
 - Developed and maintained a Tailings Management System,
 - Designated a TSF QP,
 - Established an Independent Tailings Review Board (ITRB),
 - Completed an annual review of the TSF risk assessment,
 - Maintained TSF emergency preparedness and response plans,

- Section 10.4.4 Annual Reporting
 - The Mine Manager has not submitted the following annual reporting:
 - DSIs completed,
 - Report of ITRB activities, and
 - Summary of TSF and dam safety recommendations, including a scheduled completion date.
- Section 10.5.2 Operations, Maintenance and Surveillance (OMS) Manual
 - o An OMS manual has not been prepared.
- Section 10.5.3 Annual Dam Safety Inspection
 - A DSI has not been completed since 2014.

Further, EMPR notes several engineering recommendations provided by Jacques Whitford (2003) and Thurber (2010, 2014) relating to geotechnical stability were not completed. As indicated in the preamble, EMPR expects that all written recommendations made by a Professional Engineer, relating to geotechnical stability affecting health, safety, or environment, are followed by the Mine unless a suitable alternative written recommendation is provided by a Professional Engineer.

The mine is out of compliance with Sections 10.1.5, 10.1.7, 10.1.11, 10.1.13, 10.4.1, 10.4.2, 10.4.3, 10.4.4, 10.5.2, and 10.5.3 of the Code.

Remedial Action/Results To Be Obtained:

The Mine shall prepare and submit a detailed work plan to address the Code requirements to which the Mine is out of compliance. The work plan shall be completed to the satisfaction of the Chief Inspector. The work plan shall include specific activities, deliverables, timelines and milestones to achieve compliance with the Code.

Location: Mill Site

The mill site includes four shelters/containers in various states of disrepair, a small ball mill and milling supplies (i.e. balls). None of the shelters/containers are locked and all are easily accessible. One container contains core boxes, with open core boxes laid out on the ground in front of the container (Photo 5).

Location: Trenches

The trenches are located east of the Mill Site, along an overgrown road. These linear excavations are overgrown and water has accumulated in the low spots (Photo 6). Some iron staining was visible. The tour facilitators indicated the trenches visited were the largest trenches; there are additional, smaller trenches on site which were not inspected.



Re: Order under Mines Act Section 15(5) for the Valentine Mountain Tailings Storage Facility

A geotechnical inspection of the Valentine Mountain Tailings Storage Facility (MX-8-21) was conducted on November 14, 2018 by Alexis McPherson, M.Sc., P.Eng., with the Ministry of Energy and Mines and Petroleum Resources (EMPR), accompanied by Jim Dunkley, P.Geo., Regional Permitting Inspector with EMPR. Doug Underhill, Manager, Forest Hydrology and Infrastructure with TimberWest, and Jason Carvalho, Project Manager with Couverdon Real Estate, facilitated the inspection and lead the tour.

There were two areas of immediate concern identified during the inspection. The first was the rate of discharge for the underdrain system outlet. Photos from the 2014 Dam Safety Inspection (DSI) by Thurber demonstrate a lower flowrate than was observed during the inspection, and it was noted by the inspection facilitators that the underdrain system discharge flowrate has increased since July 2018. Since the 2014 DSI large boulders were placed over the underdrain system outlet pipe, so the condition of the outlet could not be verified. The second was the spillway. The tailings storage facility pond is estimated to have ~1 m of freeboard, although there is no measuring device on site to confirm this approximation. Water was discharging through the spillway, and vegetation growing in the spillway is reducing capacity.

These areas of concerns were identified in the 2014 DSI¹ text and recommendations, as demonstrated by the following excerpts:

"Inclusion of the underdrain system is a serious design flaw in our opinion...Should this pipe rupture or develop a significant leak, it could result in a dam breach by means of a piping failure."

"Although it does not appear that any leakage is occurring along the underdrain outlet pipe that passes through the dam at its highest point, the pressure gauge located at the outlet is leaking. The

development of a significant leak in, or the rupture of, the underdrain pipe probably represents the most likely failure mode for the impoundment. A remediation plan should be developed to address this risk.

"A response plan should be developed to address the possible increase in leakage from the outlet pipe over time."

"Vegetation must not be allowed to become re-established on the dam or along the spillway channel..."

Based on EMPR's recent geotechnical inspection, conditions which were raised as concerns in the 2014 DSI have not been addressed by the Permittee and have worsened since the 2014 DSI report was issued. Please note that EMPR expects all written recommendations made by a Professional Engineer, relating to geotechnical stability affecting health, safety, or environment, are followed by the Mine unless a suitable alternative written recommendation is provided by a Professional Engineer.

EMPR considers these conditions to represent a significant risk, and requires the facility be immediately assessed by a Professional Engineer. EMPR is thereby issuing the following order to take immediate remedial action.

Order 1:

Observation of contravention:

Pursuant to Mines Act Section 15(5)(a):

"If an inspector is of the opinion that a delay in remedying a hazard would be dangerous to persons or property, the inspector may issue an order for immediate remedial action."

Remedial Action/Results to Be Obtained:

The Mine shall engage a Professional Engineer to conduct a risk assessment of the Valentine Mine tailings storage facility and prepare an assessment report containing recommendations for any remedial work required to mitigate the risks and monitoring requirements. The report shall be submitted to the satisfaction of the Chief Inspector and shall be accompanied by a letter of commitment from the Mine Manager to address the recommendations with a proposed schedule. The risk assessment shall include, but not be limited to, the following items of concern:

- Underdrain system and outlet, and
- Spillway.

Rectify By:

A Professional Engineer shall visit the site by November 21, 2018. The assessment report and accompanying letter of commitment shall be submitted no later than November 26, 2018.

This letter includes the areas of immediate concern identified during the inspection. A complete inspection report will follow.

I write on behalf of Great Thunder Gold Corp. ("Great Thunder") to appeal the Geotechnical and Permitting Orders issued under the Mines Act, dated November 16, 21 and 22, 2018 (the "Orders"), which require Great Thunder to conduct various assessments, work and reports with respect to the Valentine Mountain pond. For ease of reference, the Orders are attached to this letter, as well as our correspondence with your inspectors.

Relief Sought

Great Thunder respectfully requests that you immediately suspend all of the Orders against Great Thunder. While you consider this appeal, Great Thunder respectfully requests that you stay the Orders pending the outcome of your decision.

Basis for Appeal

Below we briefly lay out the basis for this appeal. On your direction regarding the appeal process, we can provide further submissions to support this appeal.

In short, Great Thunder has been adversely affected by the Orders, which should not have been issued to Great Thunder because Great Thunder is not responsible for the Valentine Mountain pond.

Great Thunder Did Not Construct the Valentine Mountain Pond

Great Thunder did not construct the Valentine Mountain pond. The Valentine Mountain pond was constructed long before Great Thunder commenced its exploration at the site. Further, Great Thunder

has never conducted any bulk sampling at the Valentine Mountain site, nor has it ever manipulated or added anything to the Valentine Mountain pond. Put simply, Great Thunder's activities at the Valentine Mountain site have been and are limited to those authorized pursuant to its exploration permit.

Great Thunder's Exploration Permit Does Not Impose Responsibility for the Valentine Mountain Pond Great Thunder's mine permit authorizes Great Thunder's limited exploration activities at the site, but does not impose any responsibility for the Valentine Mountain pond.

In 2010, Mill Bay Ventures Inc. (Great Thunder's name before 2013), acquired mine permit MX-8-21, which covers the Valentine Mountain exploration project. There are no conditions under the original version of MX-8-21, or in any subsequent amendments, that place any responsibility over the Valentine Mountain pond on the MX-8-21 permit holder. Concurrently, Mill Bay did not accept any responsibility for the Valentine Mountain pond when it acquired the mine permit.

Great Thunder is Not the Subject Land Owner and Great Thunder Does Not Hold the Water Licence Great Thunder does not own the subject land, nor does Great Thunder hold a water licence for the Valentine Mountain pond. Conversely, TimberWest owns the land and holds the sole water licence issued for the Valentine Mountain pond (i.e. Conditional Water Licence C72277).

Importantly, TimberWest's water licence includes the following conditions:

- "The works authorized to be constructed are dam and reservoir, which shall be located approximately as shown on the attached plan." (h)
- "The dam and reservoir authorized under clause (h) of this licence shall be maintained to the satisfaction of the Engineer under the Water Act." (i)
- "The construction of the said works has been completed and the water is being beneficially used."

 (i)

In addition to owning the subject lands and holding the only water licence for the Valentine Mountain pond, TimberWest is an "owner" under the Dam Safety Regulation. As an "owner" under that Regulation, TimberWest is subject to certain requirements, such as maintaining and exercising reasonable care to avoid the risk of significant harm at the Valentine Mountain pond.

Notably, TimberWest recently dumped boulders on the underdrain system outlet pipe of the Valentine Mountain pond, which created the current conditions identified in the geotechnical inspections associated with the Orders. TimberWest carried out these activities on its own accord, without any involvement of Great Thunder.

Closing

In sum, Great Thunder should not be the subject of the Orders.

Great Thunder's mine permit MX-8-21 authorizes Great Thunder's limited exploration efforts, but does not impose responsibility for the Valentine Mountain pond. Further, Great Thunder:

- did not construct, manipulate or add anything to the Valentine Mountain pond;
- has never held any authorization for the Valentine Mountain pond;
- does not and has never owned the land on which the Valentine Mountain pond is located; and

• is not a party responsible for carrying out any repair, maintenance or removal of the Valentine Mountain pond pursuant to the applicable legislation.

As such, Great Thunder respectfully requests that you exercise your powers under section 33 of the Mines Act and immediately suspend the operation of all of the Orders. While you consider this appeal, Great Thunder respectfully requests that you stay the Orders pursuant to your powers under section 33 of the Mines Act.

We appreciate your prompt consideration of this appeal. Please let us know if you require more information or if you have further direction on the process for hearing this appeal.

Re: Order under Mines Act Section 15(5) for the Valentine Mountain Tailings Storage Facility

A geotechnical inspection of the Valentine Mountain Tailings Storage Facility (MX-8-21) was conducted on November 14, 2018 by Alexis McPherson, M.Sc., P.Eng., with the Ministry of Energy and Mines and Petroleum Resources (EMPR), accompanied by Jim Dunkley, P.Geo., Regional Permitting Inspector with EMPR. Doug Underhill, Manager, Forest Hydrology and Infrastructure with TimberWest, and Jason Carvalho, Project Manager with Couverdon Real Estate, facilitated the inspection and lead the tour.

There were two areas of immediate concern identified during the inspection. The first was the rate of discharge for the underdrain system outlet. Photos from the 2014 Dam Safety Inspection (DSI) by Thurber demonstrate a lower flowrate than was observed during the inspection, and it was noted by the inspection facilitators that the underdrain system discharge flowrate has increased since July 2018. Since the 2014 DSI large boulders were placed over the underdrain system outlet pipe, so the condition of the outlet could not be verified. The second was the spillway. The tailings storage facility pond is estimated to have ~1 m of freeboard, although there is no measuring device on site to confirm this approximation. Water was discharging through the spillway, and vegetation growing in the spillway is reducing capacity.

These areas of concerns were identified in the 2014 DSI¹ text and recommendations, as demonstrated by the following excerpts:

"Inclusion of the underdrain system is a serious design flaw in our opinion...Should this pipe rupture or develop a significant leak, it could result in a dam breach by means of a piping failure."

"Although it does not appear that any leakage is occurring along the underdrain outlet pipe that passes through the dam at its highest point, the pressure gauge located at the outlet is leaking. The

development of a significant leak in, or the rupture of, the underdrain pipe probably represents the most likely failure mode for the impoundment. A remediation plan should be developed to address this risk.

"A response plan should be developed to address the possible increase in leakage from the outlet pipe over time."

"Vegetation must not be allowed to become re-established on the dam or along the spillway channel..."

Based on EMPR's recent geotechnical inspection, conditions which were raised as concerns in the 2014 DSI have not been addressed by the Permittee and have worsened since the 2014 DSI report was issued. Please note that EMPR expects all written recommendations made by a Professional Engineer, relating to geotechnical stability affecting health, safety, or environment, are followed by the Mine unless a suitable alternative written recommendation is provided by a Professional Engineer.

EMPR considers these conditions to represent a significant risk, and requires the facility be immediately assessed by a Professional Engineer. EMPR is thereby issuing the following order to take immediate remedial action.

Order 1:

Observation of contravention:

Pursuant to Mines Act Section 15(5)(a):

"If an inspector is of the opinion that a delay in remedying a hazard would be dangerous to persons or property, the inspector may issue an order for immediate remedial action."

Remedial Action/Results to Be Obtained:

The Mine shall engage a Professional Engineer to conduct a risk assessment of the Valentine Mine tailings storage facility and prepare an assessment report containing recommendations for any remedial work required to mitigate the risks and monitoring requirements. The report shall be submitted to the satisfaction of the Chief Inspector and shall be accompanied by a letter of commitment from the Mine Manager to address the recommendations with a proposed schedule. The risk assessment shall include, but not be limited to, the following items of concern:

- Underdrain system and outlet, and
- Spillway.

Rectify By:

A Professional Engineer shall visit the site by November 21, 2018. The assessment report and accompanying letter of commitment shall be submitted no later than November 26, 2018.

This letter includes the areas of immediate concern identified during the inspection. A complete inspection report will follow.

I write on behalf of Great Thunder Gold Corp. and to respond to your letter received late in the afternoon on Friday, November 16, 2018.

Your letter was the first time Great Thunder was informed of the November 14, 2018 inspection at the Valentine Mountain Tailings Storage Facility. As a matter of courtesy, we would expect the Ministry of Energy, Mines and Petroleum Resources ("EMPR") to notify Great Thunder of the inspection, which we now know was attended by EMPR, TimberWest and Couverdon Real Estate representatives. Great Thunder is also surprised to learn that based on this inspection, EMPR is ordering Great Thunder to have a Professional Engineer visit the site by November 21, 2018 (tomorrow) and prepare an assessment report and accompanying letter of commitment by November 26, 2018. Logistically, there is simply not enough time for Great Thunder to retain and arrange access for a Professional Engineer to attend the site by tomorrow and subsequently prepare an assessment report and letter of commitment by November 26, 2018.

Although Great Thunder is fully committed to complying with its Mines Act permits, Great Thunder needs time to consider its legal obligations and we request that EMPR provide us further information and rationale for issuing the order against Great Thunder. We also understand from Mr. Dunkley's email yesterday that EMPR is considering further orders against Great Thunder. Respectfully, we request that EMPR hold off from issuing these orders until after we have a chance to discuss these matters with you.

Introduction

A geotechnical inspection of the Valentine Mountain Site was conducted on November 14, 2018 by Alexis McPherson, M.Sc., P.Eng., Geotechnical Inspector with the Ministry of Energy, Mines and Petroleum Resources (EMPR), accompanied by Jim Dunkley, P.Geo., Regional Permitting Inspector with EMPR. Mr. Dunkley's report is issued under separate cover. Doug Underhill, Manager, Forest Hydrology and Infrastructure with TimberWest, and Jason Carvalho, Project Manager with Couverdon Real Estate, facilitated the inspection and lead the tour.

Alexis McPherson, M.Sc., P.Eng. Geotechnical Inspector Dated: September 21, 2018

Valentine Mountain is an exploration site near Sooke, BC. At least two bulk samples were processed onsite; a ~650 t sample by Valentine Gold in 1988 and a ~65 t sample by Beau Pre in 1998. Geotechnical infrastructure includes a tailings storage facility and bulk sample trenches. The inspection tour included the following locations:

- Tailings Storage Facility (TSF),
- Mill Site, and
- Trenches.

The following documents were referenced as part of the inspection preparation and follow-up:

- "Tailings Impoundment Construction Report Valentine Mountain Project" dated December 1, 1987 by Peter Peart, P.Eng., Consulting Geotechnical Engineer.
- "Initial Geotechnical Assessment Tailings Pond, Valentine Mine, Valentine Mountain Au Deposit, Sooke, BC" dated December 23, 2003 by Jacques Whitford Environmental Consulting Limited (Jacques Whitford).
- "Decommissioning and Reclamation Plan Tailings Pond, Valentine Mine, Valentine Mountain Au Deposit, Sooke, BC" dated January 12, 2004 by Jacques Whitford.
- "Valentine Mountain Property Preliminary Geotechnical Evaluation of Tailings Dam" dated November 30, 2010 Thurber Engineering Ltd. (Thurber).
- "Valentine Mountain Mine Tailings Disposal Facility 2014 Dam Safety Inspection" dated December 1, 2014 by Thurber.

At the time of inspection, the weather was overcast, lightly raining and ~10°C. All areas of interest were visible and accessible.

Preamble

The purpose of this inspection was to:

- Assess whether the Mine is meeting the intent of the geotechnical requirements of the Code;
- Assess whether the Mine is meeting the intent of the geotechnical conditions in its Mine Permit;
- Assess whether geotechnical engineering practices at the Mine are generally consistent with accepted practices at mines in British Columbia; and,
- Provide general comment on geotechnical conditions at the mine.

This report is governed by the conditions and limitations set forth in the Mines Act and Code. This report is based on a review of select reports and work areas at the Mine, and cannot practically cover the entire mine site. Professional reliance has been used throughout this inspection.

Please note EMPR expects that all written recommendations made by a Professional Engineer, relating to geotechnical stability affecting health, safety, or environment, are followed by the Mine unless a suitable alternative written recommendation is provided by a Professional Engineer.

This report summarizes EMPR's observations, comments, and recommendations based on the Mine site tour, preliminary review of annual geotechnical reports, and technical discussions with Mine staff. If required, inspection orders have been issued. For ease of reference the Mine Manager is asked to respond in red text in the space provided below each inspection order and information request.

Location: Tailings Storage Facility

The TSF is a side-hill impoundment, consisting of a single embankment. The embankment was constructed to its current elevation in 1987. The embankment has not been raised or otherwise modified since its original construction. The embankment has a maximum height of 9 m, crest width of 6 m, downstream slope of ~1.33H:1V and upstream slope of ~2H:1V. The upstream till zone is separated from the supporting downstream rip rap by a geotextile. Rip rap is located along the upstream embankment face and at the embankment crest, extending 0.5 m above the till. There is an underdrain system within the facility consisting of perforated pipe running parallel to the embankment along the upstream toe, connected to a solid pipe passing through the dam at the maximum dam height. The downstream outlet has a cap and the pipe has a pressure gauge at the downstream side.

The 2014 Dam Safety Inspection (DSI) noted that a leak in the underdrain system pressure gauge developed or increased in flowrate between 2010 and 2014. Photos from the 2014 DSI depict a lower flowrate than was observed during the inspection, and it was noted by the inspection facilitators that the underdrain system flowrate had increased since July 2018. A photo of the flow during the inspection is included as Photo 2. Boulders had been placed over the underdrain system outlet pipe, so the condition of the outlet and the source of the flows (pressure gauge, end of pipe, and/or area surrounding the pipe) could not be identified (Photo 3).

The TSF is estimated to have ~ 1 m of freeboard, although there is no measuring device on site to confirm this approximation. Water was discharging through the spillway, and vegetation is growing in the spillway (Photo 4).

A slump in the downstream face of the embankment near the left abutment was documented in 2003, 2010, and 2014 (Jacques Whitford, 2003; Thurber, 2010; Thurber, 2014). The slump did not appear to increase in size between 2010 and 2014 (Thurber, 2014). The slump has not been repaired and was visible during the inspection.

An order under Mines Act Section 15(5) was issued November 16, 2018 to address concerns related to the underdrain system and outlet, and spillway. The November 16, 2018 order is attached and must be considered along with this inspection report.

Review of EMPR files indicate the mine is out of compliance with numerous Part 10 Code sections, including the followina:

 - o An Engineer of Record (EoR) has not be retained.
- Section 10.1.7 Consequence Classification
 - o The EoR has not confirmed the consequence classification.

 - Quantifiable Performance Objectives have not been determined and reviewed by the EoR and TSF Qualified Person (QP).
- Section 10.4.1 Updated Plans
 - Mine plans, reclamation and closure plans, and water balance and water management plans have not been updated.
- Section 10.4.2 Governance
 - The Mine Manager has not
- Section 10.4.3 Register of Tailings Storage Facilities and Dams
 - The Mine Manager has not:
 - Developed and maintained a Tailings Management System,
 - Designated a TSF QP,
 - Established an Independent Tailings Review Board (ITRB),
 - Completed an annual review of the TSF risk assessment,
 - Maintained TSF emergency preparedness and response plans,

- Section 10.4.4 Annual Reporting
 - o The Mine Manager has not submitted the following annual reporting:
 - DSIs completed,
 - Report of ITRB activities, and
 - Summary of TSF and dam safety recommendations, including a scheduled completion date.
- Section 10.5.2 Operations, Maintenance and Surveillance (OMS) Manual
 - o An OMS manual has not been prepared.
- Section 10.5.3 Annual Dam Safety Inspection
 - o A DSI has not been completed since 2014.

Further, EMPR notes several engineering recommendations provided by Jacques Whitford (2003) and Thurber (2010, 2014) relating to geotechnical stability were not completed. As indicated in the preamble, EMPR expects that all written recommendations made by a Professional Engineer, relating to geotechnical stability affecting health, safety, or environment, are followed by the Mine unless a suitable alternative written recommendation is provided by a Professional Engineer.

Order 1:

Observation of Contravention:

The mine is out of compliance with Sections 10.1.5, 10.1.7, 10.1.11, 10.1.13, 10.4.1, 10.4.2, 10.4.3, 10.4.4, 10.5.2, and 10.5.3 of the Code.

Remedial Action/Results To Be Obtained:

The Mine shall prepare and submit a detailed work plan to address the Code requirements to which the Mine is out of compliance. The work plan shall be completed to the satisfaction of the Chief Inspector. The work plan shall include specific activities, deliverables, timelines and milestones to achieve compliance with the Code.

Location: Mill Site

The mill site includes four shelters/containers in various states of disrepair, a small ball mill and milling supplies (i.e. balls). None of the shelters/containers are locked and all are easily accessible. One container contains core boxes, with open core boxes laid out on the ground in front of the container (Photo 5).

Location: Trenches

The trenches are located east of the Mill Site, along an overgrown road. These linear excavations are overgrown and water has accumulated in the low spots (Photo 6). Some iron staining was visible. The tour facilitators indicated the trenches visited were the largest trenches; there are additional, smaller trenches on site which were not inspected.

We write in response to your letter and order received on November 16, 2018 and to the geotechnical and permitting inspection reports received on November 22, 2018 and in furtherance to our telephone meeting of November 22, 2018.

As discussed in our meeting and addressed in our letter dated November 21, 2018, Great Thunder Gold Corp. ("Great Thunder") cannot meet the timelines issued under the November 16, 2018 order. We understand from our meeting that the Ministry of Energy, Mines and Petroleum Resources ("EMPR") acknowledges the difficulty posed by these extremely tight timelines, and that EMPR is willing to work with Great Thunder to determine an appropriate schedule for the assessment contemplated under the order. We also understand from our meeting that the priority focus for EMPR is to have an engineer assess the water flowing from the underdrain system outlet. As discussed in the meeting, Great Thunder cannot have an engineer assess this area until we secure access from TimberWest and TimberWest removes the boulders that they placed over the outlet. We understand that TimberWest would like to have Great Thunder's engineer present for the boulder removal. This will of course depend on when TimberWest plans to do this work and whether Great Thunder can find and retain an appropriate engineer in time. In that regard, Great Thunder has already contacted a few engineers to see if they have the requisite expertise and capacity to conduct an assessment of the underdrain system and is now waiting to hear back about their schedules. We expect to have more information regarding timing today or in the coming days. In the interim, please confirm that the dates contemplated under the November 16, 2018 order are

under review pending the above and that Great Thunder will not be deemed non-compliant for not meeting the November 26, 2018 deadline (the original deadline for Great Thunder to submit the assessment report and accompanying letter of commitment).

As indicated above, given EMPR's immediate concerns regarding the underdrain system outlet, Great Thunder is committed to conducting the above noted assessment on a good faith basis. This, however, cannot be taken as an acknowledgment by Great Thunder that Great Thunder holds primary or any responsibility for the dam or tailings facility. As indicated in the meeting, we remain concerned regarding EMPR's expectations of Great Thunder pursuant to its exploration permit MX-8-21. Prior to making any further commitments to undertake work at the dam or tailings facility, Great Thunder requests EMPR provide its position and support thereof regarding Great Thunder's responsibilities under its exploration permit and the interplay between that permit, TimberWest's Conditional Water Licence C72277 and any other authorization obtained for the actual construction of the dam and tailings facility (if any). As EMPR is aware, Great Thunder's involvement with the site began in 2008 and has been limited to very minor exploration activities. At no time did Great Thunder use, add to or manipulate the dam or tailings facility in any way. Accordingly, Great Thunder would appreciate some clarity from EMPR as to who is responsible for the various past, current and future activities involving the dam and tailings facility. Until this threshold issue is resolved, Great Thunder requests that EMPR confirm in writing that it will place the less immediate requirements under the orders on hold.

We appreciate your consideration of the above.

Thank you for your emails. We continue to look for an engineer to attend the site to assess the underdrain system to address EMPR's immediate concerns at the site. To date, we have contacted four engineers, three of whom (including Thurber Engineering) have stated that they will not or cannot do the work under the deadlines. One is reviewing the various reports and we expect to hear early next week whether they can assist. In addition, we have reached out to two other engineers. We will continue to update you regarding our search.

As a general comment, your responses from your email of 3:39 p.m. Wednesday (below) do not satisfy our inquiries and we would appreciate further consideration of our November 26, 2018 letter given the scope and deadlines imposed in EMPR's orders.

More specifically, in response to items #2, 3 and 4 (below), Jim Dunkley provided only one letter since our last meeting. That February 11, 2010 letter does not address our concerns. That letter simply states that Great Thunder "... is responsible for all milling equipment, etc. located on the said tenure [506801]." This does not address who is responsible for the separate dam and tailings facility located on tenures 549331 and 549333, nor does it clarify EMPR's position regarding Great Thunder's responsibilities under its exploration permit. Further, it does not respond to our request for EMPR's position regarding the interplay between Great Thunder's exploration permit, TimberWest's water licence and any other authorization issued for the actual construction of the dam and tailings facility.

As you know, TimberWest holds the water licence, which authorized the construction of the dam and reservoir and required TimberWest to maintain same. TimberWest is also the land owner. Both of these facts make TimberWest an "owner" under the Dam Safety Regulations, which makes TimberWest subject to the requirements of an "owner" thereunder including the maintenance and exercise of reasonable care to avoid the risk of significant harm. Of course, part of these responsibilities includes removing the boulders that were placed on the underdrain system by TimberWest. In this regard, we trust that you are in constant contact with FLNRO with respect to these matters that fall within FLNRO's jurisdiction. Accordingly, we would appreciate an update with regards to the FLNRO/EMPR coordinated approach to the site, which would help to clarify our inquiries.

We would appreciate a prompt response to the aforementioned and our November 26, 2018 letter given the scope and deadlines imposed in EMPR's orders.

Alexis and Jim:

We're at a standstill with TimberWest because of their requirement that our engineer be present for the removal of the boulders that TimberWest themselves placed over the underdrain system outlet pipe. Obviously, our engineer cannot inspect the system with the boulders in place and TimberWest's availability is now weather-dependent. We would note that an engineer's presence is not a pre-condition – or an EMPR condition – to TimberWest removing their boulders.

Thank you for your Friday email, Jim.

Respectfully, your email contains errors and does not support EMPR's position that Great Thunder is responsible for the tailings pond. First, you referred to "activities ... detailed in the Notice of Work dated July 1, 2002" as a source for imposing liability on Great Thunder through MBV. That Notice of Work, however, was about proposed activities (as you acknowledge later in your email). Importantly, you overlooked that those proposed activities were never in fact conducted (as confirmed by our geologist who has been involved with the Valentine Mine project since 2003). As such, the Notice of Work was merely about a proposal that never took place and thus has no effect in the circumstances.

Second, your conclusion that Great Thunder is responsible for the tailings pond is premised on the mistaken fact that tailings from that proposed bulk sampling were deposited in the tailings pond. As indicated above, that proposal never took place. In fact, Great Thunder has never conducted any bulk sampling at the mine and has never deposited any materials or waste water in the tailings pond. As previously indicated to EMPR, since it acquired the claims in 2008, Great Thunder's work at Valentine Mountain has been limited to three small drilling programs between 2009 and 2011 totalling 21 holes and 3,783 metres on mineral tenure 506801, and soil geochemistry sampling and prospecting across the 25-claim parcel. Put simply, Great Thunder has never conducted any activities related to the tailings pond nor has it ever accepted responsibility for the tailings pond.

We are surprised that after repeated requests, your last email and attachments, and February 11, 2010 letter you sent are the extent of the support for EMPR's position. In contrast, and with all respect, you overlook the clear importance of BC legislation – the Water Sustainability Act and the Dam Safety Regulation – which expressly places responsibility for dam safety on, as in this case, the holder of the applicable water licence and on the owner of the land. That licensee/landowner is TimberWest. Your documents do not show any efforts by EMPR to ensure that FLNRO, the regulator under that legislation, has taken the requisite steps to compel TimberWest to take appropriate actions.

We understand from the Report of Inspector Mines - Geotechnical dated November 14, 2018 and received by the Company on November 22, 2018, that the November 16, 2018 order issued by Ms. McPherson must also be considered along with said Report of Inspector Mines. As indicated above, we understand from our November 22, 2018 telephone meeting that EMPR acknowledges the difficulty posed by the tight timeline set out in the order, and that EMPR is willing to work with us to determine an appropriate schedule for the assessment contemplated under the order.

Again we confirm that the priority focus for EMPR is to have an engineer assess the water flowing from the underdrain system outlet and that EMPR does not anticipate taking further action to escalate your orders as we search for an engineer qualified to evaluate the underdrain system. We also summarized above our progress on our search for an engineer qualified to assess the underdrain system outlet.

We will continue to update you on our search for engineers to conduct this work.

Closing

As a final comment, we would appreciate a response to our November 26, 2018 letter and November 30, 2018 follow up email to Ms. McPherson as it relates to the Company's overall responsibilities under its exploration permit MX-8-21.

Alexis – this is a follow up to our conference call today regarding Valentine Creek Dam/Valentine Mountain Tailings Storage Facility (structure).

This office understands that Great Thunder Gold Corp (Great Thunder) has appealed the Mines Act Orders issued in November 2018 and has not complete the ordered risk assessment of the structure that was due by November 26th 2018. The appeal is being adjudicated by the Chief Inspector of Mines at this time.

Great Thunder has indicated that they are experiencing difficulties in hiring a qualified engineering company to complete the ordered risk assessment.

This office does not normally recommend engineering companies but in this case will suggest

Bruce Musgrave, BMA Engineering (dam engineer)

Valentine Mountain Gold (mining company) built the structure on TimberWest private land. It is reported that Great Thunder removed the vegetation off the structure and TimberWest placed the rocks at the outlet of the low level pipe in this storage structure in the last few years.

The structure is holding water and tailings material at this time. The structure has two consequence classifications – significant under Mines Act and low under WSA. The difference is the impact of the tailings material in the reservoir if the structure should fail.

Both Great Thunder (current mine permit holder under Mines Act) and TimberWest (current water licence holder under Water Sustainability Act (WSA)) claim that they do not own the structure. The relationship between these companies is unknown to this office. TimberWest did confirm that they were prepared to provide equipment to complete any risk assessment studies, and are in contact with Great Thunder. This office has had no direct contact with Great Thunder on this matter.

There is typical winter weather conditions at the site at this time – full storage with saturated embankments. Access and snow conditions is unknown. This office is concerned about any major investigative digging on or near the structure at this time. Increased monitoring with emergency plan is recommended to allow for conditions to improve before undertaking any major invasive investigations of the structure.

This office will be contacting Doug Underhill and/or Steve Adams (TimberWest staff) regarding TimberWest's current position on this structure.
