



New hospital will help people in the Cowichan Valley access quality health care

NORTH COWICHAN - To provide better health care for a growing region of the province, the B.C. government has greenlit a new hospital for the Cowichan Valley.

"People who live in the Cowichan Valley have waited a long time for the hospital they deserve, and that wait will soon be over," said Premier John Horgan. "The new hospital we're announcing today will serve people in the valley for decades to come, meaning better health care in their own backyard."

The existing Cowichan District Hospital was opened in 1967, and has 134 beds. Since the hospital's opening, the valley's population has more than doubled, and is expected to grow by another 20% over the next few decades.

"Cowichan District Hospital is 50 years old. The capacity issues it faces on a daily basis are frustrating for patients and the hospital's dedicated health-care workers. It was critical that we take action," said Adrian Dix, Minister of Health. "We received a concept plan, and approved it within months, so work could get going as soon as possible, and people could have a new hospital."

In February 2018, a concept plan for the new hospital was submitted to the Ministry of Health. It was approved in June 2018, clearing the way for further work.

Construction of the new hospital is expected to begin in 2021, and is expected to be nearly triple the size of the current one.

The details, such as scope, budget and procurement method, will be finalized in the business plan stage. This stage will take approximately 12 to 18 months. Upon approval of the business plan, the project will proceed to procurement, and then to construction.

The planning for a replacement hospital has been a collaborative effort between the Government of B.C., Island Health, Cowichan Valley Regional District, Cowichan Valley Regional Hospital District, the municipalities of Duncan and North Cowichan, local First Nations and local stakeholder groups.

VICTORIA - The Government of British Columbia is taking action to support young people struggling with mental health and addiction.

To ensure that more at-risk youth in Metro Vancouver have access to the mental health and addictions services they need, the Province is working with the Dan's Legacy Foundation to add four new therapists, and expand their successful therapeutic programs.

Judy Darcy, Minister of Mental Health and Addictions, and representatives from the Dan's Legacy Foundation, made the announcement in New Westminster at Queen's Park Arena.

"Creating a mental health and addictions system of care that is seamless and connected, and that works for children and youth, and partners with Indigenous peoples, is a top priority for this government," Darcy said. "Dan's Legacy Foundation has helped hundreds of young people living with mental health and addictions challenges access the services they need to find their pathways to hope. The programs are for young people 15 to 25 years old who are at significant risk of overdose, self-harm, homelessness and suicide. Specifically, funding will be used to hire four new therapists who specialize in trauma-based mental health and addictions counselling for youth.

The funding increase is anticipated to help an additional 125 youth over the next 12 months, doubling the foundation's capacity to serve at-risk youth.

"In the past, access to services has been a big barrier for many young people who struggle with mental health and addiction challenges," said Katrine Conroy, Minister of Children and Family Development. "Funding like this means more youth and young adults in Metro Vancouver will get the types of support they need - whether it's practical tools to help them live their best life, or just having someone they can talk with who can offer guidance without judgment."

BC Hydro adds fast charging stations to its network, connecting B.C. east to west Next phase to include north-south network

VANCOUVER: BC Hydro announced today that it has completed the second phase of its electric vehicle fast charging network, allowing drivers to travel across B.C. from the Alberta border to Tofino – and the next phase will connect drivers north.

The second phase includes 28 new stations, in addition to the 30 that were completed in 2016. There are 13 new stations in the Lower Mainland and two new stations at the Britton Creek rest area on the Coquihalla Highway, allowing drivers to quickly charge up before heading to the Southern Interior – or to the Kootenays. The stations also connect drivers from Horseshoe Bay to the west coast of Vancouver Island.

BC Hydro is planning its next phase, which will connect drivers to the north from Kamloops to Prince George – and eventually to Prince Rupert.

"Our government is making zero emission transportation choices more accessible for all British Columbians," said Energy, Mines and Petroleum Resources Minister Michelle Mungall. "B.C. already has one of Canada's largest charging networks, but now motorists can travel all the way from Golden to Tofino using these new fast chargers."

BC Hydro's fast charging network can charge an electric vehicle's battery to 80 per cent in 30 minutes or less. The network is designed to provide drivers with charging options when they need them – helping reduce the 'range anxiety' many drivers feel about long road trips.

"We're very pleased to provide this network of fast chargers to encourage electric vehicle drivers to get out and explore B.C. this summer," said Chris O'Riley, BC Hydro President and Chief Operating Officer. "Electric vehicles are a great option for British Columbians looking to reduce their impact on the environment because we generate 98 per cent clean electricity. They also help lower their driving costs by around 75 per cent."

As the number of electric vehicles on B.C. roads grows, charging sessions at BC Hydro's existing stations have increased 63 per cent over the last year year. Between May 2017 and May 2018 there were over 22,000 charges at these stations. This represents around 542,000 kilometers of driving and the equivalent of approximately 138,000 kilograms in carbon dioxide emissions savings. There are currently around 9,000 electric vehicles on the road in B.C. and that number is expected to rise to 300,000 by 2030.

BC Hydro adds fast charging stations to its network, connecting east to west

Next phase to include north-south network

VANCOUVER: BC Hydro announced today that it has completed the second phase of its electric vehicle fast charging network, allowing drivers to travel across B.C. from the Alberta border to Tofino – and the next phase will connect drivers North.

The completed second phase includes 27 new stations, in addition to the 30 that were completed in 2016. There are a dozen new stations in the Lower Mainland and two new stations at the Britton Creek rest area on the Coquihalla Highway allowing drivers to quickly charge up before heading north to the southern Interior or east to the Kootenay's. The new stations also allow drivers to travel from the Horseshoe Bay ferry terminal, to the west coast of Vancouver Island.

BC Hydro is planning its next phase, which will connect drivers from Kamloops north to Prince George – and eventually to Prince Rupert.

BC Hydro's fast charging network can charge an electric vehicle's battery to 80 per cent in 30 minutes or less. The network is designed to provide drivers with charging options when they need them – helping reduce the 'range anxiety' many drivers feel about long road trips.

"We're very pleased to provide this network of fast chargers to encourage electric vehicle drivers to get out and explore B.C. this summer," said Chris O'Riley, BC Hydro President and Chief Operating Officer. "Electric vehicles are a great option for British Columbians looking to reduce their impact on the environment because we generate 98 per cent clean electricity, and lower their driving costs by around 75 per cent."

As the number of electric vehicles on B.C. roads grow, charging sessions at BC Hydro's existing stations have increased 63 per cent in a year. Between May 2017 and May 2018 there were over 22,000 charges at these stations – which represents around 542,000 kilometers of driving and the equivalent of approximately 138,000 kilograms in carbon dioxide emissions savings. There are

currently around 9,000 electric vehicles on the road in B.C. and that number is expected to rise to 300,000 by 2030.

BC Hydro has been installing charging stations throughout the province since 2012 with support from the provincial and federal governments and in partnership with municipalities, regional districts and others, like Loblaw's and accelerate Kootenays. The completed phase two stations include:

Emails and phone calls go unanswered for weeks or months. You will find all of this documented in the submission.

How can the BCOGC in good conscience grant a permit with so many outstanding unresolved issues? We have not heard from anyone at that office concerning this submission.

Who advocates for the landowners? Where do we go for unbiased help? Please at least have someone read the list of problems and have a discussion with us.

With BC being a green province, I would hope that we can get some feedback from someone please before CNRL are granted their "slam dunk"

We look forward to hearing from one of your offices. We are running out of time to alter the path of the proposal.

The SOP was designed for small BC developers to have access to a market. BC Hydro accepted projects into the Standing Offer Program and allocated Commercial Operations Dates, electricity prices and GWh they would purchase. These small local companies have spent millions of dollars to get into the queue and have spent millions more since. They have been providing work within communities that have projects and across the wider consulting industry in BC. BC Hydro putting the negotiation of EPAs "on hold" is having serious repercussions on these projects, on the owners, on the consulting industry working on projects, on First Nations involved with the projects and on local communities who are expecting both economic and employment opportunities to arise from them. It is impacting over one third of a billion dollars of investment capital allocated to be spent in BC. It is also impacting future procurement that could happen in BC as the uncertainty created by the "hold" is moving BC into the rank of a high risk investment jurisdiction.

Here are just a few things our government announced this week:

Province releases Employer Health Tax implementation details

- For over a decade, British Columbia has been the only province to maintain MSP fees. We are eliminating MSP premiums and introducing the Employer Health Tax (EHT), a more progressive system that will put money back into the pockets of British Columbians.
- The Ministry of Finance has released an Employer Health Tax (EHT) tax notice, as part of the next steps toward the elimination of Medical Services Plan (MSP) premiums and transition to the EHT. The transition to the EHT includes funding that ensures public services will not be impacted. This includes funding for colleges and teaching universities, research universities, community-health and social-service providers, school districts and health authorities. Progress report on clean up of contaminated sites released

VICTORIA - Government is protecting the health and safety of British Columbians and the environment, by continuing to remediate contaminated sites that were abandoned by their owners.

The 2018 report on the Crown Contaminated Sites Program, released on Thursday, July 5, 2018, details work done over the past two years to investigate and remediate sites that have been contaminated by historic industrial activities.

The program has investigated a total of 87 sites, which includes 19 sites where remediation is complete and 15 sites where investigation and remediation are ongoing. Most of the sites - including mine sites - reviewed by this program were active before modern environmental standards were in place.

The report highlights the remediation of the Bralorne-Takla site, which was completed in collaboration with Takla Lake First Nation. Other highlights include the remediation of the Atlin Ruffner mill and tailings site, as well as the investigation and remediation of the former Britannia mine site.

The program, established in 2003, manages the remediation of high-risk contaminated sites on Crown land in order to protect human health and the environment. The contamination generally dates back to the previous century, when impacts of industrial development were not well managed and before current environmental standards and regulations were in place.

The Environmental Management Act ensures that those that pollute are held responsible under a polluter pay principle, so that the taxpayer does not have to assume these clean-up costs.

Quick Facts:

- * A site is contaminated if the soil, groundwater or sediment contains waste or a substance in an amount or concentration that exceeds environmental quality standards.
- * The most common contaminants found at sites include heavy metals, such as lead, arsenic, cadmium and zinc.

Quesnel residents to see Highway 97 improvements within the community

QUESNEL - Residents and visitors to the Cariboo will experience better safety and traffic flow with changes to a key intersection on Highway 97, as a result of the now-finalized Quesnel Transportation Study.

The study examined the traffic patterns and short-, medium- and long-term transportation needs for the community. As a result, the Ministry of Transportation and Infrastructure will take the following actions:

- * Reconfiguring lanes on Highway 97 at Front Street in downtown Quesnel, to improve traffic flow and pedestrian safety, and upgrading to LED lighting at the intersections of Carson, Shepherd, McNaughton and St. Laurent avenues. This work will begin in the coming weeks and finish in fall 2018.
- * Advancing design work this fall for safety improvements in the Racing Road/Hydraulic Road area of Highway 97. This project will involve consolidating access to the highway and installing a traffic signal with full-access movement along this section of highway. Additional community engagement is planned as part of this design phase.
- * Engineering work to further investigate the proposed North-South Interconnector route, which received significant support in public engagement. This will help enable the ministry to build a business case for future funding.

The comprehensive study analyzed the corridor from the Highway 97/Barkerville Highway Junction to Basalt Road in the Quesnel area. Within 14 kilometres, conditions along Highway 97 change significantly as a result of the challenging geography and adjacent land uses.

The Quesnel Transportation Study included community engagement throughout the process, with open houses in April 2017 and February 2018. The engagement results are also posted on the project website.







I have recently been given 21 days to write a response of opposition to Encana Corporations proposed Oil and Gas Project. Obviously this is not enough time for most people to respond or understand the risks of the project. I am alarmed that these multi location oil and gas projects do not fall under an Environmental Assessment. There has been no adequate baseline studies done by the proponent and there are no legal requirements for them to do so? When asked at the meeting where they were the response is they are not required.

Don't get me wrong we are not anti development but this process has many "Gaps" in regards to the impacts of both chronic exposure information to human health and the environmental impacts.

Encana has paid farmers around us a year in advance to place pipelines and made them sign non disclosure letters. The "imaginary" consultation circle leaves out a number of neighbours who will be directly impacted. At the meeting there was no technical documents no environmental documents or Emergency response plan. My family was consulted but we are not in the ERP. This is disturbing as we are talking about sour gas wells and H2S. The demographic of people at this meeting was 55 plus white farmers who wouldn't stand a chance of either responding or understanding the science. Plus we were given no information at the meeting. First Nations are not adequately informed because of Treaty 8 this is not good enough.

I urge you to stop the further proposed development in oil and gas in Dawson Creek until the correct regulations are in place. Industry needs to be required to follow best management practices for industry. There needs to be big changes to this regulatory process so due diligence is a requirement. How can you legally do hydraulic fracturing beside a drinking well and have no baseline information? We are faced with non disclosure of the chemical mixture used in hydraulic fracturing? Maybe benzene or formaldehyde? Maybe not? What is actually in this liquid? No remediation required? No follow up and ongoing monitoring How do you know where you started if you have no scientific information.

Have we not learned our lesson from minings history? The severity of impacts to human health and the environment were not fully understood initially which for example the Golden Bear mine which left unregulated and leached arsenic in to surrounding fish bearing waters. Mining has become a socially responsible industry. The Oil and Gas industry needs to be also held accountable like all other industries. We have learned already from mining that there is potential for adverse effects if we do not understand the health and environmental landscape and long term chronic impacts and legally regulate activities.

I did as much research as I could in the short amount of time I was given to respond to Encana (21 days plus a mailing time of 2 days back to Calgary) the evidence was easily found through some internet research that there is potential for this development to have severe long term impacts. The other alarming fact is the lack of understanding of the long term impacts. If I can find this information can't Encana and the Government? Why are we being reactive instead of proactive?

I look forward to a response. Please forward to the minister of health as I could not locate his email address.

Please find attached our press release regarding a new study, 'Refining Margins and BC Fuel Policy 2018' commissioned by our organization and conducted by Navuis Research. The author's Executive Summary is also attached.

Findings:

- The cost to consumers of elevated refining margins was \$2.4 billion, or \$1,730 per household between 2015 and the end of 2017. This is equivalent to an average 13 cent per litre premium on gasoline and diesel over this period for ~ 80% of BC's population
- Since 2015, both wholesale fuel prices and refining margins departed even further from underlying crude supply costs to the Vancouver market.
- These elevated refining margins and higher fuel prices appear to be the result of a lack of competition in the Vancouver fuel market, which was found to have adequate physical supply; no product shortages or scarcity pricing in this period were evident.
- A high degree of concentration in the supply of fuels, and associated barriers to bringing new fuel types into the market have contributed to artificially high prices
- Costs to consumers from elevated refiner margins in the Vancouver fuel market were five times the incremental cost of renewable and low carbon fuel regulations.
- Despite 2017 crude costs that were 15 cents per litre lower vs. those in 2010, Vancouver retail gasoline prices were 6 cents per litre higher, with 1 cent per litre of this amount coming from increased taxes.
- Policy or market responses that increase refined product or crude supplies for instance, from an expanded
 Trans Mountain pipeline or from increases in local refining capacity are unlikely to lower fuel prices as they do
 not introduce more competition into the fossil-fuel dominated market.

Elevated refining margins have been secured by fuel suppliers in BC for half a decade. To the extent that British Columbians are providing refiners with profit margins that are amongst the highest globally, we perceive that renewable and low carbon fuel regulations are an important tool to create needed competition. We also perceive that refiners

have had ample financial resources to carry additional costs of the RLCFRR, and benefitted financially from undercompliance.







VANCOUVER - As part of the Province's efforts to reduce poverty and prepare for the emerging economy, three distinguished researchers have been appointed to lead a B.C.-focused exploration of basic income.

This work relates to a commitment in the Confidence and Supply Agreement between government and the B.C. Green Party caucus.

David Green, from the Vancouver School of Economics at the University of British Columbia (UBC), will chair the expert committee. Joining him will be Jonathan Rhys Kesselman, from the School of Public Policy at Simon Fraser University, and Lindsay Tedds, from the School of Public Policy at the University of Calgary.

The committee will oversee independent research to test the feasibility of a basic-income pilot in British Columbia. It will also look at how basic-income principles might be used to improve the existing income and social-support system. The committee will also consider the impact that advances in technology and automation, and other shifts, are predicted to have on the labour market over the next several decades.

The research will also include simulations that will look at how various basic-income models work with B.C.'s population. These will identify the potential impacts and financial implications of different approaches and economic conditions on B.C. citizens.

The committee will begin work this summer, assisted by researchers at the University of British Columbia.



Hedley Bridge replacement project underway

HEDLEY - Drivers are advised to expect periodic delays on Highway 3, starting this week, while the existing bridge in Hedley is replaced with a new, two-lane structure.

A temporary two-lane detour will be put in place while the old bridge is dismantled and removed, and the new 26 metre-long structure is built.

Drivers can expect short delays throughout this work to improve safety and reliability. Temporary lane closures will also be required at times, due to paving and road work, resulting in single-lane alternating traffic.

The replacement project, which is expected to be completed by fall 2018, is taking place 29 kilometres west of Keremeos.

Dorosh Construction from Langley was awarded the \$2.3-million contract to replace the existing Hedley Bridge, which was built in the late 1940s, and was nearing the end of its serviceable life.

Drivers are reminded to obey construction speed zones, and follow traffic control signage at all times.


