I also asked Rob LeForte for more details on what they wanted to discuss specifically. Here was his response:

For the whole industry it's important to provide background on the interplay between incentives and mandates.

The two pieces are interrelated in that consumer demand and meeting the obligations for the new law should be considered together. It's important for manufacturers and dealers to ensure that the needs of consumers are met, and that both initiatives complement one another to reach the goal of getting more EVs on the road.

There is also an issue to highlight with regard to the 90 day timeline for delivery to consumers to receive the incentive when there are times of year that model switchovers are occurring, it is most challenging during the late summer, when vehicle models may not be on the lot and delivery to consumers has to be completed. There have been instances where consumers can't benefit from the incentive because the stock hasn't reached them on time.

I am hoping that Min. Donaldson might be available to weigh in on the most recent concerns being raised by some of the Wet'suwet'en regarding Coastal Gaslink clearing work along the Kweese War Trail and what the province is doing in response.

My understanding is that work stopped, at least for a period of time, at the beginning of August and that the Oil and Gas Commission is (or was) investigating. But it also seems that chiefs from the Office of the Wet'suwet'en are looking to have some kind of response or sense from the province about what it's doing about what they see as repeat infractions on their territory.

I'm reaching out to CGL next to get a sense of what's happening out in the area at the moment - if work is still on pause or if it has resumed.

I'm reaching out to you because of Min. Donaldson's position as minister, but also as the MLA representing the area and someone who I know has a personal relationships within the community.

Please let me know if there's anything he may be able to comment on.

I am a journalist with National Observer who is working on an article about the federal-provincial MoU regarding the electrification of natural gas production in B.C.

I want to give you the opportunity to respond to a number of criticisms and also seek clarity on a number of questions. So:

Critics contend that your government has pushed for the expansion of the province's natural gas industry despite this path being completely incompatible with attaining the weak targets it set for itself.

These critics -- including the leader of the B.C. Green party that holds the balance of power, who said the electrification of natural gas was like 'lipstick on a pig' -- say that fracking quite likely releases more methane than previously thought (enough to make it as dangerous to the environment as coal).

- * What is your government doing to determine the true emissions profile of the province's LNG fracking industry?
- * How do you respond to the complaint that funding the electrification of natural gas is just more financial subsidy to an industry that should instead be scaled down and ultimately phased out?
- * What estimate does your government have for the reduced amount of emissions this electrification effort will produce? How is that calculated?
- * How much of the \$680 million being made available for this effort is coming from the B.C. government?
- * How much (if any) is going towards retrofitting existing operations versus helping fund projects that are not yet built?
- * Regarding the projects not yet built, could you estimate their expected emissions output (especially of methane) over a specific timeframe?

- * Regarding those projects already in operation, what emissions reductions are expected, and do the retrofits extend the life of these projects?
- * Are any of these funds available for the potential electrification of the LNG Canada project in Kitimat? If so, is there a maximum amount available?
- When your government committed to a 40 per cent emission reduction from 2007 levels by 2030, it said this meant one major LNG project and one other one could go ahead.
- * What is your government doing to let investors interested in new projects beyond LNG Canada and the Woodfibre terminal near Squamish know that no additional LNG proposals will be considered?
- * Regarding LNG Canada, do you intend to accommodate only the two trains (liquefaction facilities) planned for the launch, or do you support the expansion to four trains?
- * Why has your government not created a mechanism in legislation or regulation that would cap the expansion of LNG production in British Colombia? Do you plan to do so? If so, what mechanism will you use to achieve this? Critics also contend that exporters of fossil fuels (such as B.C.) have a responsibility to account for the emissions they send elsewhere. Does your government support this notion, and will it plan to calculate and publish such a report in the future?
