B.C. launches fund to support cleaner industry and reduce emissions

VICTORIA – The Province is helping drive cleaner industrial development with the launch of a new fund to reduce greenhouse gas emissions and support good jobs across British Columbia.

The CleanBC Industry Fund will invest carbon tax revenues of \$12.5 million in 16 projects throughout the province, with additional contributions from industry raising the total fund value to more than \$55 million this year.

"Our government is building a better future for people throughout B.C. by investing in new projects that will reduce emissions and support clean development opportunities for industry," said George Heyman, Minister of Environment and Climate Change Strategy. "We recognize the importance of working together with businesses to reach our CleanBC targets and build a stronger, more innovative economy where people in communities across the province thrive."

Provincial funding will support a range of projects across B.C., including new electro-coagulation technology at Harmac Pacific's employee-owned pulp mill in Nanaimo. The project will improve the waste-treatment process and eliminate the use of natural gas to power a

bio-boiler onsite.

"The CleanBC Industry Fund is helping Harmac Pacific improve the way we operate our pulp

mill by moving away from fossil fuels and reducing our emissions," said Levi Sampson, president of Harmac Pacific. "The investment from the Province will help us treat mill waste more efficiently using cleaner technology while supporting good local jobs in Nanaimo."

This year's initial slate of CleanBC Industry Fund projects is expected to reduce approximately 700,000 tonnes of CO_2 -equivalent over the next decade – roughly the same as taking 250,000 cars off the road for a year. Additional projects will be announced in early-2020 following signing of funding agreements.

To be eligible for funding, CleanBC Industry Fund applicants must have emissions over 10,000 tonnes of CO_2 e per year and be a reporting facility under the Greenhouse Gas Industrial Reporting and Control Act. Successful projects were chosen based on a competitive process and an evaluation of detailed project plans, business cases, and the potential to cost-effectively reduce emissions.

CleanBC is the province's pathway to a more prosperous, balanced and sustainable future. It was developed in collaboration with the BC Green Party caucus, and supports the commitment in the Confidence and Supply Agreement to implement climate action to meet B.C.'s emission targets.

Quick Facts:

- Successful CleanBC Industry Fund projects are required to sign funding agreements that define the terms and conditions of the funding.
- Provincial payments are funded through carbon tax revenues paid by industry and will
 be distributed to successful companies based on construction and implementation
 milestones to reimburse a portion of eligible project expenses.
- Final payments of 10-20% of total provincial funding will be distributed after the proposed reduction in emissions can be demonstrated.
- The CleanBC Industry Fund is part of the CleanBC Program for Industry, which also includes the CleanBC Industrial Incentive Program.
- Altogether, the CleanBC Program for Industry is expected to reduce emissions by 2.5 million tonnes of CO2e per year by 2030.

B.C. investing in electric vehicle skills training for a cleaner, better future

VANCOUVER – With support from CleanBC, a new electric vehicle (EV) training program for automotive technicians has successfully completed its first pilot and will be available to the public in the new year.

"This training program is a game changer and part of where the world is going as we switch to zeroemission vehicles," said Michelle Mungall, Minister of Energy, Mines and Petroleum Resources. "BC has the fastest increase of ZEVs on the road, with 30,000 now. So we're going to need mechanics, and BC is the first province to offer this kind of training. This is an example of the thousands of new jobs and opportunities we'll see under our CleanBC plan to boost the economy, reduce air pollution, and make life more affordable."

The newly developed EV Maintenance Training Program at the British Columbia Institute of Technology (BCIT) will make sure our workforce has the skills and training needed to support more electric vehicles on the road. Under the government's CleanBC plan, all new light-duty vehicles sold in B.C. by 2040 will be zero-emission vehicles.

With \$325,000 in provincial funding through CleanBC, BCIT has completed its first pilot of the Program with the City of Vancouver's green fleet technicians. By working with the City of Vancouver,

BCIT was able to develop and test an EV curriculum with 12 red seal mechanics. The partnership has helped the City on its path to become one of the greenest cities in the world and has continued BCIT's ongoing leadership in sustainability and training.

Vancouver has one of the largest Canadian municipal EV fleets, with 120 EVs in service. Expanding the EV fleet is a key component of the City's Climate Emergency Response, which has set a target of deriving 100% of energy used by the fleet from renewable sources before 2050.

"The City of Vancouver is committed to achieving carbon neutrality in its entire vehicle fleet by 2050," said Cheryl Nelms, Acting General Manager, Engineering Services. "Having more City staff trained in the safety, maintenance and repair of electric vehicles is a priority both today and into the future as our electric vehicle fleet grows. We are proud to have partnered with BCIT on this important training course and to see our staff be among the first in the country to be certified in maintaining and repairing EV vehicles."

BCIT's EV Maintenance Training Program will be available as a part-time studies course early in the new year.

"The BCIT Electric Vehicle Maintenance curriculum is another powerful example of how our Institute is working directly with employers and government partners to deliver sustainability training where it's needed most," said BCIT President Kathy Kinloch. "This kind of flexible up-skilling will be critical in growing the green workforce B.C. and Canada needs to meet our sustainability targets."

CleanBC is a pathway to a more prosperous, balanced and sustainable future. CleanBC was developed in collaboration with the BC Green Party caucus and supports the commitment in the Confidence and Supply Agreement to implement climate action to meet B.C.'s emission targets.
