It is with extremely mixed emotions that I am writing to tell you that I have decided to leave government effective end of day tomorrow, June 5. I will start by stressing that I have known for a little while that Friday would be the day, but I have been keeping it confidential from most people for personal reasons as well as not wanting to be a "lame duck" Deputy while the day was creeping up.

This is a hard email to write. Those who know me best know that I wear my heart on my sleeve every day. I have been a faithful and proud public servant since 1989. I started my career in the technology space with BC Systems Corp and worked my way up to be Government CIO. I am extremely proud of many of my accomplishments from that era – including leading the teams that created the Provincial Learning Network and Pharmanet, brought together all the Broader Public Sector telecommunications buying power to bridge the digital divide in rural BC and designed, built and deployed the combination Driver's Licence and Care Card that we now know as the BC Services Card. In 2012 I was asked to head the Environmental Assessment Office. That was a big leap from IT, but

one that I embraced and loved. I was then appointed Deputy Minister of Energy and Mines when EMPR was split and the Ministry of Natural Gas Development was created to pursue LNG. I came to understand the amazing passion of the bureaucrats that make possible resource development in BC and I loved being part of that. I guess it's that passion that caused government to ask me to take over the Ministry of NGD in 2015. It was a very interesting time to go from the heady days of an LNG "gold rush" mentality, to scrapping to stay in the game as the worldwide LNG market grew from its nascent beginning.

After the 2017 election I was asked to stay on as DM of the recombined EMPR that we know today, and over the last few years I have had the extreme privilege of working with all of you to achieve some pretty big things. For example, bringing the LNG Canada deal across the finish line. That project embodies the triple word score of being net good for the environment, good for the economy, and embraced (largely) by First Nations. There have been other big accomplishments as well, but as we are now into recent history all of you know about those.

BC is well endowed with natural resources that the world needs. If those resources don't come from a place like BC that has extremely strong environmental standards, they will come from somewhere else. This is why Clean BC is such an important plan. I have spent a lot of time talking to industry about the importance of being "clean and green" if they want to locate in BC. This will be very important in the future. As the world becomes increasingly aware of climate change and consumers care about the raw materials that go into their devices, the bona fides that companies get from operating in BC will pay off. I firmly believe that companies' ability to raise capital to build projects, and their ability to sell their commodities will increasingly be linked to their Environmental, Social and Governance (ESG) credentials. The trick to all of the above is that we know the system is not infinitely elastic. The difficult job for all of you at EMPR is to pace these impacts, so government achieves its environmental objectives, companies recognize investments in BC as being worth the costs of entry, and people continue to benefit from good jobs and government revenues. This is a monumental balancing act, but one I know that the EMPR team and colleagues in other ministries can and will continue to do so.

As I said – I'm extremely proud of this Ministry and the executive team, and all of you! I have been so blessed in my public service career. I have enjoyed the opportunity to work with you to make a real difference through good public policy. The culmination of that for me was being nominated by my peers and selected to win the Lieutenant Governors Silver Medal Award for Excellence in Public Administration. As it says on the IPAC website:

This award is presented annually to a public servant who has demonstrated exceptional achievement and distinctive leadership in public administration. The Silver Medal pays tribute to public sector practitioners whose careers exhibit the highest standards of excellence, dedication, and accomplishment.

I have had the wonderful good fortune of serving three Premiers and numerous Ministers. I can say with direct knowledge that they (we) are all public servants in the truest sense of the word.

Sometimes we might disagree on priorities, but that's ok. That's the system working. No one thought 3 years ago that a minority government could last this long, but here we are!

I have been so lucky with my direct bosses over the years who tolerated my passion and gave me chances. The highlight of my career has been to work for Don Wright. I can't say enough how much his mentorship, teaching and kindness has affected me deeply. Thank you, Don, for who you are! My final thank you goes to the staff in EMPR and all the other colleagues I have worked with all over government for the past 30 years. It's been amazing. Thanks for all your help and support over the

years.
