VICTORIA – Bruce Ralston, Minister of Energy, Mines Petroleum Resources, has released the following statement in response to BC Hydro's filing of its latest reports on Site C with the BC Utilities Commission (BCUC), found here: https://www.sitecproject.com/news-and-information/progress-reports-to-the-bcuc

"I am very concerned about the latest reports that BC Hydro has provided to the BCUC on the Site C project.

"COVID-19 has created significant challenges for the project that we could not have anticipated.

"In March, BC Hydro scaled down the project significantly and focused only on essential work and meeting crucial milestones, particularly river diversion.

"This was done in line with the advice and directions from the provincial health officer to ensure the safety of workers and communities.

"While the project remains on track to achieve river diversion this coming fall, there is uncertainty with the project's schedule and budget due to the ongoing pandemic.

"BC Hydro continues to safely scale up construction activities at the site. It has also begun the process to re-baseline the project to determine the cost and time required to complete the remaining work.

"The previous government chose to start Site C in 2010 and made clear they wanted to push it past the point of no return. And they did.

"We knew there were significant cost pressures and risks with Site C when we formed government. COVID-19 has dramatically added to these challenges.

"We take this very seriously. Today, I am announcing the appointment of Peter Milburn as a special advisor to work with BC Hydro and the Project Assurance Board.

"As a former deputy minister of finance and secretary to Treasury Board, I fully expect Mr. Milburn will play an important role in reviewing the project and will provide the government with independent advice."

Site C Review TOR

Q.1 Why are you announcing a review of the Site C project?

- BC Hydro has experienced significant impacts from COVID − 19 on the Site C project.
- Because of COVID-19 safe distancing requirements, construction work at the site was scaled down to focus only on critical river diversion by September 2020, which remains on track.
- But this has come at a schedule price as a reduction in staff has meant that work needed for other parts of the Project has been delayed and there is risk of delay to the in-service date.
- BC Hydro is filing with the BC Utilities Commission, its 2019 Site C annual report (to December 2019), as well as the quarterly progress report for January - March 2020.
- The reports identify overall project health and cost being at risk, and the quarterly report to March outlines additional cost and schedule risk resulting from COVID-19.
- Aside from COVID 19 impacts, there is also an identified need for enhancements to the foundations of structures on the right bank, including the powerhouse, spillways, as well as the earth-fill dam.
- Because of these and other developments, the Province has decided that an independent review at this time would be appropriate to help determine the full scope of Site C challenges and mitigation strategies available.

Q.2 Who will be doing this review of the Site C project?

- The Ministry of Finance, in co-operation with the Ministry of Energy, Mines and Petroleum Resources, will be leading the review to be carried out by Mr. Peter Milburn, an independent consultant to the Province.
- Mr. Milburn worked extensively on provincial transportation infrastructure projects over a public service career spanning over 30 years. His roles evolved from being a designer and geotechnical engineer; to direct senior project supervision and oversight of large projects; to Deputy Minister of Transportation of Transportation and Infrastructure; and CEO of the BC Transportation Financing Authority.
- From 2011 to 2015, Mr. Milburn was appointed Deputy Minister of Finance and Secretary to Treasury Board. In that role, amongst overseeing reviews of a number of major capital projects and programs, Mr. Milburn provided direct oversight of a due diligence review of BC Hydro's initial Site C Project budget in 2014/2015.
- Mr. Milburn is currently an independent consultant under a strategic advisor contract awarded through a competitive procurement process undertaken by the Ministry of Finance. He is has also served as Board Chair for the BC Investment Management Corporation since 2017.

Q.3 Who will the consultant report to? How long will the review be and will a report be made public?

- The consultant will account to the Deputy Minister of Finance and Minister of Finance, in cooperation with the Minister of Energy, Mines and Petroleum Resources, responsible for BC Hydro and Site C.
- We expect the consultant's review to take 60 days.
- When the review is finished and government has reviewed the findings and recommendations with BC Hydro, it is the intention of government to make results public, along with an action plan based on recommendations of the consultant.

Q.4 How much will the review cost?

 We are currently working with the consultant to determine what additional resources will be needed to support the review work. So it is too early to say how much the 60-day review will cost at this time.

Site C Review Engagement TOR - Final

The Contractor will provide the Services described in this Statement of Work and, at all times, in compliance with the Umbrella Agreement.

The Ministry of Finance ("the Ministry") plays a key role in establishing, implementing, reviewing and overseeing government's economic, fiscal, and financial management policies, decisions, and initiatives, as well as a number of financial and corporate regulatory functions. The Ministry draws on both internal and external resources to plan and carry out its mandate.

Context

BC Hydro's Site C Clean Energy Project (Project) will be a third dam and hydroelectric generating station on the Peace River in northeast B.C. It will provide 1,100 megawatts (MW) of capacity, and produce about 5,100 gigawatt hours (GWh) of electricity each year — enough energy to power the equivalent of about 450,000 homes per year in B.C.

The Provincial government approved the continuation of the Project in December 2017, following a review by the BC Utilities Commission (BCUC). In January 2018, the Province's Treasury Board approved a revised Site C Project budget under oversight of BC Hydro, as well as a Project Reserve to be overseen by Treasury Board.

BC Hydro is required to submit quarterly and annual Project reports to the BCUC and to make such reports public. On July 30, BC Hydro is filing the 2019 Project annual report, as well as quarterly progress report no. 19, with the BCUC. Both reports identify overall project health and cost as being at risk, while quarterly report 19 outlines additional cost and schedule pressures resulting from COVID-19.

- The annual report covers Jan. 1 to Dec. 31, 2019, while quarterly progress report no. 19 covers Jan. 1 to Mar. 31, 2020.
- The reports use a dashboard system where key project areas are classified as red (at risk), amber (moderate issues) or green (on target).
- Both reports classify overall Project health and cost as "red", signifying there are serious concerns due to identified cost pressures.

In addition, quarterly report #19 also classifies project scope and schedule as "red", largely due to:

- increased cost and schedule pressures resulting from the scale-back of work on March 18 due to the COVID-19 pandemic; and
- the need for enhancements to the foundations of structures on the right bank, including the powerhouse, spillways and earth-fill dam.

The other subcategories (safety, quality, regulatory, permits and tenures, environment, procurement, Indigenous relations, litigation and stakeholder engagement) are classified as either "amber" or "green."
