Thanks for the discussion this AM. Attached is some correspondence for your info: there was discussion regarding the moving expenses and feedback on the portion above the negotiated \$40K receiptable limit. Staff also did have some discussion about the 90-day loan, albeit after it was negotiated. As the president is responsible for repaying the interest incurred by VCC, this is not considered compensatory. It is not uncommon to see these types of loans negotiated when an individual is relocating and incurs the cost of interest.

Dear Pratibha:

On June 22, 2014 PSEC approved the offer of employment and employment contract for Dr. Peter Nunoda for the position of President, Vancouver Community College. Dr. Nunoda commenced employment in this position on August 18, 2014.

Dr. Nunoda's offer included a Relocation Allowance of \$40,000 which was meant to cover the costs of relocating his home \$.22 to the Lower Mainland of BC. At the time it was determined that \$40,000 would be a sufficient amount to cover costs that are allowable under the Canada Revenue Agency regulations. As per Dr. Nunoda's employment contract, this allowance required back up receipts and invoices for reimbursement. It was also agreed that should Dr. Nunoda voluntary leave his position with the college within 2 years, the relocation costs paid would be refunded on a pro-rata basis.

Now that Dr. Nunoda has completed his move and all allowable expenses are accounted for, the total is \$53,484. We have included a summary of the expenses in the attachment. Receipts are available for all of these expenses.

We are seeking approval to reimburse Dr. Nunoda an additional \$13,484 and amend his employment contract accordingly.
