REPORTING REQUIREMENTS:

Within 72 hours of a CAS individual leaving British Columbia, the permit holder **MUST** submit to the Fish and Wildlife Branch via fax (250-387-0239) or by email (FishandWildlife@gov.bc.ca or ControlledAlienSpecies@gov.bc.ca) an affidavit by a person other than the permit holder (e.g. veterinarian, registered professional biologist) attesting to the fact that the CAS individual, identified as on the face page of this permit, has left British Columbia and the date of departure.

GENERAL CONDITIONS:

- The permit holder must comply with all laws applicable to the activities carried out under this permit.
- This permit extends to the permit holder's employees and volunteers, but only when they are engaged in the activities authorized by this permit on behalf of the permit holder.
- The permit holder must not authorize an employee or volunteer under the age of 19 to handle a CAS individual.
- 4. The permit holder must ensure that no person handles a CAS individual under authority of this permit unless the person has at least 2 years of experience working with controlled alien species of that taxonomic Family.
- 5. This permit extends to a person authorized to practise veterinary medicine in BC while that person possesses a CAS individual for the purpose of veterinary medical treatment, but is only effective for the first 72 hours after the person takes possession of a CAS individual for any given treatment.

NOTE: If veterinarian is in possession of a CAS individual for the purpose of longer term treatment (greater than 72 hours) the veterinarian will need to apply for a Rescue Centre permit.

- 6. The permit holder must ensure that any person transporting a CAS individual under authority of this permit carries a copy of this permit on their person.
- 7. The permit holder must not display the CAS for public viewing, including public contact and media use, other than what is required for commercial filming and production of the TV Series "Zoo season 2".
- 8. The permit holder must not house a CAS individual in the same enclosure as wildlife or a domestic animal (to reduce the possibility of the transmission of disease and parasites).
- 9. The permit holder must take all steps reasonably necessary to ensure that public safety is not jeopardized by any action taken under authority of this permit.
- 10. Prior to the CAS species individual named on this permit entering the Province of BC and the commencement of activities carried out under this permit, the permit holder must notify the Fish and Wildlife Branch (email: Nurie:Aliperti@qov.bc.ca) and the Conservation Officer Service (email contact: Inspector Chris Doyle: Chris:Doyle@gov.bc.ca; phone (not for wide spread distribution) 604-892-7823) the details pertaining to locations and times for transporting and locations and times for commercial filming.
- 11. On demand of an officer under the *Wildlife Act*, the permit holder must allow an officer safe and secure access to inspect the containment of the CAS species individual that is the subject of this permit during times of transport, housing and filming.
- 12. The permit holder must ensure that the CAS individual named on this permit is under the control of a qualified animal wrangler when the CAS individual is out of its enclosure for commercial filming.

- 13. The permit holder must immediately notify the Fish and Wildlife Branch (email: <u>FishandWildlife@gov.bc.ca</u> or <u>ControlledAlienSpecies@gov.bc.ca</u>; fax: 250-387-0239) should a CAS individual cause harm to any person or animal.
- 14. The permit holder must ensure that no CAS individual is released or escapes.
- 15. The permit holder must immediately notify the Conservation Officer Service (1-877-952-7277) or the Ministry of Forests, Lands and Natural Resource Operations, Fish and Wildlife Branch Regional Manager if a CAS individual escapes or is released.
- 16. The permit holder is responsible for all costs associated with the keeping and care of the CAS, and any damage, loss or injury to persons or property caused by the CAS.
- 17. The following applies to each CAS individual and the term "described" means "described in the attached detailed enclosure description applicable to the taxonomic group to which the CAS individual belongs." e.g. a detailed enclosure description for Pythonidae applies to each CAS individual that is a member of the Family Pythonidae.

The permit holder must do the described things, including, without limitation, the following:

- (a) keep the CAS individual only in an enclosure
 - made of materials described,
 - constructed in the described way,
 - padlocked in the described way, and
 - which includes the described elements;
- (b) while the CAS individual's enclosure is being cleaned
 - · move the CAS individual to the described secure area, and
 - take the described security measures;
- (c) maintain the described features in the CAS individual's enclosure in the described way, and
- (d) keep no more than one CAS individual in the described enclosure unless the detailed enclosure description provides for a greater number, in which case, no more than that number.

The permit holder may depart from the strict observance of a specific requirement in this paragraph by substituting an alternate measure, but only if that alternate measure will clearly result in persons and animals being no less safe than if the specific requirement had been strictly observed.

18. The following applies to each CAS individual and the term "described" means "described in the attached public safety plan applicable to the taxonomic group to which the CAS individual belongs." e.g. a public safety plan for Pythonidae applies to each CAS individual that is a member of the Family Pythonidae.

The permit holder must do the described things, including, without limitation, the following:

- (a) not allow the CAS individual to come into contact with people except in the described way;
- (b) ensure in the described way the safety of those that come into contact with the CAS individual;
- (c) in the described way, prevent the CAS individual from escaping or coming into unintended contact with other people;
- (d) if the CAS individual escapes, notify others in the described way and recapture it in the described way;
- (e) if the CAS individual is transported,
 - · transport it only in the described way,
 - transfer it to its transport container only in the described way, and
 - follow the described emergency plan if it escapes during transport
- (f) if the CAS individual is being transported into or from BC, transport it into or from BC only in the described way.

Application of this Act to controlled alien species

6.6 (1) Sections 3, 82 (4), 89, 93, 94 (1), 95 and 107 (2) apply in relation to controlled alien species as if those species were wildlife.

Release or escape of animals

- 77 (1) A person who releases or abandons an animal or from whose captivity an animal escapes
 - (a) is, despite section 11 (4) of the *Livestock Act*, liable to the government for loss or damage to wildlife or wildlife habitat caused by the animal, and for all costs incurred by the government in pursuing, recovering, holding or destroying it, and
 - (b) is not entitled to any compensation from the government if the animal is destroyed under section 79
 - (2) If a person releases or abandons an animal, other than a domestic animal, the person commits an offence.
 - (3) If an animal, other than a domestic animal, escapes from the possession of a person, the person commits an offence if he or she fails to make every reasonable effort to recover the animal.
 - (4) This section does not apply if the person is authorized by the regional manager to release the animal.

Destruction of animals

79 (1) An officer may kill an animal, other than a domestic animal, that is at large and is likely to harm persons, property, wildlife or wildlife habitat.

Documents not transferable

- 81 Except as authorized by regulation or as otherwise provided under this Act, a licence, permit or limited entry hunting authorization is not transferable, and a person commits an offence if the person
 - (a) allows his or her licence, permit or limited entry hunting authorization to be used by another person, or
 - (b) uses another person's licence, permit or limited entry hunting authorization.

Failure to pay fine

- 85 (1) This section applies if a person
 - (a) fails to pay, within the time required by law, a fine imposed as a result of the person's conviction for an offence under this Act or the *Firearm Act*, and
 - (b) has been served with notice of this section.
 - (2) In the circumstances referred to in subsection (1),
 - (a) the person's right to apply for or obtain a licence, permit or limited entry hunting authorization under this Act is suspended immediately and automatically on the failure to pay the fine,
 - (b) all licences, permits and limited entry hunting authorizations issued to that person under this Act are cancelled immediately and automatically on the failure to pay the fine, and
 - (c) the person commits an offence if, before that fine is paid, the person
 - (i) applies for, or in any way obtains, a licence, permit or limited entry hunting authorization under this Act. or
 - (ii)does anything for which a licence, permit or limited entry hunting authorization under this Act is required.

Entering premises

- 89 (1) For the purpose of ensuring that this Act and the regulations are being complied with, an officer may enter and inspect any premises or enclosure in which live wildlife or live fish is kept but, at the request of the owner or occupier, the officer must produce proof of identity.
 - (2) Despite the *Trespass Act*, an officer exercising duties under this Act may enter any land, whether enclosed or not but, at the request of the owner or occupier of the land, the officer must produce proof of identity.

Production of licence or permit

- 97 If a person who is required to hold a licence, permit or limited entry hunting authorization issued under this Act
 - (a) fails to produce it for inspection to an officer on request, or
 - (b) fails or refuses to state his or her name and address to an officer on request,

the person commits an offence.

REGULATIONS

Here are some, but not all, relevant excerpts from the **Controlled Alien Species Regulation** made under the Wildlife Act:

Possession

3 A person must not possess a prohibited species individual unless the person holds a permit authorizing the possession of that prohibited species individual.

Breeding

- 4 (1) Subject to subsection (2), a person who possesses a prohibited species individual must prevent the prohibited species individual from breeding.
 - (2) A person who possesses a prohibited species individual referred to in subsection (1) may allow the prohibited species individual to breed if
 - (a) the person operates a zoo or is an educational or research institution,
 - (b) the person holds a permit authorizing the person to allow that prohibited species individual to breed, and
 - (c) the breeding is in accordance with a management plan approved by a regional manager.

Release prohibited

5 A person must not release a restricted species individual or a prohibited species individual or allow a restricted species individual or a prohibited species individual to be released.

Shipping or transportation

5.1 A person must not ship or transport in British Columbia a prohibited species individual unless the person holds a permit authorizing the shipping or transportation of the prohibited species individual.

This excerpt from the Permit Regulation, made under the Wildlife Act, is relevant:

8 A person who holds a permit under the Act or the Permit Regulation commits an offence if he or she fails to comply with a term of the permit.

ADDENDUM TO APPENDIX 2 - PUBLIC SAFETY PLAN

Additional details regarding transport and containment (as provided by the permit holder to the Fish and Wildlife Branch on February 22, 2016 and February 24, 2016):

There are no other animals on the set other than Jean Cardinal's tiger. There are no other animals being housed with this tiger at the offset housing.

The tiger is loaded in a cube van truck to travel in this travel cage from the Cinezoo to Dorval Airport then onto Air Canada. The flight time is 4 hours and 23 minutes – animals are not allowed to fly over 5 hours. This flight will be direct from Dorval to Vancouver.

Jean Cardinal's assistant trainers will fly out to Vancouver in advance to meet the tiger when he arrives. The tiger is the last freight loaded on the plane and the first offloaded. The tiger will be offloaded into an enclosed trailer with double locks. Another trainer who possesses the permit of a shotgun and tranquilizer dart qun will be added to the delivery of the tiger from the airport to the off-set housing location (s.15).

The tiger will be transferred to a much larger enclosure while at the offset housing and exercised every morning and evening. The tiger will also have a large cage to move to the movie set and to relax in during filming. The cage to travel in is an approved IATA cage. There will be 24 hour security on the tiger wherever he goes.

The tiger will be moved in the same trailer that he is picked up in from the plane. It is 24 feet long and 8'6" in width and the tiger will have circulation vents in the roof. This trailer will accommodate a large cage to bring the animal to set. The cage contains a built in water supply. Jean Cardinal has flown this animal to other shows and sets.

The housing of the tiger will be in a large cage to transport him to the set inside the enclosed trailer. Once at the set, the tiger truck and trailer will be brought into the compound where we are going to film. The compound where the filming takes place is a 10 foot steel fence. The interior of the compound will have a hot wire within which the tiger will work. No one except trainers will be allowed into the compound.

The tiger will be transported in a cage in an enclosed trailer with double locks. There will be four trainers with the trailer and one American Humane Association officer with the trailer.

A safety trailer contains electric fence, bear spray, CO2 fire extinguisher. Canes, ropes and heavy duty leashes are available and used if needed. The tiger is in a double contained holding at the set, inside a hot wire which is inside a 10 foot high steel mesh fence.

The tiger will be removed from the trailer and walked on a leash by two trainers from Point A to Point B, where the tiger will work. Then the tiger will be allowed to work free from Point A to Point B, but a cable leash is still attached to his collar while working free. There will be veterinarian present at the film location at all times. There is also two City of Vancouver police officers present all day during filming.

Should the tiger escape, there are two police officers, one trainer licensed with a shotgun. The tranquiller gun is loaded with a combination of ketaset and rompen.

We will be contacting the Conservation Officer Service (COS) to monitor everything we are doing when the tiger arrives. The transport routes and schedules would be relayed to the COS.

On behalf of Jean Cardinal, I am trying to help him secure his permit for his tiger, as he is in Quebec and misunderstand some of your questions in English. Jean Cardinal has asked that I respond to your questions on his behalf.

I will try and address the concerns of each CAS PAC member separately to hopefully assist you with the answers you need and to help the Director of Wildlife with the application.

This is a very separate application from CAS # 99957. There are no other animals on the set than Jean Cardinal's tiger. There are no other animals being housed with this tiger at the offset housing.

The tiger is loaded in a cube van truck to travel in his travel cage from the Cine Zoo to Dorval Airport then onto Air Canada. The flight time is 4 hours and 23 minutes – animals are not allowed to fly over 5 hours. This flight will be direct from Dorval to Vancouver.

Jean Cardinal's assistant trainers will fly out to Vancouver in advance to meet the tiger when he arrives. The tiger is the last freight loaded on the plane and the first offloaded. The tiger will be offloaded into an enclosed trailer with double locks. Another trainer who possesses the permit of a shotgun and tranquilizer dart gun will be added to the delivery of the tiger from the airport to Action Animals Compound. This compound was picked because Fish and Wildlife had requested that cats on the show called "The 100" be housed there. The tiger will be put into a larger compound that is a tiger approved cage with plenty of room for exercise. I have been to the offset housing facility and found it to be secure for this animal. There will be 24 hour security on this animal wherever he goes. s.22 is the owner of the property and is one of the six people in Canada qualified to work with exotic cats. This is why he was chosen.

Another option we have is to go to a compound called "s.15", s.22

s.22

This brings to five, the trainers that will be around this animal. Three from CINE Zoo and two from Vancouver, being members of Teamsters Local 155. This compound has been in business for over 25 years and is also well known to Fish and Wildlife. Their cages and enclosures are very safe and secure, as they also hold bears here.

Our company Ultra Productions Inc. has insured this animal for 50,000.00 and we do not want a scratch on him or any harm to him.

The tiger will be moved in the same trailer that he is picked up in from the plane. It is 24' long and 8'6" in width and he will have circulation vents in the roof. This trailer will accommodate a large cage to bring the animal to set. The cage contains a built in water supply. Jean Cardinal has flown his animals to other shows and sets.

The American Humane Association representative, Chris Obansawin, who is working with us on Season 2 of Zoo will be monitoring all actions in and around the tiger. The housing of the animal will be in a large cage to transport him to the set inside the enclosed trailer. Once at the set the animal truck and trailer will be brought into the compound where we are going to film. The compound where we shoot is a 10° steel fence as is shown in the attached photos. No one except trainers will be allowed into the compound.

The animal will be removed from the trailer and walked on a leash by two trainers from Point A to Point B, where he will work. Then he will be allowed to work free from Point A to Point B, but a cable leash is still attached to his collar while working free. There will be a vet present that day that is hired by Ultra Productions Inc. There is also two City of Vancouver Police Officers with us all day.

I think there is a mix up on where we are keeping the animal for offset housing. The facility is open to Fish and Wildlife anytime they want and they had insisted previously that the animals from "The 100" show go to this facility. If you do not like this facility we would be happy to move to one of your choice. This is why we came up with the option of going to the compound "s.15" with s.22 s.22

The American Humane Association Officer, Chris Obansawin will be travelling with the tiger from offset housing to the movie set and return to the offset housing. Both he and the vet will monitor this and the vet will monitor the off loading from the plane and also the loading up of the animal on the plane to return to Quebec.

There is no negative reinforcement training practices with this tiger. He was raised from a kitten by Jean Cardinal and they have a great partnership.

Our Locations department has blocked off a wide area where we are going to film this scene and this area is under the control of Vancouver City Police and several officers that are employed by our locations department. The public is not allowed to come into our locked off area as per the Vancouver City Police.

The Vancouver film office has approved our permit to film on this location please see the attached pictures.

The public safety plan for the filming with the tiger is an enclosed area as per our maps attached. The steel fence is 10' high on the exterior near high walled buildings. The interior of the compound will have a hot wire within which the tiger will work.

We had chosen the Action Animals facility in Matsqui, a district of the City of Abbotsford, for storage of the animal because Fish and Wildlife had insisted that the animals from a show "The 100" be kept there. s.22 is the owner of the facility and is one of six people in Canada qualified to work exotic cats. He has handled these kinds of cats for over 35 years with no accidents and no complaints of mistreatment.

Another option for offset housing is a compound called 's.15 owned by s.22 who has been a s.22 trainer for over 25 years. This is probably the facility we will go to depending upon your approval.

The tiger will be transported in a cage in an enclosed trailer with double locks. There will be four trainers with the trailer and one American Humane Association officer with the trailer. A vet will be on site at the film location at all times. A safety trailer with our show contains electric fence, bear spray, CO2 fire extinguisher. Canes, ropes and heavy duty leashes are available and used if needed. The animal is in a double contained holding at the set, inside a hot wire which is inside a 10° high steel mesh fence.

The tiger truck and trailer is also inside the 10' fence. The tiger walks from the trailer on the set to his spot where he works with two trainers with a leash on him. We will have two City of Vancouver Police Officers to keep the public away and several officers will have the streets blocked off as per our Locations department.

Should the animal escape – there are two police officers, one trainer licensed with a shotgun as is specified by CINE Zoo. One trainer with a tranquilizer gun as specified, and one vet on set. The animal is enclosed inside a hot wire inside a 10° high steel fence with police supervision outside of the compound to keep the public away. The tranquilizer gun is loaded with a combination of ketaset and rompon.

We will be contacting the Conservation Officer Service to monitor everything we are doing when the tiger arrives. The police of jurisdiction is the Vancouver City Police and the City of Vancouver film office at 604-257-8840 which has approved our permit for our location. The transport routes and schedules would be relayed to COS and everyone involved depending upon which offset housing you are approving.

The transport cage is only for the tigers' travel while on the plane. This cage is big enough for him to stand up and turn around. He will be transferred to a much larger enclosure while at the offset housing and exercised every morning and evening. He will also have a large cage to move to the movie set and to relax in during filming. The cage to travel is an approved IATA cage.

The cage measurements sent to you was for a travel cage. The tiger will be kept in a large compound at the offset housing where he will be made comfortable and exercised.

There will be 4 trainers with this animal at all times along with a vet when at the film set. The American Humane Association officer, Chris Obansawin will be with the tiger coming to the set and returning to the offset housing. There will be security on the tiger at the offset housing. This compound is double fenced all the way around.

I will try to address CAS PAC Member #1 and Member #2 at the same time as opposed to two different correspondence.

In response to the public safety concern please note that, the Vancouver Film Commission has approved our film permit for shooting this scene with the tiger at the location, s.15 which is at the corner of s.15 and s.15 in East Vancouver, as was enclosed in the previous map sent. The map depicts the exact location of the set, and where we will be implanting road closures with the help of the Vancouver Police Department.

Our Location Scout, Karen Sanderson, who is working hand in hand with the Vancouver Police Department, has arranged to have at least two Police Officers with us at all times. The Vancouver Police Department phone number is 604-717-3321. Due to the privacy act we cannot give out the Officers' cell phone numbers. The Officers on set will be on our radio frequency while on set. Their main job is to keep the public away from the compound. Again, I reiterate there will be no public access allowed near this compound. The streets are also blocked off by other Vancouver Police squad cars and personnel.

The tiger will not be out in the open on set. He will be working inside a double fenced compound. The interior fence will have hot wire, and the outer fence is 10' high and made of steel. The tiger will never leave the compound, as the safety trailer he is transported in will be driven into the fenced compound to ensure maximum security. The safety of our crew members is of upmost priority, thus, all cameras will be operated outside of the fence.

You are correct that the American Humane Society Officer does not have legal authority in Canada, but they do have contractual authority with the production company to inform the proper authorities of any mistreatment to make a complaint.

I fully see the COS monitoring everything that deals with this animal and their presence would be over and above the Vancouver Police. The V.P.D. are there for controlling the public. The COS Officer is there to monitor everything connected with this animal. We are also willing to pay this officer time and expenses for doing this. The officer will be advised of the location, times, transportation, filming schedule of the tiger as soon as I know who the COS will be. The COS will have access to inspect the tiger's containment at all times, wherever the tiger is present. I will happily supply the COS officer with all names and phone numbers of the trainers, support staff, animal coordinator, production personnel, veterinarian, police officers and A.H.A. officer.

No choice came forward so we took it upon ourselves to go to \$1.5 a compound owned by \$1

This will be the location of the offset housing for this tiger. If and when the permit is approved the COS will be notified immediately and we can bring up to speed with our plans whatever officer they choose.
