Subject: Grocery sales of 100% British Columbia wines

Dear Premier Clark:

We are writing to follow up on our letter to you of January 21, 2015. Wine Institute has since met with the B.C. Ministry of International Trade, private counsel, B.C. wineries and retailers, importers, agents and other stakeholders to learn the details and impacts of the government's wine in grocery store initiative. While your efforts to modernize retail distribution channels and promote the sale of B.C. wines are highly commendable, the initiative as currently outlined remains problematic for California wineries.

Our primary concern is the plan to relocate or move any existing or new VQA licenses to a shelf within grocery stores. Wine Institute believes that the Government's desire to promote B.C. wines can reasonably be achieved by modifying the initiative so that all wines, both local and imported, can equally access grocery store shelves. Although there are a number of other preferential benefits received by B.C. wineries that are concerning, our primary focus is on equal access.

For these reasons, we request that prior to April 1, the plan be modified to ensure equal access for imported wines on grocery store shelves and that VQA licenses not be relocated to grocery stores.

Thank you very much for your consideration for this request. We look forward to working with you in the coming days on this important matter.

#### Dear Premier Clark

Australia had the great pleasure of being the theme country for the recently concluded Vancouver International Wine Festival (VIWF). We were warmly welcomed by the city of Vancouver and believe the festival was an outstanding success.

During our visit we held a meeting with over 50 local agents representing Australian producers to discuss the proposal to allow BC grocery stores to exclusively sell BC VQA wines. All of the agents expressed strong concerns about this proposal. We also wish to register our concerns with this proposal for the reasons set out below and in doing so support the comments made by the Californian Wine Institute on 21 January 2015.

In 2014 BC VQA wines recorded gross sales of \$217m representing a 20.9% share of the total wine market with strong growth of 12% for the year resulting in \$24.2m of additional sales. In contrast, Australian wine sales declined by 6% or \$4.72m in 2014 to \$82.2m. Australian wine sales represent 7.9% of the total wine market. It is clear that BC consumers enjoy local BC wines and the BC industry is the market leader. This is no doubt partly due to the fact that BC wineries already enjoy significant preferential treatment as:

- BC wine that is "direct delivered" does not go through the BCLDB system and no LDB fees or mark-ups are applied;
- BC wineries are permitted to 'direct deliver" wine to customers straight from the winery;
- "Cellared in Canada" wines (which are imported wines bottled in Canada) can be delivered using the BC wine distribution system even though they are not BC wines;
- VQA Support Program or QEP (Quality Enhancement Program) provides rebates for BC wines that are sold through government BC liquor stores.

In addition, BC wineries enjoy flexibility regarding terms of sale, delivery options and discounts which are not open to imported wine.

In light of this, we query why the BC wine industry requires further preferential support as it clearly already competes very strongly in the BC market.

The proposal to allow BC VQA wines to be sold in the BC grocery stores will only serve to further cement the market leading position enjoyed by the BC wine industry and therefore should either by withdrawn or modified to ensure a level playing field is afforded to domestic and imported wines alike in accordance with Canada's obligations under World Trade Organisation (WTO) rules.

During my visit last week, I took the opportunity to taste many BC wines and I continue to be impressed with the high quality and style evolution of these wines. Our view is that the best way for BC wines to continue to thrive is for them to compete fairly with all the wines of the world, leading to future export opportunities.

Canada in general and British Columbia in particular, are important markets for Australian wine, underscored by our involvement in the VIWF and we work closely with the Canadian Government and industry in a number of fora including the World Wine Trade Group and the Asia-Pacific Economic Cooperation Wine Regulatory Forum with a shared goal of removing trade barriers and facilitating global trade in wine.

With this in mind, we respectfully urge the BC government to reconsider this proposal to ensure BC and imported wines receive equal treatment, in line with WTO obligations.

We would welcome the opportunity to discuss this further with you.

Wine Institute submits the following comments on behalf of the California wine industry. We appreciate this opportunity to express our objections to the above referenced initiative.

Wine Institute is the public policy advocacy association of 1,000 California wineries and businesses supporting legislative and regulatory advocacy, international market development, media relations and education programs that benefit the California and United States (U.S.) wine industry. California represents more than 90 percent of U.S. wine production and 95 percent of U.S. wine exports. More than one hundred U.S. wineries, most of which are small and medium sized enterprises, export their products into the global marketplace, including British Columbia (B.C.) and other Canadian Provinces. U.S. wine is the largest import category in the B.C. market.

On December 19, 2014, your government announced a number of initiatives designed to create new opportunities for B.C. wineries, support B.C.'s local economy and address calls for added convenience for consumers:

- 1. Grocery stores will be able to sell 100% B.C. wine on designated shelves on April 1, 2015;
- 2. The second phase of the liquor-in-grocery model will allow existing VQA stores and independent wine stores to relocate or transfer their license to an eligible grocery store as long as the license is only used to sell 100% B.C. wine. (These licenses are not subject to the one-kilometer restrictions, previously announced); and
- 3. A limited number of new licenses will be made available specifically for the 100% B.C. wine-on-shelves model.

We believe that the proposal allowing only B.C. Vintners Quality Alliance (VQA) wines to be sold at B.C. grocery stores should be withdrawn or modified to allow for the sale of imported wines. Since these new opportunities are not extended to imported wines, they violate Canada's international trade obligations including NAFTA, GATT and the EU-Canada Agreement on wine sales.

Existing government regulations already dramatically favor B.C. wineries. For example:

- B.C. wine that is "direct delivered" does not go through the BCLDB system and no LDB fees or markups are applied;
- B.C. wineries are permitted to "direct deliver" wine to customers (e.g., individuals, private stores, restaurants, etc.) straight from the winery;
- "Cellared in Canada" wines (which are imported wines bottled in Canada) can be delivered using the B.C. wine distribution system even though they actually are not B.C. wines; and
- VQA Support Program or QEP (Quality Enhancement Program) provides rebates for B.C. wines that are sold through government B.C. Liquor Stores.

In addition, B.C. wineries, unlike those from outside B.C., can:

- Provide terms to restaurants and retailers (all other wine comes through the B.C. Liquor Distribution Branch (BCLDB) and must be paid for upfront);
- Provide discounts and quantity discounts (this is not allowed through the BCLDB system);
- Provide next day delivery via their own trucks (a "spec" item could take 10 days to be delivered); and
- Deliver less than a case (all other wines need to be purchased in full cases).

The proposed initiative would even further disadvantage non-locally produced and imported wines, and in a particularly discriminatory manner.

By law, only a limited number of privately owned specialty wine stores may sell wine in B.C. The Province allows B.C. wineries to maintain a fixed number of off-site retail locations under a clause that was "grandfathered" into legislation when the Canada-U.S. Free Trade Agreement (FTA) came into effect in 1989. The Canada-U.S. FTA provides that: "... Ontario and British Columbia are not prevented from allowing private wine outlets *existing on October 4, 1987* to favor their own wine." *(Emphasis added)* 

Since only a limited number of privately owned specialty stores sold VQA wines in 1987, any new retail outlets for the exclusive benefit of B.C. vintners will be a clear violation of Canadian international obligations.

The proposed system would have B.C. VQA wines available in grocery stores on the regular store shelves. Imported wines would only be available in a 'store within a store' model; essentially a liquor store within the grocery store. Clearly, this scheme imposes an additional burden on our consumers and, as a result, does not provide the same type of revenue opportunity for import products that VQA wines would enjoy. Especially concerning is the fact that the liquor store within grocery store model is being promoted as a way to control abuse and under- age purchase. If this is the case, is there not the same concern with VQA wines on regular store shelves?

Canada is a vitally important trading partner with the U.S., particularly in the wine sector, and we value this relationship. Our governments and wine industries work closely together in a variety of forums -- the World Wine Trade Group, the Asia-Pacific Economic Cooperation Wine Regulatory Forum and the U.S. Tax and Trade Bureau/Wine Institute International Technical Forum -- all with the goals of removing discriminatory barriers and facilitating international trade. Proposals that raise new barriers to trade, such as B.C.'s initiative, run counter to these important international cooperation efforts and must not be supported.

For these reasons, Wine Institute requests that the initiative be withdrawn or modified to allow for equal access of all wines at B.C. grocery stores. We appreciate the opportunity to provide comments on this proposal. Thank you very much for your consideration.

The European Union has been monitoring with great interest the policy developments in British Colombia following the launch of your liquor policy review last year. My staff has had the opportunity to meet representatives from your ministry to discuss the different aspects that affect also imported liquor products.

While the European Union welcomes initiatives to increase consumer access to liquor in a responsible way, recent developments are causing some concern that the actual implementation of the envisaged measures — notably those to be launched in April this year - may be disproportionally favoring BC products.

As you know, the European Union has been raising for some time a number of concerns regarding existing discriminatory practices by the different provincial liquor boards, mainly in the form of differential application of mark-ups, but also as regards preferential routes to market for local products.

These and other issues are discussed regularly with the Canadian federal authorities in the joint EU-Canada wines and spirits Committee, which met the last time in November 2014. The Committee will also be the place to look into some of the measures launched recently at provincial level as regards the facilitated market access for local wines and spirits.

Pending the full set of details and way of implementation, certain policy statements in relation to the implementation of the current BC liquor policy review have given the impression that part of the legal measures as well as their de facto implementation may not be covered by existing derogations granted under Canadian international trade commitments as regards the obligation of national treatment of imported products.

In particular, our concern regards the following points:

In June 2014, sale of BC liquor (wine, beer and spirits) was allowed at farmers markets in the province. Although small in scale, this constitutes a new discriminatory route-to-market that is exclusively opened to local products.

The two-model approach for sale of liquor in grocery stores allows for more flexibility and choice of locations for the part of the model which is limited to BC wines only as it is not subject to the one-kilometer restriction. It would also appear to be less costly to implement separate wine shelves within the grocery store than establishing a shop-in-shop solution. It seems not quite clear why there is a need for a two part model, where one part is limited to BC

wines only, if it is not with a clear objective of promoting local wines by providing them more favorable conditions on the expense of imported wines.

In our conversations with your staff it has been guaranteed that the announced issuing of "new licenses" allowing grocery stores to sell B.C. wines only, will be fully respecting the existing cap on 60 licenses for off-site private BC wine outlets. However, the additional guidelines released on February 26<sup>th</sup> allow for private store licenses covering also imported products to be converted to a license for sale of BC wine only, in case of a transfer to a grocery store. In our understanding this can in no way circumvent the cap of 60 on the licenses for off-site private BC wine outlets.

Respecting the legitimate policy objective to support the local wine industry, this needs to remain in line with international trade commitments.

I respectfully urge you to implement, and possibly amend, the current initiatives to allow for equal treatment of imported liquor products.

Thank you for your letters of January 21, 2015 and March 12, 2015, addressed to the Honourable Christy Clark, Premier of British Columbia (BC), regarding comments from the California Wine Institute on BC's initiative to allow liquor to be sold in grocery stores. As Minister of International Trade, I am pleased to respond.

As you know, BC is undertaking a number of liquor reforms as part of a larger initiative, driven by one of the most highly successful public consultations in the history of the Province of BC. In the public consultation, consumers asked for more convenient access to alcoholic beverages at concerts and events, in bars and restaurants, and in grocery stores. We are striving to provide improved access within our current regime.

We are satisfied that changes to liquor laws and regulations are being done in compliance with our obligations under our domestic agreement on internal trade, the North American Free Trade Agreement and the Canada-European Community Wine and Spirits Agreement.

Other changes to our liquor policies include the implementation of wholesale pricing, which eliminates the cost differential applied to imported wine. This provides a real benefit to California wine producers. As we are implementing our liquor reforms, we consider both our international trading partners and our local producers and strive to provide more access, better convenience and fairer pricing. This is a balanced outcome that will help to encourage an overall appreciation of wine, including those from California.

I believe we share the same sentiment that the success of local wine producers is important for the overall success of wine globally. I understand the United States of America wine industry has received tax credits and federal government support in its growth to be a leading seller internationally. BC's wine industry is a key component of our tourism and culinary sectors, creating an industry of connoisseurs, exporters and importers who are as externally focussed as they are locally.

I commend you on the growth and penetration of the California wine industry, including achieving the number one import category in the BC and Canadian markets. Recent sales numbers in British Columbia indicate that California wines have increased gross sales in the Province from \$56.4 million in 2009/10 to over \$93.5 million in 2013/14, an increase of over 65 per cent. In fiscal 2013/14, California wines captured almost 10 per cent of total wine sales in the Province. Our partial sales numbers for 2014/15 indicate that California wines will again be the number one selling import over all other countries in the Province.

**ISSUE:** Selling BC wine in grocery stores

**BACKGROUND:** In December 2014, the BC government announced BC wine would be able to be sold directly on grocery store shelves as of April 1, 2015. This was one in a number of announcements of recommended liquor policy reforms arising from the 2013 BC Liquory Policy Review Final Report.

Certain stakeholders, such as the California Wine Institute (CWI), have expressed concern that this (and other practices in BC that support the domestic wine sector) is non-compliant with international trade obligations.

### DISCUSSION:

The distribution and pricing of alcoholic beverages are covered under a number of domestic and international agreements<sup>1</sup>. These agreements commit Canadian provinces and territories to treat imported alcoholic beverages as favourably as products from Canada. This means that the Province must: (1) treat the transportation and distribution of products from other jurisdictions at least as favourably as domestic products; and (2) not apply internal taxes or "other charges" on imported products that are in excess of those being applied on domestic products.

Two successful trade actions against Canada's liquor boards have resulted in the provinces being required to make changes to their pricing and distribution practices:

A 1984 World Trade Organization General Agreement on Tariffs and Trade (GATT) challenge launched by the European Commission against Canadian provinces' differential listing practices and mark-ups applicable to domestic and imported alcoholic beverages resulted in the EU securing certain obligations in a bilateral agreement, the Canada-EU Wines and Spirit Agreement (CEWSA), such as protection for geographical indicators and a commitment to provide audits to justify differential pricing for handling imported product versus domestic product.

<sup>&</sup>lt;sup>1</sup> These include the World Trade Organization's General Agreement on Tariffs and Trade (GATT), as well as the North America Free Trade Agreement, the Agreement on Internal Trade and the New West Partnership Trade Agreement (NWPTA). In addition, provinces are bound by the 1989 Agreement between the Economic Community and Canada Concerning Trade and Commerce in Alcoholic Beverages and the 2004 Agreement Between Canada and the European Community on Trade in Wines and Spirit Drinks (Canada-Europe Agreement), which amended and further supplemented the 1989 Agreement.

 A 1993 GATT challenge by the US that targeted provincial requirements that limited self-distribution rights to their own province's breweries resulted in British Columbia and other provinces being forced to allow direct delivery of imported beer to bars and restaurants.

In the North American Free Trade Agreement (NAFTA), Canada negotiated for BC to be able to maintain measures which allowed private wine outlets to sell only BC wine. These private wine outlets are also protected in the CEWSA and the Canada-EU Comprehensive Economic and Trade Agreement (CETA). The difference between the NAFTA, the CEWSA and the CETA is that only the CETA has included a figure of 60 stores (the NAFTA and the CEWSA were silent on the number of stores and referenced "those private wine outlets in existence as of the date of the Canada-US Free Trade Agreement", which was October 4, 1987). s.13,s.17

In a letter to the Premier, the CWI raised the BC wine on grocery store shelves and other practices as non-compliant with trade agreements (see **Appendix II:** CWI letter).

#### Dear Premier Clark:

Wine Institute submits the following comments on behalf of the California wine industry. We appreciate this opportunity to express our objections to the above referenced initiative.

Wine Institute is the public policy advocacy association of 1,000 California wineries and businesses supporting legislative and regulatory advocacy, international market development, media relations and education programs that benefit the California and United States (U.S.) wine industry. California represents more than 90 percent of U.S. wine production and 95 percent of U.S. wine exports. More than one hundred U.S. wineries, most of which are small and medium sized enterprises, export their products into the global marketplace, including British Columbia (B.C.) and other Canadian Provinces. U.S. wine is the largest import category in the B.C. market.

On December 19, 2014, your government announced a number of initiatives designed to create new opportunities for B.C. wineries, support B.C.'s local economy and address calls for added convenience for consumers:

- 1. Grocery stores will be able to sell 100% B.C. wine on designated shelves on April 1, 2015;
- The second phase of the liquor-in-grocery model will allow existing VQA stores and independent
  wine stores to relocate or transfer their license to an eligible grocery store as long as the license is
  only used to sell 100% B.C. wine. (These licenses are not subject to the one-kilometer restrictions,
  previously announced); and
- A limited number of new licenses will be made available specifically for the 100% B.C. wine-onshelves model.

We believe that the proposal allowing only B.C. Vintners Quality Alliance (VQA) wines to be sold at B.C. grocery stores should be withdrawn or modified to allow for the sale of imported wines. Since these new opportunities are not extended to imported wines, they violate Canada's international trade obligations including NAFTA, GATT and the EU-Canada Agreement on wine sales.

Existing government regulations already dramatically favor B.C. wineries. For example:

- B.C. wine that is "direct delivered" does not go through the BCLDB system and no LDB fees or markups are applied;
- B.C. wineries are permitted to "direct deliver" wine to customers (e.g., individuals, private stores, restaurants, etc.) straight from the winery;
- "Cellared in Canada" wines (which are imported wines bottled in Canada) can be delivered using the B.C. wine distribution system even though they actually are not B.C. wines; and
- VQA Support Program or QEP (Quality Enhancement Program) provides rebates for B.C. wines that
  are sold through government B.C. Liquor Stores.

In addition, B.C. wineries, unlike those from outside B.C., can:

- Provide terms to restaurants and retailers (all other wine comes through the B.C. Liquor Distribution Branch (BCLDB) and must be paid for upfront);
- Provide discounts and quantity discounts (this is not allowed through the BCLDB system);
- · Provide next day delivery via their own trucks (a "spec" item could take 10 days to be delivered); and
- Deliver less than a case (all other wines need to be purchased in full cases).

The proposed initiative would even further disadvantage non-locally produced and imported wines, and in a particularly discriminatory manner.

By law, only a limited number of privately owned specialty wine stores may sell wine in B.C. The Province allows B.C. wineries to maintain a fixed number of off-site retail locations under a clause that was "grandfathered" into legislation when the Canada-U.S. Free Trade Agreement (FTA) came into effect in 1989. The Canada-U.S. FTA provides that: "... Ontario and British Columbia are not prevented from allowing private wine outlets existing on October 4, 1987 to favor their own wine." (Emphasis added)

Since only a limited number of privately owned specialty stores sold VQA wines in 1987, any new retail outlets for the exclusive benefit of B.C. vintners will be a clear violation of Canadian international obligations.

The proposed system would have B.C. VQA wines available in grocery stores on the regular store shelves. Imported wines would only be available in a 'store within a store' model; essentially a liquor store within the grocery store. Clearly, this scheme imposes an additional burden on our consumers and, as a result, does not provide the same type of revenue opportunity for import products that VQA wines would enjoy. Especially concerning is the fact that the liquor store within grocery store model is being promoted as a way to control abuse and under- age purchase. If this is the case, is there not the same concern with VQA wines on regular store shelves?

Canada is a vitally important trading partner with the U.S., particularly in the wine sector, and we value this relationship. Our governments and wine industries work closely together in a variety of forums — the World Wine Trade Group, the Asia-Pacific Economic Cooperation Wine Regulatory Forum and the U.S. Tax and Trade Bureau/Wine Institute International Technical Forum — all with the goals of removing discriminatory barriers and facilitating international trade. Proposals that raise new barriers to trade, such as B.C.'s initiative, run counter to these important international cooperation efforts and must not be supported.

For these reasons, Wine Institute requests that the initiative be withdrawn or modified to allow for equal access of all wines at B.C. grocery stores. We appreciate the opportunity to provide comments on this proposal. Thank you very much for your consideration.

As you will know, I had the pleasure of meeting your respective deputies during my visit to Vancouver in late October. At this meeting we discussed, among others, the treatment of European wines and spirits in British Columbia.

Further to these discussions, please find attached a detailed elaboration on what the EU believes to be discriminatory practices towards non-local wines and spirits in your Province. We are particularly concerned about the increasing number of sales outlets offering additional possibilities for the sale of local liquor only, including access to lower mark-ups or mark-up exemptions. Canada's commitments under the WTO and its bilateral Wines and Spirits Agreement with the EU stipulate that imported goods must be treated in a way that is no less favourable than the most favourite treatment offered – we believe this is not the case right now.

I look forward to receiving your views on the issues raised in the attached document.
