Thank you for taking the time to meet with the Languages Canada delegation last Thursday. We recognize the level of importance that you placed on the issue by ensuring that appropriate senior staff members were in attendance and by your thoughtful questions.

One area that I believe merits some further explanation relates to the request by Languages Canada for appropriate legislation to cover our sector. While, we realize that the request is somewhat unusual and may seem in some ways contrary to the free-enterprise approach of the government, we also believe it is necessary to achieve the government's objectives.

Quite simply, we have come to believe that a legislative framework is necessary to ensure BC's leadership position in the industry. Well-crafted legislation will re-assure foreign students and provide BC with an advantage in attracting students to maintain the province's strength in terms of attracting students and generating economic activity in the province. Legislation will also ensure high quality language training programs. At the end of the day, there cannot be a system that protects students from fly-by-night operators who offer neither financial security, nor quality in education without some sort of legislative structure. The absence of legislation stands to imperil BC's reputation with respect to language and other education programs and bring harm to the many legitimate language programs that invest in quality, growth, and student protection.

Let me be clear. We are not seeking unnecessarily expensive, onerous, or restrictive legislation that creates more red tape and imperils free enterprise. We believe that it is possible to devise a framework that:

- is customized to meet the unique features, needs and challenges of the language training
- Establishes minimum standards of quality for education in this sector;
- Provides financial protection for students; and,
- Allows legitimate and otherwise viable languages programs to flourish and innovate while screening out programs and institutions that would harm BC and Canada's reputation for providing quality international education,

IMAGINE

For example, Alberta and Nova Scotia have arrived at a solution that leverages Languages Canada's world-class Quality Assurance Framework (which was launched in BC) and a modern registration method with the province.

Language education occupies a unique position in BC, and we realize that as a sector we impact education, tourism, immigration and labour force development in the province. Not only are we the necessary pathway into all of these, but in the process our 45 private sector members are small businesses that contribute approximately \$420,000,000 to the BC economy in export revenues. With a sound legislative environment in place, we cannot assure our overseas partners, such as China, that their youth will be protected and well taken care of while in BC.

We will ensure that all of these points are brought up during our upcoming consultations with AVED, and of course remain open for further discussions on the matter.
