Hi Daphne,

Regarding your piece on stadium and arena development in the Issues and Ideas section this morning, dropping you a quick line just to point out a few things regarding the section on BC Place:

- Total renovation cost for BC Place is \$563 million dollars under a fixed price contract, not \$583 million - and that covers renovations to the entire building, not just the roof. The cost of the roof component itself is roughly \$240 million of that.
- Although revenue contributions from lease or sale of the PavCo-owned properties adjacent to BC Place for an entertainment complex would provide a steady annual income of several million dollars, that revenue would not cover the entire cost of the renovation.
- Revenues from such things as an increase in business at BC Place owing to the revitalization will contribute more to recovering that cost over time.
- Thus - to say the "bill simply got handed to the provincial taxpayer" because of the City of Vancouver decision on the entertainment complex is misleading.
- Also, unlike other "sports only" stadium or arena developments, BC Place is multi-purpose - and an asset to all British Columbians which generates millions of dollars in economic activity every year. Without BC Place, for example, we would not have been able to host 100,000 spectators in January for the CONCACAF Women's Olympic Qualifying Tournament, or be a serious contender in the bid to have Vancouver host the 2015 Women's World Cup.
- Final note: A deal is nearing approval in Minneapolis to build a new stadium to replace the existing one which is very similar to BC Place, at a much greater cost of \$975 million, and will be used mainly for football.
