**Residents voice concern over uranium; Property values could plummet if mine allowed to open, says former test pilot -- Penticton Herald Monday, March 2, 2009**

Willy Floyd wants to gather the assessment data on 1,000 properties east of Kelowna for an anti-uranium, class-action lawsuit against the province.

The retired air force test pilot says assessments could potentially drop on all the properties from Trapping Creek north of Beaverdell 65 kilometres south to the Dam Fino Creek across from the Christian Valley. His rough estimate is \$500 million in assessments, not including Grand Forks.

"I've already got voluntarily everything from little tiny farmholes to a million-dollar religious retreat up at Yuma. The average house is worth between \$120,000 and \$400,000," he said.

"Property values would drop if there was a mine allowed. They have everywhere else in the world. We definitely want this entirely in place and underway in the courts before the end of the year."

The Committee for a Clean Kettle Valley (CCKV) is opposed to Boss Power's plans to develop the Blizzard claim, a round knob which can be seen nine kilometres east of Highway 33, 10 kilometres south of Big White Ski Resort.

"There is no such thing as mining without pollution," said Floyd, the CCKV researcher.

"You've got to have water for the mining and concentration processes, and where is the water going to come from? There are some very nice fishing lakes there called Lassie, Copper Kettle, Joan, Andrew and Maloney lakes. I know them all; I fish and hunt up there."

If mine runoff goes west, it will end up in the West Kettle River and if it goes east, in the main Kettle River, he said.

That water flows through Westbridge (where he lives), Rock Creek and Midway, enters the U.S. and re-enters Canada near Grand Forks.

"It would contaminate the entire Kettle River all the way through Grand Forks down to Christina Lake and back into the States. We're concerned with all the people who live in Beaverdell, Christian Valley, Westbridge, Rock Creek, Midway and Grand Forks," he said.

As well, "At four pounds of U308 yellow cake per ton, which is what they want to extract, you end up with 1,996 pounds of crap which remains there," he added.

Uranium processing also releases radon gas, which is heavier than air so it drifts downhill, enters the ground and can travel great distances, he said.

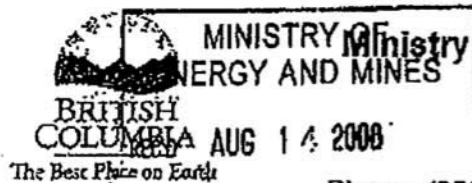

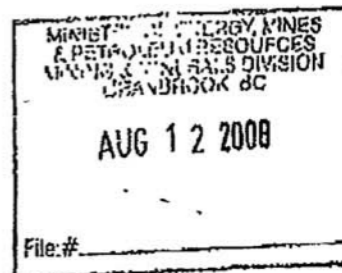

## Uranium Exploration in BC - Update

### **\*NEW INFORMATION IN BOLD\***

#### KEY FACTS REGARDING THE ISSUE:

The president of the BC Chamber of Commerce has stated publicly that his organization challenges the Province's decision to put a "no registration reserve" on uranium and thorium exploration in B.C.

The Chamber passed a resolution at its general meeting on May 24 condemning the decision. The Chamber says the ban is 'misguided and was made at the expense of B.C.'s reputation as a place to do business'.

On April 24, the Province announced it would not support the development of uranium in British Columbia and established a "no registration reserve" under the *Mineral Tenure Act* for uranium and thorium.

As well, the Province amended the Health, Safety and Reclamation Code to enhance the protection of workers who may encounter uranium during the exploration for other minerals, and to ensure protection of the public with respect to possible radiation from drill holes. The amendments also ensure that B.C. requirements for uranium protection for both workers and the public are consistent with national standards and guidelines.

#### BACKGROUND:

Saskatchewan is the only province with active uranium mining; Ontario and Quebec are promoting it and Nova Scotia has had a moratorium on uranium since 1982. The regulation of all nuclear substances (exploration, mining and production) is within federal jurisdiction; however, uranium may be encountered in the exploration or mining for other minerals.

The Energy Plan is clear that nuclear power will not be a part of B.C.'s energy supply mix. However, the plan does not address the question of whether the Province's uranium deposits should be used to fuel nuclear power plants in other jurisdictions. The Province has 196 known mineral occurrences that have some uranium, but has never had a producing mine. The Beaverdell area (near Kelowna) has the largest uranium deposit in the Province (known as the Blizzard Property), but the property is smaller and lower grades than other jurisdictions in Canada. It's believed that B.C. has relatively low potential to have economic uranium mines.

Since 1991, B.C.'s Health, Safety and Reclamation Code has included health and safety standards for mine workers who are incidentally exposed to uranium while engaged in exploration or mining for other minerals.

#### ADVICE AND RECOMMENDED RESPONSE:

- We've been clear about where the Province stands on the 'no registration reserve' on uranium and thorium exploration in B.C. and we told industry last year that we would not allow uranium mining in the Province.

- The decision simply formalized long-standing public opposition to mining radioactive materials in B.C.
- For some to say this decision sends the wrong message that B.C. isn't open for business is not true. Last year, B.C. set a record for mineral exploration – spending upwards of \$416 million.
- The Province only has about 200 existing mineral claims that show uranium content...the rest of B.C. boasts some 12,000 known and mapped mineralization areas to be explored.

## BACKGROUND:

Both the 2002 and 2007 British Columbia Energy Plans are clear that nuclear power will not be part of British Columbia's energy supply mix. Neither Plan, however, addresses the question of whether the Province's uranium should be used to fuel nuclear power plants in other jurisdictions.

The Province has 196 known mineral occurrences that have some uranium (133 are primarily uranium), but has never had a producing mine. Many geologists believe British Columbia has relatively low potential to have economic uranium mines. The Beaverdell area, southeast of Kelowna, hosts the largest uranium deposit in the Province (Blizzard property), but the property is considerably smaller and lower grade than the only active Canadian uranium mines in northern Saskatchewan.

Regulation of nuclear substances, including exploration, mining and production of uranium, is within federal jurisdiction. However, uranium may be encountered in the course of exploration or mining for other minerals. Accordingly, since 1991, the Province's Health, Safety and Reclamation Code has included safety standards for mine workers incidentally exposed to uranium while engaged in exploration or mining for other minerals.

Currently, Saskatchewan is the only Canadian province with active uranium mining. Ontario and Quebec are promoting uranium exploration, whereas Nova Scotia has had a moratorium on uranium mining and exploration since 1982 (

## History of Uranium in British Columbia

In the late 1970s, development of uranium resources in the Beaverdell area was proposed. In response to public concerns, the Province introduced a Uranium Moratorium Regulation (UMR) in 1980 for a period of seven years. The UMR was created in two stages. First, a no staking reserve, dated April 26, 1980, restricted the locating and recording of any mineral title for its uranium content over the entire Province. Second, a Uranium Moratorium Regulation, dated September 12, 1980, prohibited the development, mining or production of any mineral for its uranium content within the reserve

The moratorium was not renewed in 1987 as there was virtually no interest in uranium in British Columbia at that time. Three separate Private Members Bills were tabled in 1981, 1993 and 1998 to re-establish a moratorium, but none were enacted.

A number of uranium targeted claims were held by companies and individuals when the UMR commenced, including the Blizzard deposit which was considered a potential mine at the time. Despite the existence of these properties, there were no compensation claims against government as a result of the time-limited moratorium. During the moratorium, holders of mineral claims who declared that they had a uranium property were relieved of any fee or work requirements as they were unable to carry out work on their claims.

Following the expiry of the moratorium in 1987, regulatory provisions regarding exploration and mining of uranium were established under the Mines Act 1987 Exploration Regulation. This regulation was replaced in 1991 by the Health, Safety and Reclamation Code for Mines in British Columbia under the *Mines Act*, which continued to regulate aspects of uranium exploration and mining thought to be within provincial jurisdiction. In addition, the Code established health and safety standards for mine workers incidentally exposed to radiation during the course of exploring for or mining other minerals.



In 2007, a Code review determined that Code standards relating to health and safety of workers incidentally exposed to radiation were inconsistent with national standards established by the federal government, and recommended amendments to bring the Code into conformity. These amendments are required to ensure that provincial health and safety standards provide appropriate measures to protect mine workers against harmful effects of radiation exposure. As radiation may be encountered during exploration and mining for other minerals, these updated standards are required for all mining activity in the Province regardless of whether there is uranium exploration or mining.

## BACKGROUND:

Both the 2002 and 2007 BC Energy Plans are clear that nuclear power will not be part of British Columbia's energy supply mix. Neither Plan, however, addresses the question of whether the Province's uranium should be used to fuel nuclear power plants in other jurisdictions.

The Province has 196 known mineral occurrences that have some uranium (133 are primarily uranium), but has never had a producing mine. Many geologists believe BC has relatively low potential to have economic uranium mines. The Beaverdell area, southeast of Kelowna, hosts the largest uranium deposit in the Province (Blizzard property), but the property is considerably smaller and lower grade than the only active Canadian uranium mines in northern Saskatchewan.

Regulation of nuclear substances, including exploration, mining and production of uranium, is within federal jurisdiction. However, uranium may be encountered in the course of exploration or mining for other minerals. Accordingly, the Province's Health, Safety and Reclamation Code for Mines (Code) includes safety standards for mine workers incidentally exposed to uranium while engaged in exploration or mining for other minerals.

Currently, Saskatchewan is the only Canadian province mining uranium. Ontario and Quebec are actively promoting uranium exploration, whereas, Nova Scotia has had a moratorium on uranium mining and exploration since 1982 (

## History of Uranium in BC

In the late 1970s, development of uranium resources in the Beaverdell area was proposed. In response to public concerns, the Province introduced a Uranium Moratorium Regulation (UMR) in 1980 for a period of seven years. The UMR was created in two stages. First, a no staking reserve dated April 26, 1980 restricted the locating and recording of any mineral title for its uranium content over the entire Province. Second, a Uranium Moratorium Regulation dated September 12, 1980 prohibited the development, mining or production of any mineral for its uranium content within the reserve.

The moratorium was not renewed in 1987 as there was virtually no interest in uranium in BC at that time. Three separate Private Members Bills were tabled in 1981, 1993 and 1998 to re-establish a moratorium, but none were enacted.

There were a number of properties held by companies and individuals when the UMR commenced, including the Blizzard deposit which was considered a potential mine at the time. Despite the existence of these properties, there were no compensation claims against government as a result of the time-limited moratorium. During the moratorium, holders of mineral rights who declared that they had a uranium property were relieved of any fee or work requirements as they were unable to carry out work on their claims.

Following the expiry of the moratorium in 1987, regulatory provisions regarding exploration and mining of uranium were established under the *Mines Act* 1987 Exploration Regulation. This regulation was replaced in 1991 by the Health, Safety and Reclamation Code for Mines in British Columbia



(Code) under the *Mines Act*, which continued to regulate provisions for uranium exploration and mining thought to be with provincial jurisdiction. In addition, the Code established health and safety standards for mine workers incidentally exposed to radiation during the course of exploring for or mining other minerals.

In 2007, the Code was reviewed and it was determined that Code standards relating to health and safety of workers incidentally exposed to radiation were inconsistent with national standards established by the federal government. The review recommended revision of the Code to bring its standards into conformity with national standards. These amendments are required to ensure that provincial health and safety standards provide appropriate measures to protect mine workers against harmful effects of radiation exposure. As radiation may be encountered during exploration and mining for other minerals, these updated standards are required for all mining activity in the Province regardless of whether there is uranium exploration or mining.

### GOVERNMENT CONFIRMS POSITION ON URANIUM DEVELOPMENT

VICTORIA – The Province will not support the exploration and development of uranium in British Columbia and is establishing a “no registration reserve” under the *Mineral Tenure Act* for uranium and thorium, Minister of State for Mining Kevin Krueger announced today.

“By confirming our position on these radioactive minerals, we are providing certainty and clarity to the mining industry,” said Krueger. “B.C. is an attractive place for mining exploration and investment and we are committed to fostering a healthy, productive industry.”

The “no registration reserve” will ensure any future claims do not include the rights to uranium. Government will also ensure that all uranium deposits will remain undeveloped. These changes support the BC Energy Plan commitment of no nuclear power.

Uranium is present in many areas of the province and can be encountered while exploring for other mineral resources. Therefore, the Province will also amend the Health, Safety and Reclamation Code concerning exploration for minerals where uranium or thorium are incidentally encountered. The amendments are designed to enhance the protection of workers and the public during exploration-related activities. The amendments also ensure that B.C.’s standards for exploration are consistent with national standards and guidelines.

Today, there is no uranium mining in the province. Exploration and mining of uranium in Canada is regulated by the federal government through the Canadian Nuclear Safety Commission. The only uranium mines operating in Canada are in Saskatchewan.
