- The National Emergency Centre and response expertise will be in Montreal. All calls for spills in BC (and all of Canada) will be routed to staff in Montreal to address. All exercise and regional planning for BC will also be done out of Montreal.
- They will participate in spill response incidents by conference call from Montreal with a focus on "coordination of science". In the event of a Spill of National Significance they would send people from Montreal to the incident.
- The implementation of the environmental emergencies regulations and participation in federal prevention and preparedness work will continue to take place out of Gatineau.
- Notification regime with PEP will be maintained, but contacts will change. Each
 region will have a position that will liaise with provincial and territorial authorities,
 and EC will continue to provide its technical expertise to environmental
 emergencies. However, travel budgets have also been reduced which will have
 an impact on the ability of remaining staff in Montreal to travel to British
 Columbia.
- Coast Guard & Transport Canada are to receive increased funding to respond, however, these agencies do not have the required environmental expertise.
- As a result, EC will have little or no surge capacity in the event of a major spill to bring in responders from across the country. Vancouver EC staff share the current

- workload with our EEROs, work that our staff will now have to manage. Providing the current level of service, strong relationships and familiarity required in emergency management from Montreal is not realistic.
- Provincial experts believe that EC should be the lead federal agency for all spills in order to determine if a cleanup is adequate to protect the environment or public safety. Agencies such as the Coast Guard, National Energy Board, and Transport Canada should provide support based on their expertise in stabilizing a vessel or pipeline.
- Recent communication with Coast Guard around spill response training, suggests
 they don't know if they will have the available funding. This leaves uncertainty as to
 the extent of additional resources to be provided, and what relevance they may
 have.



Hi Jim,

I had a quick conversation with s.22 with Environment Canada (EC) on this yesterday afternoon. The following information was provided by s 22

- The 5 person Environmental Emergencies section in Vancouver is being entirely disbanded.
- Overall 23 EC environmental emergency staff across the country are being eliminated.
- All EC environmental emergency preparedness and response operations will be handled out of Montreal.
- There will also be a group in Gatineau that works strictly on policy and regulation.
- Travel budgets have also been reduced which will have an impact on the ability of remaining staff in Montreal to travel to British Columbia.
- All calls for spills in BC (and all of Canada) will be routed to staff in Montreal to address.
- They will participate in spill response incidents by conference call from Montreal with a focus on "coordination of science".
- In the event of a Spill of National Significance they would send people from Montreal to the incident.
- All exercise and regional planning for BC will be done out of Montreal.
- EC enforcement actions will continue to be provided by their enforcement staff in the region.
- They will address prevention issues and compliance promotion, including federal-provincial liaison from Daniel's compliance group in Vancouver.
- EC will have less involvement in recovery activities.
- Transition to Montreal will occur between May and end of June.
- 3 of the existing 5 staff in Vancouver will be losing their jobs and are currently seeking job opportunities (may be an excellent opportunity for the province to build capacity by finding opportunities for these experienced and well trained staff!).
- BC based weather reporting and other regional services will still be available through requests to Montreal.

As I mentioned yesterday we are developing an info note on the detailed impacts we see from this change. This represents not only a significant loss of capacity in BC, but the 23 person cut across the country means that EC will have little or no surge capacity in the event of a major spill to bring in responders from across the country. Vancouver EC staff handle many aspects of spills and share the current workload with our EEROs, therefore this represents a significant volume of work that our staff will now have to manage. Trying to provide the current level of service from

Montreal is not realistic. Basing their program in Montreal will significantly reduce EC's ability to meaningfully contribute and will present challenges in building and maintaining the strong relationships and familiarity required in emergency management. Current EC staff have found it challenging to respond to spills outside of their base in Vancouver, a move to Montreal will certainly increase these challenges many fold.

ISSUE: Impacts to BC Environmental Emergencies Program resulting from Environment Canada funding cuts.

BACKGROUND:

The Federal government has announced Environment Canada (EC) Environmental Emergencies Program will be reduced by 23 staff nationally with the complete elimination of the Pacific and Yukon Region (PYR) office. The province has been advised that PYR prevention, spill response and recover will be moved to Montreal leaving no representation in British Columbia. This transition will occur by June 2012.

- Preparedness and response activities in BC will be handled via telephone from Montreal.
- Response personnel will attend incidents only of national significance.
- The primary role of EC staff will focus on the coordination of science.
- The recovery aspect of emergency management will not be addressed.
- Policy and regulation development will occur in Gatineau, Que.
- Prevention, compliance and enforcement activities will continue to be delivered in BC.

EC and the Provincial Environmental Emergencies Program (EEP) are legislated for protection of human health and the environment from oil spills and hazardous materials spills. Impacts from spills affect the economy both locally and provincially.

Federal legislation and regulations for environmental protection and emergency response apply to numerous areas including First Nations, Federal facilities, railroads, pipelines, banks, airports and marine environments.

International Agreements and Contingency plans pertinent to BC, require the Regional Environment Canada official responsible for managing the regional environmental emergencies program to chair and coordinate the planning and response activities of the agreement.
