Thank you for your email of May 23, 2012, regarding whether individuals who are authorized to possess marihuana for medical purposes allowed to smoke marihuana in homes that have smoke free policies.

With regards to the consumption of marihuana for medical purposes in a smoke-free home, individuals who are authorized to possess and/or licenced to produce marihuana for medical purposes under the Marihuana Medical Access Regulations (MMAR) are reminded to abide by all other applicable federal, provincial, territorial or municipal legislation, therefore, municipal legislation pertaining to smoking in homes, may also apply to smoking marihuana for medical purposes. You may wish to review the relevant municipal legislation in your region or contact your municipal government and/or your provincial Residential Tenancy board for further information on use of marihuana for medical purposes in smoke-free homes.

Health Canada advises people who hold an authorization to possess to limit consumption to a private location to respect those around them who may be adversely affected by the consumption of second-hand smoke.

The science is overwhelmingly clear and there is no argument that breathing second-hand smoke can be deadly to human life.

We are aware of the BC Human Rights Tribunal cases for people living in apartment buildings and suffering health issues from second-hand smoke. We believe this is not enough to protect people only in work places and multiple-occupancy units. People can leave workplaces after a shift four or five times a week, but we cannot leave our homes where we spend most of the rest of our time. This makes legislation to protect people in their homes far more important than in workplaces only, or public parks.

And it is simply not acceptable to wait till some negative health response emerges (e.g. the asthma problem of the people in an apartment building). It is wrong to subject people to these experiments with a dangerous toxin, against their choice. Especially children and special needs people. It is wrong to wait until some health damage appears before taking protective action. We would not do this with arsenic or asbestos on that same list, claiming that we need to wait for some actual concern to become visible before we halt exposure to such toxins. The evidence is overwhelming of the damage second-hand smoke causes.

Any university ethics committee would not even countenance an experiment that threatened the health of subjects. They would not even pass an experiment that caused emotional trauma. Yet all over this province some 500,000 people are regularly subjected to second-hand smoke against their freedom to choose otherwise. This is entirely unacceptable and must be changed. Orange County in the US has now taken proper action and banned smoking on residential balconies and patios (http://www.ocregister.com/articles/smoking-288662-patios-city.html). This type of ban must be extended clearly to residential areas everywhere. It is not just about nuisance bylaws but about an overwhelmingly proven dangerous threat to human health.

We are not interfering with the freedom and rights of smokers to smoke. But an unquestioned principle that already exists in our societies concerns the economic principle of 'negative externalities'. No company or person is permitted to expel dangerous toxins into the air, water, or soil. And so it must be with second-hand smoke, a proven dangerous toxin in the same category as arsenic and asbestos. Smokers should not be allowed to expel this toxin into other's air or homes against their choice. We are all responsible for our own negative externalities. And we cannot violate the right of others to choose to be free from exposure to dangerous toxins. While people have the right to do all sorts of things in their own yards, our freedom does not include the freedom or right to endanger the health of others or to violate their rights and freedom to not inhale toxins. It is the same thing with any toxin on that same EPA list- asbestos, arsenic- we do not have the right to blow these into neighboring yards and homes and subject them to an experiment with their health against their choice. It astounds me that governing agencies do not get this simple and clear principle and take action to protect citizens from a proven dangerous toxin in the same category with arsenic and asbestos.

Someone has expressed this fundamental limit on personal freedoms in the statement that "your freedom to swing your arms ends where my nose begins". These are fundamental human rights issues.

And while "quiet enjoyment" is extended to smokers in their backyards it is not extended to neighbors that have to put up with their smoke (in their yards and inside their homes) against their choice. And remember, the smoker smokes outside to keep his home free of the stink but then stinks up the homes of neighbors.

We have politely asked our neighbors to smoke elsewhere to resolve this problem. They did for a short while then resumed regular smoking S22. To protect the health of our family we are planning on pursuing all avenues possible to protect our family such as applying to the BC Human Rights Tribunal, contacting a lawyer, offering proposed ban legislation at the municipal level, and so on (e.g. drawing media attention). But most important is for the province to enact legislation to protect the hundreds of thousands of people who suffer from exposure to this proven dangerous toxin that is in the same category as arsenic and asbestos.

And I have not even touched on the emotional stress of our family's exposure and living under the constant stress of not knowing when the next exposure will begin and how to take protective action. My own mother experienced years of stress in her apartment building going through the same problem with a smoker on a balcony below her. That gave us some insight into the impact this has on others. It is unbearable to live with this on a daily basis, with no choice over being exposed. People feel threatened but helpless to protect themselves and their families. I had no idea of the impact on people of the loss of a most basic freedom and right to protect the health of one's family. The smoker carelessly makes the choice to subject you and your children to danger and you have no choice in response, and this in your own home.

Let's be very clear this is not an issue of violating smoker's rights. To the contrary, this is about smokers violating non-smoker's rights to a safe and healthy life. Smokers violate such rights by not taking proper care when expelling their toxins into other's property and lungs. Let's be very clear on the direction of violated rights in these situations. This is not about picking on smokers or interfering with their rights to smoke in their own yards. It is about the right of all people to be free from harm and it is about the unwanted violation of that basic human right by others not taking responsibility for their harmful actions and intruding into others freedom and property in a proven harmful manner. Non-smokers are not whiners and complainers in this issue, sticking their noses into other's private activity. They are simply seeking basic protection in their own homes after suffering a violation by the carelessness of others. This is about taking protective action against an unwanted invasion of one's own property, health, and rights and basic freedom of choice. I cannot make this clear enough as smokers argue their rights are being violated. We are all responsible for our own negative externalities that we expel into other's property, homes and lives. Especially when these are proven dangerous toxins.

We will join any campaigns underway or needed to get going to press this critical matter of public health. But it is primarily up to the provincial government to act on this. The time is past for protective action on behalf of the citizens of this province. The science is overwhelming on the damage to human health from this dangerous toxin. My question is- what is the point of these varied government departments if they are not protecting their citizens from one of the most dangerous and widely experienced threats to their health.

Previous to our personal experience we were not fully aware of the damaging consequences of second-hand smoke, nor the fact that so many people are subjected to this harmful toxin and feel helpless to protect themselves and their families.

Medical marijuana use is a federal issue. Interestingly the *Tobacco Control Act* and Tobacco Control Regulation specifically references tobacco. All other types of smoke do not fall within the ambit of the legislation. The municipality bylaws may impact this issue but from a provincial tobacco perspective we do not have any jurisdiction over the marijuana issue.

Municipalities can have greater restrictions. The information does not say what area they were camping in or if it fell within the municipal bylaws. An example of a municipal bylaw is Vancouver which has the following restrictions:

Smoking prohibited in a park; on a seawall or beach in a park; in a building in a park (except in a caretaker's residence); in a customer service area (partially enclosed or unenclosed area including a balcony, patio, yard or sidewalk that includes the service of food or alcoholic drinks) in a park; in a vehicle for hire in a park; on public transit in a park; or in an enclosed or partially enclosed shelter in a park where people wait to board a vehicle for hire or public transit. The definition of smoking includes hookah pipes and other weeds or substances.

Hi Ilana

As I understand from the information below, the person whom the writer is complaining about is federally authorized to smoke cannabis for medical purposes. According to Health Canada' Marihuana Medical Access Regulations, authorized medical cannabis users are required to comply with local smoking by-laws, but are otherwise within their constitutional rights to smoke cannabis (i.e. no laws are being broken). My understanding of BC smoking by-laws is that BC Parks are not covered (except for smoking prohibition due to extreme fire hazard), so there is no legal basis for the objection.

This is really a complaint that should be directed to the federal government, which oversees rules and regulations for medical cannabis use.

I've cc'd Karen Parasram in Tobacco Control, just to confirm my reading of the BC smoking bylaws: http://www.health.gov.bc.ca/tobacco/communities.html

- Smoking is not permitted in any fully or substantially enclosed public place or workplace.
- Smoking is not permitted within 3 metres of most public or workplace doorways, open windows, or air intakes (i.e. a "buffer zone").
- Substantially enclosed transit shelters are smoke-free.
- Common areas of apartment buildings, condominiums and dormitories are smoke-free.
- Tobacco use of any kind, including smoking, is banned on all public and private K-12 school grounds.
- In motor vehicles when youth under 16 years of age are present.

Abstract

The availability of smoke-free multiunit dwellings is severely lacking. This study identified a number of science-based and legal misperceptions that may prevent the adoption of smoke-free policies. 



Dear Honourable Dr. MacDiarmid,

As you are ewere, second hand smoking has a huge negative effect to those who do not smoke. As a non-smoker, I take pride for taking good care of my body and family.

Living in a townhouse unit, I am well within arms reach to my neighbour's entrances and yards.
Unfortunately, both my neighbours are smokers. One is kind enough to only smoke at the back, but the other one just lights up wherever she prefers, whenever.

I did some research, and found by smoking in her balcony, front and back yards, she is actually violating 8C Tobacco Act, Vancouver City By-Law and BC Strata Property Act. Unfortunately, none of the acts or by-law actually enforces the policies and this allows thousands of smokers in BC causing nuisance and hazard to their non-smoking neighbours. A simple search on Google shows many residences complained about similar issue, yet the ones causing hazards to others still continue their acts.

Please, it is time to update Tobacco Act and allow law enforcements, whether Federal, Provincial, or Municipal to actively catch and fine these offenders. We have traffic enforcement officers proactively catching violators to reduce risk of traffic accidents that kill innocent people. By the same argument, we also should have similar enforcement in place since second hand smoke kills, too.

Thank you for your letter dated July 11, 2012, regarding, banning smoking in residential homes. The Honourable Michael de Jong, QC, Minister of Health, has shared your email with me and I am happy to respond on his behalf.

In British Columbia, the *Tobacco Control Act* sets a minimum standard for work/public places that all facilities must meet. The Act bans smoking in common areas of apartment buildings, condominiums and domitories.

Provincially smoking is banned in the following places:

- Smoking is not permitted in any fully or substantially enclosed public place or workplace.
- Smoking is not permitted within three metres of most public or workplace doorways, open windows, or air intakes (i.e. a "buffer zone").
- Substantially enclosed transit shelters are smoke-free.
- Tobacco use of any kind, including smoking, is banned on all public and private K-12 school grounds.
- In motor vehicles when youth under sixteen years of age are present.

Smoking is restricted in a person's home when it is another person's place of work. If workers or service providers, such as homecare workers and trades people, come to work inside your home, WorkSafeBC advises that smoking stop one hour before they arrive.

A municipality, health authority, post secondary institution, or owner of a work or public place may have more restrictive requirements in place, if they wish. For example, the City of Vancouver's bylaw prohibits smoking on or within six metres of a customer service area (includes all patios regardless of whether or not they are covered by a roof); within six metres of entrances, windows that open and air intakes; in an enclosed or partially enclosed shelter where people wait to board a vehicle for hire or public transit.

At this time, government does not anticipate any ban on smoking inside private residences, or drifting smoke in multi-unit dwellings.

Thank you for your email dated July 20, 2012, regarding banning the sale of tobacco in BC. The Honourable Michael de Jong, QC, Minister of Health, has shared your email with me and I am happy to respond on his behalf. It is always difficult to see your family hurt by smoking.

You are correct when you state that there are serious health risks from tobacco use. The province, in recognition of these health risks, has banned smoking in the following places:

- Smoking is not permitted in any fully or substantially enclosed public place or workplace.
- Smoking is not permitted within three metres of most public or workplace doorways, open windows, or air intakes (i.e. a "buffer zone").
- Substantially enclosed transit shelters are smoke-free.
- Common areas of apartment buildings, condominiums and dormitories are smoke-free.
- Tobacco use of any kind, including smoking, is banned on all public and private K-12 school grounds.
- In motor vehicles when youth under sixteen years of age are present.

In addition BC's Tobacco Control Act sets a minimum standard for work/public places that all facilities must meet. A municipality, health authority, post secondary institution, or owner of a work or public place may have more restrictive requirements in place, if they wish. For example, the City of Vancouver's bylaw prohibits smoking on or within six metres of a customer service area (includes all patios regardless of whether or not they are covered by a roof); within six metres of entrances, windows that open and air intakes; in an enclosed or partially enclosed shelter where people wait to board a vehicle for hire or public transit.
