In British Columbia, legislation bans smoking in indoor common areas (e.g. hallways, laundry rooms) of apartments and condominiums but smoking is not banned within the private units of those buildings. At this time, government does not anticipate bringing in a ban on smoking inside private residences. However, this does not mean that smoking must be allowed in these units. An owner or landlord in such a building can take steps, over time, to make private units non-smoking. For example, all new rental agreements can state the apartment is smoke-free. As smokers move out of their units, the new tenant's agreement can state that smoking is not allowed and the building gradually moves to smoke-free status.

It appears from your email description that you have taken this up with the building's management and they attempted to come to some arrangement with the smoker only to have another smoking tenant move into the same apartment. In spite of this, you may raise the issue of new rental agreements containing a smoke-free clause. You may wish to look at the 'tenants' section of the Smoke-Free Housing BC website <a href="http://www.smokefreehousingbc.ca/">http://www.smokefreehousingbc.ca/</a>. It is an excellent resource for owners, managers and residents wishing to get information about a smoke-free environment. We hear many positive reports as to the usefulness of this site as more landlords, tenants and strata associations find success in increasing their smoke-free units.

I have taken the liberty of sharing your letter with my colleague, the Honourable Rich Coleman, Minister Responsible for Housing, so that he can hear of your experiences in dealing with the harmful effects of second-hand smoke. Your letter ably demonstrates the value of smoke-free housing and I hope that throughout BC, we see owners and managers increasing their smoke-free homes.

Thank you for your email dated March 12, 2013, in which you request clarification on provincial smoking regulations related to smoking in hotels. Your email has been forwarded to me and I am happy to respond.

The tobacco control legislation allows hotels to designate smoking and non-smoking sections. Guests who smoke are given a specific hotel room in which smoking is allowed and those rooms will be solely for the use of smoking guests. Similarly, specific hotel rooms or a majority of the rooms in a hotel can be non-smoking and these would be solely for the use of non-smoking guests.

As you have correctly stated, the Tobacco Control Act bans smoking in the following places:

- Smoking is not permitted in any fully or substantially enclosed public place or workplace (includes restaurants).
- Smoking is not permitted within three metres of most public or workplace doorways, open windows, or air intakes (i.e. a "buffer zone").
- Common areas of apartment buildings, condominiums, hotels and dormitories are smoke-free, as they are considered public or work places (includes lobbies and hallways).

## Costly clean-up for smoking in MUDs:



- Costs 3 to 4 ½ times higher than non-smoking units:


### SMOKE-FREE POLICIES

# Smoke-free policies can mean large savings:



- 2103 study by US Centers for Disease Control and Prevention:
  - » \$521 million = annual costs savings of eliminating smoking in public housing:
    - \$321 million health costs
    - \$108 million renovation costs
    - \$72 million smoke-related fire loss





### SMOKE-FREE POLICIES IN BC



### Smoke-free policies in BC:

- Strong demand for smoke-free housing in BC
- Some evidence in BC and elsewhere of willingness to pay higher rents
- In a renters' market, MUDs without smoke-free policies may be bypassed.





### LECAL AND ADMIN COSTS

## Smoking and lack of smoke-free policies mean:



- Legal and admin problems for landlords and strata boards:
  - » More than three hundred disputes to Residential Tenancy Branch since 2009.
  - » Growing number of human rights complaints
  - » BC Human Rights Tribunal precedent \$8000 award to BC couple in 2012
- Insurance premiums may rise in the future





## SMOKING IN MUDS-CONCLUSIONS (1)



- Significantly higher clean-up/renovation costs
- Lower property values
- Longer times to rent or sell
- BC consumers support smoke-free policies and prefer smoke-free units





## SMOKING IN MUDS-CONCLUSIONS (2)



- Admin, legal and insurance costs may rise
- Clear smoke-free policies can help
- Need for BC-based research

#### SMOKING IN THE HOME

### Smoking in the home is rare in BC:



- 32% of MUDs smokers, smoke in the home
- 25% of all MUDs residents allow smoking in their residence or property
- 6% or 50 of 833 allow smoking in a room of the home





### SMOKING - RENTERS/OWNERS

 More than twice as many renters than owners smoke: 19% compared to 8%



- But exactly the same proportion smoke in their home: 32%
- The same proportion of renters and owners allow visitors to smoke in their home (25% and 26%)





### SHS EXPOSURE

 50% of MUDs residents report exposure to SHS



• 59% see SHS as a health hazard

47% see SHS as a nuisance.





#### **COTHERED BY SHS**

 Nearly 40% of all MUDs residents were bothered when SHS odors got into their residence:



- 2% moved
- 8% considered moving
- 28% bothered quite a bit, but not enough to move.
- 36% bothered somewhat





### **DEMAND FOR FRESH AIR**



### A strong desire to live smoke-free

- Nearly 2/3rds prefer a completely smoke-free building
- 2/3rds or more support:
  - » Converting rentals to smoke-free
  - » More condos having smoke-free bylaws
  - » Prohibiting smoking in their own buildings





### THE RIGHT TO KNOW

### Huge Majorities believe they should know:



- If smoking is permitted in the building or on balconies (96%)
- Which units are designated smoking (90%)
- If a previous tenant was a smoker (87%)
- If there have been past complaints about SHS (85%)





### MUDS RESIDENTS NEED SUPPORT



- Large majority never complain about SHS
- Only half who complain are satisfied with response
- Less than 1/3 have a formal way to complain
- More than half reported there was no, nosmoking policy for their building
- Less than half said there should be a formal way to address complaints





### REGIONAL VARIATIONS





- North varied somewhat:
  - » More smokers and more smoke in the home
  - » More saw SHS as a health hazard
  - » Fewer felt SHS something to worry about
  - » Fewer preferred living in a smoke-free building
  - » More supported decision to prohibit smoking in their building



First, we have two programs that I am involved with.

The VCH Mental Health and Addictions Tobacco Treatment Program (formerly the TDC's and Butt Out, now in the process of merging) sees clients who have mental illness and/or substance use disorders. The majority are on some kind of income assistance and often live in rooming houses, recovery houses etc. Many also live independently.

The VGH Smoking Cessation Clinic is based in the hospital and sees a slightly different population. Most of these individuals have medical co-morbilities and are referred mainly by other hospital disciplines. (Of course many also are marginalized and have MH or SUD as well).

So there isn't a single answer to your question but I would say that the majority of clients we see have multiple barriers to success but the intensity of the programs lead to very good outcomes.

Please let me know if you wish to speak some more about this.
