The ministry is in the news today further to steps it has taken in response to an internal investigation underway since May 2012.

The investigation has been looking into allegations of inappropriate conduct and practices in areas including data management / access and contract management involving ministry employees.

This is a very serious matter, and I want to assure you that we are doing everything possible to ensure a full investigation. The ministry has notified the RCMP of this matter, and will cooperate with the RCMP in its investigation.

We have strong internal policies and practices in place to prevent incidents of this nature from occurring, but it's very important that these be followed.

This is a very disappointing situation for the ministry and for me personally. A foundation for our ministry is our reputation for ethical conduct, integrity and fairness. Each of us, through our daily decisions and actions, helps shape the culture of our workplace. And, we have a shared responsibility for protecting the ministry's reputation and assets.

While this is, of course, an issue of considerable concern, I would not want you to think it negates the excellent and ethical work that goes on here at the ministry.

Our next Town Hall meeting is Monday, September 10, and the executive team and I will be there to answer your questions on this and other topics.
