# Police - Provincial Police Service Review

### SUGGESTED RESPONSES:

- We need to be clear, the report is not finalized, so it cannot be released at this time.
- It is a review of how government oversees the RCMP contract – not a review of the RCMP.
- Decisions around severing on FOI Requests are made by professional public servants, and are in line with exceptions under the Freedom of Information and Protection of Privacy Act
- This report was done to review how we were managing the previous RCMP contract. As such, it was one significant component in determining the terms we sought in the new agreement, particularly around accountability.
- For example, under the new agreement we have significantly increased financial and operational reporting, established a new management committee structure that is consulted before decisions are made and we now have the ability to conduct reviews of programs, including national programs.

### IF ASKED:

 When the report is finalized, we will need to look at it to see if there are any FOIPPA concerns as we consider a public release.

### BACKGROUND:

On October 9, 2012, responding to FOI request JAG-2012-01158 for "A copy of the RCMP Audit" by a political party, Information Access Operations (IAO) recommended withholding access to this document in its entirety. The report, which is a review of the previous Provincial Police Service Agreement, has not been finalized, and was prepared for submission to Treasury Board.

IAO recommends that the enclosed records be withheld in their entirety pursuant to sections 13 (Policy advice or recommendations), 16 (disclosure harmful to intergovernmental relations or negotiations) and 17(disclosure harmful to the financial or economic interests of a public body) of F01PPA.

IAO recommends following OOP's recommendation concerning the application of section 12 (Cabinet confidences) of FOIPPA, when it is provided. On July 17, 2012, MLA Corrigan wrote to the Minister, requesting a copy of the report.

The final draft of this report is with Internal Audit. It will go to chair of Treasury Board who signs as "accepting" the report, probably in the fall. It then goes to cabinet for approval after which it will be determined whether it can be made public under FOIPPA guidelines.

On Oct. 4, 2011, in the Times Colonist, NDP leader Adrian Dix urged the Province to release a 'secret audit' of the RCMP so taxpayers can have an informed debate on whether a provincial police force would be cheaper and more accountable than renewing a 20-year contract with the Mounties (full story below). Earlier, in October 2010, the BC Civil Liberties Association requested from PSSG a copy of the RCMP 'audit' report and all related correspondence under the Freedom of Information and Protection of Privacy Act.

The Office of the Comptroller General, Ministry of Finance, has conducted a Provincial Police Service Review, but it is not an 'audit' of the RCMP – rather, it is a review of provincial oversight by Police Services Division (PSD) of the RCMP contract. The draft document is dated May 2010.

The purpose of the review is to determine whether roles and responsibilities are defined, understood, appropriate and allow the province to direct the services' priorities and strategic direction, and whether the province's policing expenditures

are effectively controlled and monitored to ensure that they are appropriate and the province's priorities are achieved. In addition, the review was to identify and recommend options to reduce provincial police service contract expenditures.

The B.C. Civil Liberties Association says the provincial government is refusing to release the results of the review (they refer to it as an an audit of RCMP services.) The BCCLA received a letter from the OIPC (dated August 15, 2011) denying a release of the report saying it is in draft format and although it has been prepared for Treasury Board or Cabinet, neither body has had the opportunity to review the record or deliberate on its contents. The BCCLA issued a news release saying the information should be made public before a new RCMP contract is signed.

The BCCLA has previously requested all correspondence and reports relating to any audit findings or proposed audits. Records responsive to the request were located; however, Nov. 5, 2010, the BCCLA was informed that the records are being withheld in their entirety pursuant to sections 13 (policy advice or recommendations), 15 (harm to law enforcement), and 16 (harm to intergovernmental relations or negotiations) of the Act.

On Aug. 25, 2011, PSD became aware, through the media, that on Aug. 15, 2011, the Office of the Information and Privacy Commissioner (OIPC) responded to BCCLA's written request for the OIPC to review a decision by the Ministry of Finance to withhold information regarding the "audit" under section 12(1) (information on deliberations of the Executive Council including advice, recommendations, policy considerations or draft legislation).

The BCCLA went to the media again arguing for the release of the review. Global News reported that under BC law, once a report is reviewed by cabinet, it must be made public. Global said when he was solicitor general, Kash Heed asked for the audit because he knew BC had to make a big decision--to stick with the RCMP or create a provincial police force. Heed was quoted by phone in the story: Kash Heed: "Certainly it was incumbent upon government to make sure we were getting value for our dollar. We needed to know what was going on with respect to the RCMP here in British Columbia."


### **Current Status**

A number of drafts of the report have flowed from the field work by internal audit staff, which has included discussions with and data collection from numerous RCMP and Police Services Division staff. The review remains in draft format and needs to be reviewed and discussed internally; it won't be finalized until approved by Treasury Board.

#### RCMP audit has not been disclosed to Cabinet

The BCCLA has been notified by the Office of the Information and Privacy Commissioner that the audit of B.C.'s RCMP has not been given to Cabinet or to the Treasury Board, despite the fact that these bodies are on the verge of signing another 20 year agreement with the force.

We can only imagine that the point of this audit, which is almost a year old now, was commissioned to inform the government on how to ensure the best quality policing for B.C.," said Micheal Vonn, Policy Director of the BCCLA. "How is it that B.C.'s Cabinet and Treasury Board have not yet received a copy of it, given that they're on the verge of signing a single-source, multi-billion dollar, 20 year contract with the RCMP?"

The decision, issued by an analyst from the Office of the Information and Privacy Commissioner, reads as follows:

### ADVICE TO MINISTER

The Ministry states that all audit reports, other than ad hoc and forensic ones, are presented to both Treasury Board and Cabinet for deliberation. The Ministry tells me that the record is currently in draft format. It has been prepared for Treasury Board or Cabinet. I understand that neither body has yet had the opportunity to review the record or deliberate on its contents.

\*Once the contract is signed, it's too late to read the audit and realize what should have been included in the contract," says Vonn. "This audit needs to get to Cabinet and Treasury Board urgently, and before B.C.'s signature goes on the dotted line."

The BCCLA will be appealing the decision to refuse to disclose the audit pursuant to an FOI request made by the BCCLA for the audit, which the organization first learned about in October of 2010.
