Sorry again for the delayed response – s.22

If you do have to boil it down to a single number then 108 FTE's would be the overall total. That being said, I also want to point out that unlike other natural resource C&E program areas (e.g. COS or FLNRO NRO's), our FTE numbers don't reflect the time staff spend on C&E duties and responsibilities. While all staff who are designated as park rangers are trained and certified to undertake C&E duties, these staff only spend a portion of their time working directly on C&E business (other areas of responsibility include permit administration, facility management, public safety, etc. etc.). The amount of time also varies greatly by position depending on priorities and pressures in their specific area of responsibility. For example a ranger in the lower mainland may spend more time working on C&E issues than a backcountry ranger in the north.

This is my reluctance to suggest a single number captures the essence of our C&E program as the number doesn't describe a very clear picture of our operational responsibilities. As long as there is a way to describe this in the profile then using the 108 FTE's as a proxy is ok.

Hi Greg,

No problem providing the numbers, but best not to mix the 2 numbers of fte's (permanent and seasonal). Reason being our seasonal allocation can fluctuate (although it hasn't over the past six years) based on seasonal fte budget allocation. I would keep the numbers in terms of 70 permanent and 90 seasonal positions as this provides the best indication of number of C&E positions in BC Parks.

Here are the numbers for BC Parks:

BC Parks employs approximately 160 park rangers of which approximately 70 are permanent and 90 are seasonal employees (38 seasonal FTE's). These numbers break down by position as follows: 10 Parks and Protected Area Section Heads, 49 Area Supervisors, 39 Senior Park Rangers (incl. 29 seasonal positions), 58 Park Rangers (all seasonal) all have park ranger authority.

Here is some context in terms of the enforcement role park rangers perform. Park rangers, as appointed Pursuant to section 4(2) of the *Park Act* (See attached Appointment Letter), are the enforcement arm of BC Parks. Their mandate includes providing enforcement and investigative services in support of environmental legislation related to protected areas management. They are responsible for enforcing a number of provincial and federal statutes, including: the Park Act, Ecological Reserve Act, Wildlife Act, Liquor Control and Licensing Act, Firearm Act, Motor Vehicle Act, Offroad Vehicle Act, Trespass Act, Canada Shipping Act – Vessel Operation Restriction Regulation.

Some park rangers also carry additional appointments as Auxiliary Conservation Officers (pursuant to Section 106(3)(b)(ii) of the *Environmental Management Act*) and/or Natural Resource Officers (pursuant to Section 2 of *Natural Resource Compliance Act*).
