Dear Mr. Doyle, dear Mr. Dyble,

First, congratulations on the recent BC Provincial election and majority mandate provided by the people of British Columbia. FPInnovations has developed, over the years, a very good working relationship with the BC government, and we sincerely hope that this public-private partnership will continue to grow in the future.

I would like to bring to your attention a letter that FPInnovations sent in February 2013 to the Minister of Advanced Education, Innovation and Technology (MAEIT) in which we requested continued funding of the FPInnovations BC Bio-Economy R&D Program. This request was supported, in writing, by senior forest industry executives of the BC Bio-Economy Transformation Council (see document attached). We also understand that the executive staff from the Ministries of Forests, Lands and Natural Resource Operations (MFLNRO) and Jobs, Tourism and Skills Training (MJTST) are advocating such funding, based on their experience and previous participation in this results-driven R&D Program.

It is important to note that on April 3, 2013, the Minister of FLNRO provided a positive response to this request in a letter to industry in which you were copied (see attached).

This letter is following up on this recent exchange of communications. FPInnovations is requesting your direct involvement in securing full funding (\$1,215,000) of the BC Government contract with FPInnovations to continue the BC Bio-Economy R&D Program. Further, to ensure optimal value and improved coordination, we propose that this investment in the BC Bio-Economy be guided via the interests and expertise of the BC MFLNRO during the 2013/14 fiscal year.

In addition, it should be noted that the BC R&D funding for this contract is matched and leveraged by Federal investments through FPInnovations. The following are the key objectives of the Program:

- Maximize sustainable utilization of wood biomass to support a vibrant 21st century bioeconomy in British Columbia
- Technology Transfer to enable investment via business and communities collaboratively linked to the resource economy
- Develop, pilot and guide implementation of novel bio-products for BC's competitive advantage and highest return for its resource
- Design and engineer solutions for advanced building systems to support development of environmentally superior, cost-effective, tall wood for commercial, residential and institutional buildings.

These focus areas are directly linked to recent BC Forest Policy Reports, Ministry strategic plans and the interests of the commercial sector.

The program is already achieving measurable progress in the development of the bio-economy in British Columbia, and its related jobs, communities and GDP contribution. Here are some examples:

- Identified and now developing the five most competitive bio-economy product platforms for the BC Bio-Economy - a potential \$200 billion global market
- Developed and now piloting a new technology tool kit for resource inventory assessment and economic delivery of wood biomass to processing locations - meeting the environmental goals of best fibre application and utilization
- Research, design and maintenance of wood and integrated wood building systems construction guides/codes and standards for Canadian and US architects and engineers for tall commercial institutional and residential wood buildings. This is potentially as significant to the BC economy as the development of the China market for BC wood products (a 50% penetration of the greater than six-storey building construction market in North America represents 3.5 billion bf/yr expansion for wood product).

There is very aggressive global competition in the bio-economy field. British Columbia needs to act quickly in order to maintain its competitive position and fully realize its opportunities.

If you are interested, my colleagues and I would be pleased to meet with you to discuss how we can further advance this program and our overall partnership in the development of a socially, economically and environmentally responsible BC Forest Resource Economy.
