

Dear Yinka Dene Alliance members:

Thank you for your letters of May 17 and June 4, 2013 wherein the members of the alliance communicate their concerns about the proposed Enbridge Northern Gateway Pipelines project (ENGP). I am following up on the Premier's response of May 24, 2013 as the newly appointed Minister of Aboriginal Relations and Reconciliation.

As you know, the project is currently the subject of a federal government Joint Review Panel (JRP), during which the Province submitted detailed questions to ENGP to understand if the project would meet British Columbia's heavy oil conditions.

After a thorough review and cross examination on May 31, 2013, provincial representatives have submitted British Columbia's final written arguments. It is the Province's assessment that ENGP responses during the JRP were not adequate and that British Columbia does not support the issuance of a certificate for the proposed project. Dear Premier Clark,

The BC Mètis Federation writes to thank you on behalf of our board, partner communities, and 6500 Métis members from throughout BC with the announcement made earlier today by Provincial Environment Minister Honourable Terry Lake rejecting the proposed Enbridge Northern Gateway Pipelines Project primarily for environmental concerns.

The large majority of Métis people in British Columbia have also rejected this project for three specific reasons:

- 1. Improper Métis consultation
- 2. Overwhelming rejection by First Nations
- 3. Proposed benefits not worth the environmental risk.

The BC Métis Federation appreciates the alignment on environmental concerns related to this project and this is a step forward together.

As such we continue to urge the Provincial Government to review the incongruence between the Métis Nation British Columbia (MNBC), an organization your government has continued to identity as the Provincial representative for Métis people in BC, and your government priorities and values.

BC Métis Federation has continued to advance our concerns to your government about a number of issues related to MNBC and the Enbridge Northern Gateway Pipelines Project was one of several issues. MNBC has misrepresented the interests and concerns of Métis people regarding this project and in May 2012 sent the attached communication about why MNBC supported the proposed Enbridge Northern Gateway Pipelines Project. The MNBC correspondence suggests MNBC reviewed all issues including environmental. Therefore in light of the environmental concerns expressed by the Provincial Government earlier today, we urge your government to understand that this issue is only one of many to further reinforce, demonstrate, and validate our concerns in how MNBC has been misinforming and misrepresenting the interests of Métis people in BC. MNBC and their supporters were simply trying to make a cash grab through a proposed equity deal at the expense of legitimate Métis community concerns or conducting proper Métis consultation. MNBC has used these industry projects as revenue generation under the impression that they will ensure proper community consultation. It was clear that despite hundreds or thousands of dollars in consultation resources funded by governments and Enbridge in relation to the proposed project, MNBC did not completed the work with their members and communities and their announcement was not supported by the vast majority of Métis people in BC.



I hope your office and government can come to better understand why the BC Métis Federation formed and why it is important that your government understands we share many similar values and outcomes. This Provincial Government announcement demonstrates that we share very similar views and we hope can be the start of a new relationship.

In closing thank you once again for this leadership. We understand the Joint Review Panel will continue their process regardless but together we can all make a difference to stop this project for the sake of the environment and all British Columbians.

Aboriginal Ownership Agreement

I am privileged to advise that the Board of Directors of the Metis Provincial Council of British Columbia has agreed to confirm the Enbridge Northern Gateway Project Aboriginal Ownership Agreement, and to take advantage of an equity ownership interest in the Northern Gateway Project Limited Partnership. By accepting this agreement, MPCBC now becomes an Aboriginal Ownership Partner in the project and will share in revenue once the project is completed and operating. Metis citizens and businesses in British Columbia will also be able to directly benefit through job opportunities, skills development and the issuance of millions of dollars in the provision of service contracts during the pre-construction and construction phases respectively.

This decision was taken after carefully considering all aspects of the project, including environmental, economic and social. It was also recognized that Metis citizen and Metis community input on the proposed project has been underway since 2009 through a process facilitated by MNBC staff. A community advisory meeting held earlier this month in Richmond and attended by delegates on behalf of most of the MNBC Chartered Communities in British Columbia, plus representatives of BCMNR, provided an excellent opportunity for all attendees to ask any and all questions of the representatives of Enbridge and receive answers back. Members of the MPCBC Board in attendance listened very carefully to the questions asked and answers given. That information exchange combined with all of the other discussions that have taken place with citizens and community leaders over the last few years helped inform members of the Board about not only the proposed project, but also of the views of many Metis citizens.

In agreeing to become an Aboriginal Ownership Partner in this project there is no cost to MPCBC nor is there any liability in doing so, but there will be significant benefits for Metis citizens and businesses during the life of the construction project and for years following. Being on the inside working with the company on all aspects of the project, including ensuring adequate safeguards are in place for the environment, and generating economic opportunities for our people is much preferred over being simply another critic on the outside and gaining absolutely nothing for Metis citizens.

The leadership shown by the MPCBC board in making this challenging decision represents a valuable step towards providing for the current and future needs of the MNBC and Metis citizens of British Columbia and the continued strength of the Metis Nation.

Re: Cease and desist order for investigative field work activities related to Enbridge Northern Gateway pipelines

We are the Chiefs of the Yinka Dene Alliance. Since the time the Enbridge Northern Gateway pipelines and tankers project was announced, we have told you plainly that we will not allow your project to cross our territories. We stand firm in this. Our Indigenous laws forbid the transport of toxic bitumen through our lands. It is our responsibility to protect the salmon in our rivers and to keep the waters clean for future generations. The *Save the Fraser Declaration* states our legal position unequivocally. We have made our decision against your project abundantly clear, and we are quite certain you are aware of it. Now Enbridge has sent correspondence to one of our nations, Nak'azdli, indicating an intention to proceed with work related to the Northern Gateway pipelines in their territories, and to seek related provincial permits and approvals.

We are writing to put you on notice that any entry onto our lands in relation to the Enbridge Northern Gateway pipeline will be considered an act of trespass.

This is your final warning to refrain from unwanted activity on our lands. If you fail to heed this warning, you will be in breach of our laws and can expect to face legal consequences. We will proceed against you with enforcement actions and will seek appropriate remedies. We trust that you will communicate this information to your employees as well as to your affiliates and to all contractors hired to conduct work on your project.



Re: <u>Constitutional obligation to consult on establishment of a new industry – British</u>
Columbia Liquefied Natural Gas Export Industry

I am writing on behalf of Wet'suwet'en First Nation to request a meeting with you in Vancouver during the week of September 9-13th, 2013. The purpose of this meeting is to begin Crown consultation regarding strategic planning and high level decision-making in relation to government plans to promote and develop a new British Columbia liquefied natural gas export industry (new LNG export industry).¹

The start of a new LNG export industry is a <u>unique and rare opportunity</u> to develop a resource strategically, with a broad and long view, to provide economic benefits, fulfill environmental responsibilities and honour Constitutional obligations to consult and accommodate Wet'suwet'en First Nation in the establishment of a new industry.

The balance of my letter sets out the reasons for this meeting request.

¹ Please note that this Crown consultation is separate and distinct from Crown consultation regarding individual pipeline applications.

New LNG Export Industry is an unprecedented high priority economic opportunity

Since the re-election of your government on May 14th, 2013 and your re-election on July 10th, 2013, you have made establishment of a new LNG export industry a very high priority by

- appointing Deputy Premier Rich Coleman as Minister of Natural Gas Development,
- · establishing a new ministry for the sole purpose of natural gas development,
- · making natural gas development a priority issue in other BC government ministries,
- planning an Asian LNG trade mission.

The June 2013 BC Ministry of Finance Update to the Budget and Fiscal Plan 2013/14 – 2015/16 re-confirms the exceptional outlook for this new LNG export industry:

British Columbia has an unprecedented economic opportunity and the potential for significant increases in revenues from liquefied natural gas (LNG) development. The revenue can be used for the benefit of all British Columbians, both now and in future generations.

Independent experts retained by the BC government forecast that the new industry will bring in between \$4.3 billion and \$8.7 billion in extra government revenues each year.

Supreme Court of Canada mandates Crown consultation on strategic, higher level decisions

When establishing a new industry to be built upon and affecting lands and resources claimed by First Nations such as the new LNG export industry, the scope of the Crown's duty to consult is not limited to the individual and incremental decisions along proposed pipeline routes, the related regulatory permitting or physical impacts.

The duty to consult transcends this. The Crown's duty to consult requires high level consultation about what resources should or will be exploited, by whom and how.

The Gitxsan and Wet'suwet'en brought the landmark aboriginal title case of *Delgamuukw v. The Queen*, [1997] 3 SCR 1010. In that decision, the Supreme Court of Canada held that aboriginal title encompasses the right to exclusive use and occupation of the land and the right to choose to what use the lands are put.

The Supreme Court also recognized that aboriginal title has an "inescapable economic component" and the uses of the land are not restricted to traditional uses. Aboriginal title includes the right to exploit the land and resources "for a broad variety of purposes" to meet the general welfare of the First Nation and present-day needs of the aboriginal community.

These fundamental statements by the Supreme Court of Canada about the nature of aboriginal title also apply to the nature and scope of consultation required when the Crown contemplates initiatives and activities that engage lands subject to aboriginal title or assertions thereof.

The "duty to consult extends to "strategic, higher level decisions" that may have an impact on Aboriginal claims and rights" (*Rio Tinto Alcan v. Carrier Sekani Tribal Council* 2010 SCC 43, para. 44). The Supreme Court of Canada lists examples of the sorts of high level strategic planning initiatives that require high level consultation—in our view, the proposed new LNG industry in British Columbia is just this sort of an initiative.²

Wet'suwet'en First Nation has a direct interest in the new LNG export industry

Our Nation asserts aboriginal title over lands (aboriginal title lands) that will be directly impacted and necessary to the new LNG export industry. Please refer to the attached map of aboriginal title lands.

In so far as the new LNG export industry depends upon pipeline transport through the core of the lands to which we claim aboriginal title, we must be appropriately consulted about this significant proposed new land use and its implications for our community. This goes beyond Crown consultation on individual pipeline proposals. The new LNG export industry is a unique and rare circumstance involving high level strategies and decisions to establish a new industry on aboriginal title lands.

We are currently aware of three potential projects that involve transporting natural gas by pipeline laid through our aboriginal title lands in proximity to our Indian reserves. Based on your public statements and the government's plans, we recognize that these pipeline projects are integrally connected to government initiatives to promote and develop the new LNG export industry and, based upon these initiatives, will likely be followed by further proposals to use our aboriginal title lands.

Our aboriginal title includes the right to choose the use to which our aboriginal title lands are put, and the right to the use and benefit of the land and resources within those lands. Failure to consult and develop a model of shared decision making with us would "be to deprive the Aboriginal claimants of some or all of the benefit of the resource. That is not honourable": Supreme Court of Canada, *Haida Nation* para. 27.

Crown consultation on the new LNG export industry must take place before, not after, the new industry is established

Over the past year, your government has released at least three strategy documents related to the development of the new LNG export industry and as noted above, since your re-election in July 2013, establishment of this new industry has been made an even higher priority.

² The examples listed by the Court include: a) the transfer of tree licences which would have permitted the cutting of old-growth forest, b) the approval of a multi-year forest management plan for a large geographic area, c) the establishment of a review process for a major gas pipeline, and d) the conduct of a comprehensive inquiry to determine a province's infrastructure and capacity needs for electricity transmission.
(B.C.U.C.))."

Wet'suwet'en First Nation has not been consulted on the establishment of this new LNG export industry.

The Supreme Court of Canada's decision in *Haida Nation v. British Columbia*, 2004 SCC 73 made clear, the Crown cannot unilaterally take up and manage our lands pending resolution of our claims. Proceeding unilaterally, the government:

- deprives our Nation of choosing the use to which our land can be put;
- · deprives our Nation of the use, value and benefit of our aboriginal title lands;
- deprives our Nation of using our lands for the modern needs of our community;
- is much more likely to cause negative physical impacts to the lands, resources and environment on our aboriginal title lands.

Premier, you have said that a new LNG export industry in British Columbia "is right around the corner," and that companies that want to participate must get "in the game now." Therefore we seek consultation now, before any meaningful participation in the choices and planning for our aboriginal title lands is effectively eliminated.

Our people suffer to this day from the direct and incidental effects of government policies and industrial development established without prior consultation. Let us work together to avoid the repetition of this province's past, that is, a history where lands and resources were unitaterally taken up, without prior consultation, for the primary or exclusive benefit of a population that excluded indigenous people.

Proposed Meeting Agenda and Timing

We request that Crown consultation on the establishment of this new LNG export industry commence immediately.

Recognizing the speed with which you hope this new industry will develop and the need for meaningful Crown consultation, we ask for a meeting with you in Vancouver during the week of September 9-13th, 2013. At this first meeting we wish to discuss the establishment of a consultation process that will address:
