



Recommendation

GCPE to provide response on background from Ministry of Finance, not for direct attribution to an individual but may be attributed as information provided by the B.C. Ministry of Finance.

1) Why was the decision made not to allow BC hotels to have VLTs on premises, in contrast to the policies of Alberta, Saskatchewan and Manitoba?

Video lottery terminal (VLT) is another name for an electronic gaming machine (EGM) or slot machine. The difference between VLTs and EGMs are that VLTs are located outside of gaming facilities, usually in pubs and bars that are licensed to serve alcohol. B.C. is one of two provinces, along with Ontario, that does not have VLTs.

In B.C. EGMs are only permitted in dedicated gaming facilities (casinos and community gaming centres) where trained staff are able to monitor players and potentially identify problem gambling. This also facilitates an effective Voluntary Self-Exclusion (VSE) program because individuals who want to self-exclude from gambling can be restricted from gambling by prohibiting their access to gaming facilities. In jurisdictions where VLTs are available in pubs, bars, and other establishments, it is not possible to restrict people's exposure or access to these high-risk forms of gambling.

EGMs and VLTs are known to be higher risk than other gambling activities because of game features such as the speed of play and the illusion of control. While EGMs generate the greatest amount of revenue, they also pose risks to people who are at-risk for problem gambling. The most recent problem gambling prevalence study carried out by the Gaming Policy and Enforcement Branch (GPEB) in 2014 found that moderate and high-risk problem gamblers make up an estimated 3.3% of British Columbians (approximately 125,000 people). Cwy: Which has declined since the prior survey – you may want to note the decline

3) Is there any chance of the policy being modified in the foreseeable future? Other provinces talk a lot about how VLTs improve revenue streams in hotels and bars - just wondering what the `BC' mindset is at the government level.

B.C. is not currently considering any changes to permit the introduction of VLTs. (I would make this statement 1st not last). VLTs are highly controversial and any consideration of permitting VLTs in ^{S.13} (BC hotels?) would require extensive study of the current research regarding the impacts of VLTs as well as broad public consultation.

Hello:

Our previous correspondence advised of a recent change to a government email system that switched some government email domains to an Exchange Online Protection (EOP) process which caused your organization's inbound emails to be routed through a server in the United States. The affected organizations were notified out of an abundance of caution.

We have been working closely with Microsoft and the Ministry of Technology, Innovations and Citizens' Services to determine potential impacts associated with this incident. Through this combined effort, we were able to determine that no data was retained, stored or accessed while routed through the server in the United States. Microsoft issued the following statement in regard to this incident:

Microsoft confirms that routing for the Canadian Data Center caused some mail to relay outbound through a Microsoft data center located in the United States. Microsoft is in the process of changing the configuration so that email is routed through a server in Canada.

In this instance for the Province of British Columbia, while email messages traveled from the Canadian Data Center servers to outbound proxy servers that are physically located in the United States, the messages were not written to, retained, or stored to the server disk drives. The role of the outbound proxy server is simply to forward the email message on to the recipient's email domain, and nothing more; and in doing so, would not have written any of the mail message data to disk. Microsoft understands that local data-storage considerations are of utmost importance to the BC government. Microsoft has engineered the Office 365 service in such a way, and has committed contractually, that storage of the province's data such as Exchange Online mailbox content (e-mail body, calendar entries, and the content of e-mail attachments) will only be stored at rest within Canada. In this incident, Microsoft did not deviate from these commitments.

Upon investigation of this incident, Microsoft has determined that data was not viewed or captured by an external source. In addition, the routing of the data to the outbound proxy server located in the United States does not affect Microsoft's commitments regarding access to your data, even from a third party government agency. Relative to the Province's question of whether data in transit may have been captured, Microsoft would like to reiterate that it does not provide any third party under any circumstance (i) direct, indirect, blanket or unfettered access to customers' data; or (ii) platform encryption keys used to secure a customer's data or the ability to break such encryption. The position is confirmed via specific provisions in our contract for Online Services, and through multiple public statements on behalf of Microsoft by Brad Smith, President and Chief Legal Officer. By design, email content is encrypted in transit. Microsoft's email systems are continuously monitored to detect anomalous events and during the timeframes relevant to this incident, there is no evidence to suggest any access to email by external sources. Accordingly, we can confidently state there has been no capture or access of email by unpermitted third party actors.

We continue to work with Microsoft and the Ministry of Technology, Innovations and Citizens' Services to ensure a similar incident does not occur in the future. If you have any further questions or concerns, please do not hesitate to contact me.

Provided Background

- Approximately 5,100 excluded employees (including those at GCPE) are covered by the Management Classification and Compensation Framework (MCCF).
- In August 2016, the public service began a process of updating the current MCCF. The previous structure with three leadership bands (Applied, Business and Strategic Leadership) did not adequately reflect and differentiate between the levels of work that exist across the public service. This resulted in some salary compression and inversion issues.
- Staff at GCPE are staying at their same levels and the overall budget at GCPE has not changed.

Recommendation – GCPE on background:
