#### Investment plan calculations of property taxes

196 (1) Subject to subsection (2), each investment plan must,

- (a) for the first applicable year, reflect, as the total revenue that may be raised by the authority from property taxes in that applicable year, the total property tax revenue contemplated for that applicable year by the strategic plan that is in effect in the investment plan preparation year, and
- (b) for each subsequent applicable year, reflect, as the total revenue that may be raised by the authority from property taxes in that applicable year, an amount that is not greater than the sum of
  - (i) 103% of the total revenue contemplated to be raised from standard property taxes in the preceding applicable year, and
  - (ii) \$18 million.
- (2) If it is proposed to increase the amount of standard property tax revenue that the authority may realize in any applicable year to an amount that is greater than the amount determined in accordance with subsection (1), the investment plan must set out the additional amount of standard property tax revenue that is proposed for that applicable year.
- (3) Subject to section 16 (3), the authority must not, for any applicable year, assess property taxes in such a way that the total amount of revenue raised by the authority from property taxes in that year is greater than the total revenue amount reflected for that year in the strategic plan.

#### **Adoption Awareness Month**

The Government of British Columbia has proclaimed November as Adoption Awareness Month. The Ministry of Children and Family Development is taking this month-long opportunity to raise awareness about children and youth in care who are waiting for an adoptive home, and to recognize adoption as a valued way to build a family.

#### **Key Facts:**

- Children and youth in the permanent care of B.C.'s Ministry of Children and Family Development may be placed for adoption through the ministry.
- Permanent care mainly occurs when the courts have determined that the child or youth cannot return to the care of their birth parent(s). For these children and youth, the ministry makes plans for permanency. These plans can include:
  - Adoption, including foster caregiver adoption.
  - Transfer of custody: this transfers custody of the child or youth to someone with whom they have a strong connection.
  - Ensuring a child or youth has lifelong connections with significant adults in their lives if adoption or other permanency options are not in the child or youth's best interest.
- During the past 10 years, an average of approximately 270 children have been adopted annually. Last year, 273 children and youth in care of the ministry found permanent homes. Still, more than 1,000 children and youth in permanent care are waiting for adoption.
- Potential adoptive parents come from diverse backgrounds and have a range of life experiences. Anyone 19 and over who is interested in providing a loving, nurturing home may be eligible to adopt.
- Many of the children and youth waiting for adoption are school age. They may be siblings who need to stay together. Some may have special placement needs due to difficult early childhood experiences, prenatal exposure to alcohol or drugs, learning delays or other developmental challenges.
- The ministry strives to place children and youth with families that preserve the child or youth's ethnic and cultural heritage. As culture is essential to a child or youth's positive identity formation and preservation, adoptive parents who reflect British Columbia's cultural diversity and adoptive parents who are willing to maintain lifelong connections with the child or youth's cultural community are needed.

- In September 2015, Grand Chief Ed John was appointed senior advisor on Aboriginal child welfare to the Minister of Children and Family Development. His role will be to assist – including through the development of stronger permanency plans – in finding forever families for more Aboriginal youth in care through adoption, guardianship or other options that may be more appropriate in First Nations communities.
- The number of Aboriginal children and youth being placed with Aboriginal families is encouraging and was approximately 53 per cent last year – up from 27 per cent in 2000.
- In 2008, the Cowichan Tribes on Vancouver Island became the first delegated Aboriginal
  child and family service agency to handle adoptions in British Columbia. They have since
  held two cultural adoption ceremonies and completed adoptions for 20 children and
  youth in their community.
- The ministry works with community partners, including the Adoptive Families
   Association of BC, to increase the number of adoptions for children in government care.

   The ministry funds the association to help recruit new parents and provide both preand post-adoptive support for adoptive parents and children.

#### Post-Adoption Assistance Program:

- B.C.'s Post-Adoption Assistance Program provides financial support to adoptive families to help them meet the unique needs of their adopted children and youth with special needs.
- The program makes adoption possible for many families that, otherwise, would not have the financial means to give a child or youth a home and family.
- The Post-Adoption Assistance Program supported approximately 1,200 families in British Columbia with a budget of over \$19 million for 2014-15 up from \$2 million in 2000-01.

#### **Adoption Reunion Registry:**

- B.C.'s Adoption Reunion Registry has been in operation since 1991, and is legislated to provide search services for eligible people in B.C. and help them explore adoption reunion possibilities.
- The registry is available to adopted adults, birth parents, siblings and relatives of an adopted adult and the children or grandchildren of a deceased adopted adult. Adoptees that are searching or being searched for must be at least 19 years of age.
- Since 1991, approximately 17,800 applications for searches have been filed with the registry, resulting in approximately 5,900 searches connecting people together.





- The Industry Training Authority (ITA) leads and coordinates British Columbia's skilled trades system by working with employers, employees, industry, labour, training providers and government to issue credentials, manage apprenticeships, set program standards and increase opportunities in the trades.
